FINANCE AND STAFFING PORTFOLIO HOLDER'S MEETING

DECISIONS

Set out below is a summary of the decisions taken at the Finance and Staffing Portfolio Holder's Meeting held on Tuesday, 6 October 2009. The wording used does not necessarily reflect the actual wording that will appear in the minutes.

1. REVIEW OF FEES AND CHARGES: LAND CHARGES

The Portfolio Holder **APPROVED** the introduction of a 'refresher' search at a fee of £45.

Other Options Considered: No other options were considered.

Reason For Decision: The fee was set at a level proportionate to the charge for a full 'official' search in order to encourage solicitors to carry out an 'official' search initially rather than using a Personal Search Company. This could potentially help the Council regain some of the market share that has been lost to Personal Search Companies.

2. BALSHAM - PRECAUTIONARY ITEMS

The Portfolio Holder **APPROVED** the drawing of £3,900 from Precautionary Items to meet the associated costs of the Balsham by-election held on 4 June 2009.

Other Options Considered: No other options were considered.

Reason For Decision: To prevent an overspend on the election budget.

3. RURAL RATE RELIEF

The Portfolio Holder **AGREED** the Rural Settlement list for 2010/11 as follows:

Other Options Considered: No other options were considered.

Reason For Decision: Qualifying properties situated within a designated rural settlement are eligible for relief from payment of the National Non-Domestic Rates.

4. PAY AWARD 2009/10

The Portfolio Holder **AGREED** to the implementation of a 1% increase to conclude the 2009 pay negotiations, and to backdate the award to 1st April 2009.

Other Options Considered: Other options considered were:

- 1. Agree a lower settlement figure.
- 2. Implement a higher percentage increase.

Reason For Decision: To award an increase of less than 1% could adversely impact on staff morale, while an increase greater than 1% would exceed the amount included in the Council's financial estimates.

Additionally the amount of 1% is in line with the increase agreed by other employers and unions covered by the NJC scheme.

5. RELOCATION ASSISTANCE POLICY

The Portfolio Holder **AGREED**, subject to agreement from the unions:

- 1. the proposed amendments to the relocation policy and procedure;
- 2. an uplift in the total amount to £7000.

Other Options Considered: Other options considered were:

- 1. Maintain the status quo.
- 2. Agree the revisions to the policy but retain current levels of allowance to a maximum value of £6,910.

Reason For Decision: To make financial assistance available to new employees.

The amendments to the policy should make the policy easier to follow and more consistent in its application.
