The Panel has considered the application very carefully and had due regard to the Licensing Act 2003, the accompanying Guidance and Regulations and the SCDC Licensing Policy.

The Panel heard the evidence of joint applicant Mrs Chou Tang and, notwithstanding the absence of the Representee concerned, due to illness, also considered a representation received that was particularly focussed on noise nuisance emanating from the premises. The Panel noted that representations had not been received from either the Police, or from the Environmental Health unit.

The applicant informed the Sub-Committee that she was willing for music at the premises to cease at midnight at the latest and clarified an intention to run no more than 6 live events typically in any year.

The Sub-Committee **APPROVED** the application with some modifications as stated in the above operating schedule, together with the following conditions:

- (a) Prominent, clear and legible notices should be posted close to any exit doors and in the car park, reminding patrons that the premises are located in close proximity to noise sensitive dwellings and that they leave quickly and quietly.
- (b) Avoid wherever possible opening doors unnecessarily and ensure that any windows in the room in which music is to be played are kept shut.
- (c) Periodic checks should be made at the boundary of the premises whilst live or recorded music is being played to ensure that no neighbouring dwellings will be adversely affected through noise nuisance.
- (d) No more than 6 events involving live musical performances relying upon amplification and/or public address systems, or performances of recorded music to facilitate dancing or to accompany singing shall occur in any 12

month period; and no more than 2 such events shall occur in any single month.

Interested parties and responsible authorities may apply for a review of the licence on a ground relating to one or more of the licensing objectives should there be any relevant issues arising from the operation of the premises licence at any stage in the future. The four licensing objectives are: the Prevention of Crime and Disorder; Prevention of Public Nuisance; Public Safety and Protection of Children from Harm.

The applicant and objectors have a right of appeal to the Cambridge Magistrates' Court within 21 days of receiving notification of this decision.
