3. Community Housing Groups to Receive Boost from Council

On September 12th the Housing team at South Cambs will be launching a new community-led housing initiative.

DCLG's Community Housing Fund recently awarded both South Cambs District Council and Cambridge City Council just over £50,000 each in grant funding to help boost the provision of affordable homes delivered by community-led housing groups. The two Councils have decided to pool their funds and embark upon a year-long pilot of advice, support and funding for community groups to kick start their housing ambitions.

At the Parish Forum on September 12th details of how community-led housing groups can apply, on a competitive basis, to the Council for up to £4,500 in grant funding will be released. This funding is intended to help communities to develop their ideas for community-led housing, explore opportunities in their local area and form a legally recognised entity in order to further their plans.

6. View Planning Applications





To view the list of planning applications that have recently been submitted to the Council, please visit the authority's on-line <u>Planning Application Search</u>. Once the page has loaded, you can use the <u>Search option</u> to set your own criteria of parish, area and date range.

The system will provide a range of information on current and decided applications since 1948, including a brief description of the development, reference number, decision and the date of decision. More recent applications show the name and telephone number of the council officer who is dealing with the application.

Search results are presented in a collection of pages, the number of which depends on the number of results your search produces. There are navigation tools to allow you to browse your results.

EXECUTIVE DECISIONS TAKEN SINCE 30 AUGUST 2017



In accordance with the Access to Information Procedure Rules in Part 4 of the Council's Constitution, any executive decision shall be published normally within five days of being made. That record will bear the date on which it is published and will specify that the decision will come into force, and may then be implemented, on the expiry of 5 working days after the publication of the decision, unless called in for review by the Chairman of the Scrutiny and Overview Committee or by any five other councillors.

A list of decisions currently within the call-in period is available on the Council's website.

The call in procedure is set out in full in <u>Part 4 of the Council's Constitution</u>, 'Scrutiny and <u>Overview Committee Procedure Rules'</u>.

7. Central Bedfordshire Local Plan Consultation

The Planning Portfolio Holder agreed that a consultation response be submitted based upon paragraphs 18-25 of this report.

This decision was first published on Thursday 31 August and so the deadline for call-in is 5pm on Thursday 7 September. If not called-in this decision can be implemented on Friday 8 September.

8. Huntingdonshire Local Plan Consultation

The Planning Portfolio Holder agreed that a consultation response be submitted based upon the following:

"Huntingdonshire are consulting on their draft Local Plan between the 4th July and 4.30pm on the 25th August. They intend to consult again in late 2017 on a Proposed Submission Local Plan and submit their plan for examination in March 2018. The plan includes strategic scale developments at Alconbury to the north of Huntingdon and at St Neots East. The plan proposes sites to meet all of the objectively assessed housing need in the district. Overall its draft policies and proposals are considered to be an appropriate response to the planning challenges affecting Huntingdonshire insofar as it affects South Cambridgeshire. The plan is also considered to be consistent with the agreed duty to cooperate documents relating to the Cambridgeshire and Peterborough area." (paragraph 10 of the report)

This decision was first published on Thursday 31 August and so the deadline for call-in is 5pm on Thursday 7 September. If not called-in this decision can be implemented on Friday 8 September.

9. Uttlesford Local Plan Consultation

The Planning Portfolio Holder agreed that a consultation response be submitted on the draft Uttlesford Local Plan based upon paragraphs 15-35 of this report, taking account of agreed modifications and additions concerning transport, the North Uttlesford Garden Community start date, build-out rates, water supply and disposal, and 'rat running'.

This decision was first published on Thursday 31 August and so the deadline for call-in is 5pm on Thursday 7 September. If not called-in this decision can be implemented on Friday 8 September.

10. Neighbourhood Plans: Thriplow Neighbourhood Area designation

The Planning Portfolio Holder approved the designation of a Neighbourhood Area for the parish of Thriplow as proposed by Thriplow Parish Council (see Appendix A).

This decision was first published on Thursday 31 August and so the deadline for call-in is 5pm on Thursday 7 September. If not called-in this decision can be implemented on Friday 8 September.

Agenda Item 2 A14 Cambridge to Huntingdon Improvement Scheme August to September 2017



Section 1 & 2 - Alconbury to the East Coast Main Line Section 3 - East Coast Main Line to Swavesey Section 4 & 5 - Swavesey to Milton

Traffic Management:

Section 1 & 2. Night closures at the end of July ensured that the main beams of the Grafham Road Bridge over the A1 were placed in position safely and successfully.

Night closures are now in place for the safe installation of the CCTV cameras which are required to monitor the road during late September, when we will narrow the lanes and set a reduced speed limit to allow work to progress safely. We will let you know the exact dates as soon as they are confirmed.

Section 3: Road closures will be necessary on the A1198 for the imminent opening of the new bridge and roundabouts. The first road closure will begin at 9 p.m. on Friday 1st September, ending at 6 a.m. on Monday the 4th September. This is for drainage works on the A1198 carriageway. The second closure will take place between 15th and 18th of September to configure the new alignment with the existing carriageway. Traffic lights will continue to operate at plant crossings at Hilton Road, Potton Road and Offord Road.

Section 4 & 5: Narrow lanes and speed restrictions continue on the A14 between Swavesey and the Girton interchange. Speed is limited to 40mph in the narrow lanes and speed cameras are monitoring compliance. Lane closures are in place on the eastbound A428 by the Madingley turn-off and on the northbound A1307 between Girton Road and the A14.

Construction Activities:

Section 1: Culverts under the A1 are being extended to allow for the next stage of road-widening on the east side, including the initial construction layers.

We are planning to divert Alconbury Brooke and the old bailey bridge has now been removed.

As part of the scheme's legacy, we are committed to establishing flood compensation areas to balance out the A14 works. These areas will remain to work with existing flood modelling. Before this mitigation work can commence, detailed archaeological investigations must be completed. Topsoil clearance has started to the west of the A1, north of Brampton Hut, to allow archaeologists to carry out their work.

Section 2: The Grafham Road Bridge's main beams have been lifted into place over the existing A1. These will support the new sections of the A14. The adjacent beams already in place to the west, will span the realigned A1. The new bridge will be completed before the old Grafham Road bridge is demolished. crossing, we have completed 70% of the piling work, 5 of the 16 supporting pier structures and 80 % of the west abutment, which is where the bridge structure lands on the embankment works. We have also manufactured and stored the bridge deck sections, ready for installation later in the year

Section 3: Structures continue to be the focus in this section, with extra efforts being made to open the realigned A1198 ahead of schedule. Work continues on the structure that will

carry the A14 over the East Coast Mainline and beams have been lifted at some of our smaller structures such as Silver Street. Progress on the bridges at Hilton Road and Potton Road continues. Once the traffic is on the newly aligned A1198 these bridges will quickly begin to take shape.

Section 4 & 5: The accommodation block area at Swavesey is almost complete and we expect it to be occupied in mid-September.

The bailey bridge across the A14 close to Swavesey junction was installed over two nights at the end of August, meaning there is no need for haulage vehicles to traveling on the A14 carriageway. Construction materials can now be transported from the borrow pit in Boxworth to the north side of the A14, via this temporary bridge. These materials will be used to build the new Swavesey junction.

Piling works continued next to the A428 in preparation for the construction of two new bridges. The image below shows some of the 36 columns, which will support the bridge deck, which have now all been completed, A concrete pour to create the deck itself will take place in September. The beams on the second bridge under constructed at Girton junction will also be installed in September.

Environmental

Section 1: Fourteen Water voles have been released back into Alconbury Brooke following their winter and spring stay in a local special habitat, under the care of our very experienced, licenced ecologists. The capture and release was undertaken with the blessing of Natural England and enabled us to undertake various water course diversions without harming these endangered animals.

Section 4 & 5: A water recycling unit is being installed near the borrow pit at Dry Drayton. This facility, which is made from recyclable materials, will enable our road sweepers to empty their tanks locally. The unit works by trapping sediment from dirty water and filtering out clean water which is then re-used. Without this facility, our sweepers would need to travel significant distances to another licenced facility to deposit waste water, so we have reduced dramatically their trips on the A14; which enables them to spend more time keeping the local roads clean. This unit will be fully operational early in September.

Archaeology

Section 1 & 2: As mentioned above, archaeological investigations will commence shortly in the flood compensation areas to the west of the A1, north of Brampton Hut.

Section 3: Over 100 archaeologists continue their ground investigations across the 13km span of this section, in the vicinity of the Offord, Conington and Hilton Roads

Section:4 & 5 A team of 14 archaeologists continues to working alongside the A14 close to Bar Hill. Another team of 30 is investigating excavations at Girton. We will be announcing details of their exciting finds later this month.

In total, we currently have over 200 archaeologists working on the project.

Community Engagement
