

Sections 1 & 2 - Alconbury to the East Coast Main Line Section 3 - East Coast Main Line to Swavesey Sections 4 & 5 - Swavesey to Milton

#### **Traffic Management:**

Sections 1 & 2: Narrow lanes and a 40mph speed limit remain in force on the A1.

**Section 3**: There will be a full closure of the B1040 over the weekends of  $16^{th} - 17^{th}$  June and  $30^{th}$  June  $-1^{st}$  July and of Hilton Road the weekend of  $23^{rd}$  &  $24^{th}$  June.

**Sections 4 & 5:** Traffic management is in place on the A14 Cambridge northern bypass between junctions 32 (Histon) and 33 (Milton). This is to allow for the start of works to widen the carriageway, adding an extra lane in both directions between these junctions. Currently the lanes have been narrowed and a 40-mph speed limit is in place.

#### **Construction Activities:**

**Sections 1:** Work continues converting the old southbound carriageway to the new north bound.

**Section 2:** Pictured below is the installation of the first of four beams which will span the River Great Ouse. Each of the steel girders weighs 70 tonnes and the first was lifted into



place on by a 600-tonne crawler crane. The girder acts as the infill piece that completes the longest section of the structure, a 78m span over the river. The 17-span composite steel structure will include a precast deck, fabricated at our on-site pre-cast yard near Brampton. The River Great Ouse Viaduct is the largest structure on the project, totalling 745m in length and will carry six lanes of traffic over the flood plain. We are about halfway through construction, working from the east towards the east coast mainline railway.

The new northbound section of the A1 is now running from just north of the Buckden roundabout to Brampton Hut. The new south bound section will be open by mid-June. We will then start to upgrade the old sections to align with the A14.

**Section 3:** With the weather improving, the earthworks and structures teams are making great headway. You may have noticed that Silver Street Bridge is now open – a few weeks ahead of schedule, with Potton Road bridge (B1040) not far behind, due to open in early July.

The plug beneath the A1198 bridge has now been removed, allowing free movement of the earthworks team along the haul road. The material cut from this area has been transported east towards Hilton Road to build embankments.

Our earthworks delivery partners are moving around 10,000m3 per day which involves more than fifty dumpers carrying up to forty-five tonnes per load.

The bridges across this section of the scheme will be opened in sequence as follows;

- Silver Street June.
- Hilton Road mid-summer
- Mere Way late summer
- Conington road late summer
- Offord Road late summer/early autumn

**Sections 4 & 5:** The bailey bridge near junction 30 is now in operation, allowing dumper trucks to carry materials from a borrow pit on the north side of the A14 to the south, to construct a new local access road and the embankment which will take the A14 over the A428.

Further west, the new bridge that will replace the existing bridge at Swavesey, is taking shape. During a full closure of the A14 on the nights of 1st & 2nd June, six concrete beams, each weighing 102 tonnes & the scheme's longest, were lifted into place by a 750-tonne mobile crane to form the north span of the bridge. The beams had been transported as an abnormal load from Liverpool a few days before installation.

There will be further closures of the road for completion of the bridge decking in the first two weeks of June.



#### **Archaeology**

Our archaeology team from MOLA Headland welcomed the public to their Time Truck at Tesco, Bar Hill in May and at the recent Huntingdon Riverside Festival. Items found during A14 excavations were on show and children were encouraged to dig for artefacts hidden in sand boxes. Both events proved to be an outstanding success, with between 250-300 visitors at each.

MOLA Headland is now inviting volunteers to take part in a free summer community dig on for 24<sup>th</sup> July and 25<sup>th</sup> August 2018. These will be unique opportunities to take part in one of the largest archaeological excavation projects ever undertaken in Britain. Volunteers will work alongside archaeology experts from the team, exploring evidence of to the abandoned medieval village of Houghton, near Huntingdon, as well as Iron Age and Roman remains.

- Capture community design priorities in a well-written, visually led document with maps and graphics.
- Work with village representatives to review and finalise this document.
- Adopt the Village Design Statements as Supplementary Planning Documents.

The aim is to help village communities capture what is distinctive about their physical environment, and how they would like the design of new developments to respond to local character.
