The system will provide a range of information on current and decided applications since 1948, including a brief description of the development, reference number, decision and the date of decision. More recent applications show the name and telephone number of the council officer who is dealing with the application.

Search results are presented in a collection of pages, the number of which depends on the



number of results your search produces. There are navigation tools to allow you to browse your results.

EXECUTIVE DECISIONS TAKEN SINCE WEDNESDAY 21 NOVEMBER 2018



In accordance with the Access to Information Procedure Rules in Part 4 of the Council's Constitution, any executive decision shall be published normally within five days of being made. That record will bear the date on which it is published and will specify that the decision will come into force, and may then be implemented, on the expiry of 5 working days after the publication of the decision, unless called in for review by the Chairman of the Scrutiny and Overview Committee or by any five other councillors.

A list of decisions currently within the call-in period is available on the Council's website.

The call in procedure is set out in full in <u>Part 4 of the Council's Constitution</u>, 'Scrutiny and Overview Committee Procedure Rules'.

6. Pay Award 2018/19

The Lead Cabinet Member for Finance has agreed to:

- A) Apply a 1% increase on all pay points with effect from 1st April 2018 or the Living Wage rate (effective at 1 April 2018) of £8.75 per hour, whichever is the highest, with effect from 1st April 2018
- B) Equalise annual leave and reintroduce the reimbursement of professional fees.

7. Leasehold Equity Sharing Scheme for the Elderly - Sale to South Cambs Ltd (Trading as Ermine Street Housing)

The Lead Cabinet Member for Housing has agreed to sell a Leasehold Equity Share Scheme for the Elderly bungalow at 12 Plantation Road, Sawston to South Cambs Ltd (Trading as Ermine Street Housing).

A14 Cambridge to Huntingdon, Cambridgeshire: major improvements

Construction work on the new A14 Cambridge to Huntingdon scheme is underway. We are currently carrying out a variety of tasks for which we need to close lanes or carriageways on the A1, A14 and some local roads at times, usually overnight between 8pm and 6am, unless otherwise stated. A clearly signed diversion route will always be in place for closures.

For this week, the planned closures are:

Full closures

Monday 26th to Friday 30th (five nights)

A428 eastbound Madingley to A14 eastbound Fen Ditton J34

Motorway traffic will travel south on the M11, east on A505 and north on A11 to re-join the A14. Non motorway traffic will be diverted on local roads through Cambridge.

- M11 junction 14 exit slip
- A14 westbound Six Mile Bottom J36 to Girton J31

Motorway traffic will travel south on the A11, west on the A505 and then north on the M11.

Non motorway traffic will diverted on local roads through Cambridge

Monday 26th to Wednesday 28th (three nights)

A1 northbound between Brampton Hut and Alconbury

Vehicles will be diverted east on the A14, then north on the A14 link road to re-join the A1

Wednesday 28th (one night)

A14 westbound Brampton Hut J21 to Ellington J20

Vehicles will follow the A14 link road at junction 23 to travel north on the A1(M) then travel west on the A605 to re-join the A14 at junction 13. Non motorway traffic west at Wooley Road, south on Ellington Road and west at Wooley Hill to re-join the A14

• A14 eastbound junction 28 exit & entry slips (Cambridge Services)

Thursday 29th (one night)

A1 southbound between Alconbury and Brampton Hut

Vehicles will be diverted south on the A14 link road, then west on the A14, to re-join the A1 at Brampton Hut

Thursday 29th to Friday 30th (two nights)

Buckingway Road

Friday 30th November 9pm to Monday 3rd December 5am

A1 southbound between Alconbury and Brampton Hut

Vehicles will be diverted south on the A14 link road, then west on the A14, to re-join the A1 at Brampton Hut

A1 southbound Brampton Village exit & entry slips

Drivers wishing to access the A1 southbound from Brampton will need to exit the village at junction 22 of the A14 Drivers wishing to access Brampton from the A1 southbound will also need to use junction 22 of the A14.
