4. Home-Link - New Website

Due to a new IT provider, the Home-Link website is changing, and the system is being improved. Applicants will be receiving a letter to explain this and what they need to do.

To ensure that they are still able to bid for properties after 1st April 2019 they will need to complete a new online application form between 1st February and 28th February 2019 by visiting our website <http://www.home-link.org.uk/> and following the link to re-register.

The new online application will be faster and easier to complete than the current form. When we receive their new application, we will re-assess their priority. If their housing circumstances remain the same as their most recent application with us, we will honour their previous priority and assessment date - this will only be the case if they re-register during February 2019.

If they cannot use the internet and do not have a friend, relative or support worker to assist them in re-registering, they should contact us for assistance. We would however recommend that if they can get some support with completing the online form, this would be the most efficient way of ensuring their details are registered.

To view the list of planning applications that have recently been submitted to the Council, please visit the authority's on-line [Planning Application Search](#). Once the page has loaded, you can use the [Search option](#) to set your own criteria of parish, area and date range.



The system will provide a range of information on current and decided applications since 1948, including a brief description of the development, reference number, decision and the date of decision. More recent applications show the name and telephone number of the council officer who is dealing with the application.

Search results are presented in a collection of pages, the number of which depends on the number of results your search produces. There are navigation tools to allow you to browse your results.

EXECUTIVE DECISIONS TAKEN SINCE WEDNESDAY 9 JANUARY 2019



In accordance with the [Access to Information Procedure Rules in Part 4 of the Council's Constitution](#), any executive decision shall be published normally within five days of being made. That record will bear the date on which it is published and will specify that the decision will come into force, and may then be implemented, on the expiry of 5 working days after the publication of the decision, unless called in for review by the Chairman of the Scrutiny and Overview Committee or by any five other councillors.

9. Authorisation to enter into a new PSN contract

The Leader of Council **AGREED** to authorise officers to enter into the Partnering Agreement with Cambridgeshire County Council and thereafter enter into a partner call off contract under the Framework Agreement with MLL TELECOM LIMITED for the provision of Centralised Services.

This decision was first published on Friday 11 January and so the deadline for call-in is Friday 18 January at 5pm.

10. Statement of Community Involvement

Cabinet agreed

- (a) the draft Statement of Community Involvement (attached at Appendix 1) for consultation purposes;
- (b) that the consultation period will take place for six weeks between Monday 4 February and Monday 18 March 2019;
- (c) that the Joint Director of Planning and Economic Development is granted delegated authority, in liaison with the Lead Cabinet Member for Planning, to make any editing changes identified prior to publication for consultation.

This decision was first published on Friday 11 January and so the deadline for call-in is Friday 18 January at 5pm.

11. Northern Fringe Area Action Plan

Cabinet

- (a) Approved the Cambridge Northern Fringe Issues and Options 2 for Regulation 18 public consultation in accordance with the Town and Country Planning (Local Planning) (England) Regulations 2012 for a period of six weeks jointly with Cambridge City Council (Appendix 1 to the agenda report);
- (b) Approved the Statement of Consultation (Appendix 2)
- (c) Noted the findings of the Interim Sustainability Appraisal and Equalities Impact Assessment (Appendices 3 and 4)
- (d) Delegated authority to the Deputy Leader to consider and agree, as is consistent with this Council's Corporate Objectives, any changes proposed by Cambridge City Council.
- (e) Delegated authority to the Joint Director of Planning and Economic Development in liaison with the Deputy Leader, to make editorial changes to the Issues and Options Report and supporting documents prior to the commencement of the consultation period (to comprise minor amendments and factual updates and clarifications).

This decision was first published on Friday 11 January and so the deadline for call-in is Friday 18 January at 5pm.

12. Local Plan and Housing Monitoring Update

Cabinet agreed

- (d) to publish the South Cambridgeshire Authority Monitoring Report 2017-2018 (included as Appendix 1), with any further minor editing changes delegated to the Joint Director for Planning and Economic Development where they relate to technical matters;
- (e) that, in future, a Greater Cambridge Authority Monitoring Report is produced, and that these future Greater Cambridge Authority Monitoring Reports will be agreed for publication by the Lead Member for Planning via a decision outside of a meeting (together with the Executive Member for Planning Policy and Transport at Cambridge City Council), unless the Authority Monitoring Report identifies any significant issue with the implementation of any Local Plan or Area Action Plan policy that requires more detailed consideration by Cabinet;
- (f) that a decision on whether to submit a Greater Cambridge Annual Position Statement (relating to five year housing land supply) to the Planning Inspectorate (PINS) for consideration will be made by the Lead Member for Planning via a decision outside of a meeting (together with the Executive Member for Planning Policy and Transport at Cambridge City Council) and that the decision will be made before 1 April each year as required by national planning guidance;
- (g) that, whether or not it is decided to prepare a Greater Cambridge Annual Position Statement, the housing trajectory and five year supply calculations will be agreed by the Lead Member for Planning via a decision outside of a meeting (together with the Executive Member for Planning Policy and Transport at Cambridge City Council);
- (h) to seek agreement from the Ministry of Housing, Communities and Local Government (MHCLG) that South Cambridgeshire and Cambridge should be considered together for the purposes of the Housing Delivery Test; and
- (i) that, if on publication of the annual Housing Delivery Test results, an Action Plan is necessary in this or future years, it will be agreed by the Lead Member for Planning via a decision outside of a meeting.

Agenda Item 2

A14 Cambridge to Huntingdon, Cambridgeshire: major improvements

Construction work on the new A14 Cambridge to Huntingdon scheme is underway. We are currently carrying out a variety of tasks for which we need to close lanes or carriageways on the A1, A14 and some local roads at times, usually overnight between 8pm and 6am, unless otherwise stated. A clearly signed diversion route will always be in place for closures.

For this week, the planned closures are:

Full closures

Monday 14 to Thursday 17 (four nights)

- A1 southbound between Brampton Hut and Buckden

Vehicles will be diverted east on the A14, south on the A1198 then west on the A428 to re-join the A1

Monday 14 to Friday 18 (five nights)

- A428 eastbound Madingley to A14 eastbound Fen Ditton junction 34

Motorway traffic will travel south on the M11, east on A505 and north on A11 to re-join the A14. Non motorway traffic will be diverted on local roads through Cambridge.

- M11 junction 14 exit slip

- A14 westbound between Six Mile Bottom junction 36 and Girton junction 31

Motorway traffic will travel south on the A11, west on the A505 and then north on the M11.

Non motorway traffic will be diverted on local roads through Cambridge

Friday 18 9pm to Monday 21 5am

- A1 northbound Brampton village exit slip
- A1 southbound Brampton village exit slip

Brampton village will remain accessible via junction 22 of the A14

- Brampton Road

Friday 18 (one night)

- A1 southbound Brampton Hut entry slip

Saturday 19 7am to Sunday 18 7pm

- Conington Road

Saturday 19 (one night) **11pm to 11am**

- A14 westbound between Bar Hill junction 29 and Swavesey junction 28

Vehicles will be diverted west on the A428 then north on the A1198 to re-join the A14 at Godmanchester

- A14 eastbound between Swavesey junction 28 and Bar Hill junction 29

Vehicles will be diverted south on the A1198 at junction 24, then east on the A428 to re-join the A14.

- A14 Girton junction 31 westbound to westbound loop

Sunday 20 (one night)

- A14 westbound between Bar Hill junction 29 and Swavesey junction 28

Vehicles will be diverted west on the A428 then north on the A1198 to re-join the A14 at Godmanchester

- A14 eastbound between Swavesey junction 28 and Bar Hill junction 29

Vehicles will be diverted south on the A1198 at junction 24, then east on the A428 to re-join the A14.

- A14 Girton junction 31 westbound to westbound loop
