6.	Stopping Scams in Just Five Simple Steps
	Please find attached a document from the Cambridgeshire And Peterborough Against Scams Partnership (CAPASP) on how parish councils can protect local residents from scams.
7.	Local Policing Review - Statement from Inspector Paul Rogerson
	As many of you will know in April 2018 Cambridgeshire Constabulary underwent a wholesale reorganisation, referred to as the "Local Policing review" or LPR. The community teams which previously covered Huntingdonshire, South Cambs, East Cambs and Cambridge City merged but continue to have local presence and focus led by a local Sergeant. These Geographical officers are supported by a larger enforcement team called "CAT", the Community Action Team
	The LPR has caused the Constabulary to review many of its processes, including how we engage with communities. Our previous commitment in South Cambs (providing seven quarterly panel meetings) is no longer something the Constabulary can maintain. For this reason we have explored new ways to ensure we understand communities and residents can have their say on local police issues.
	Moving ahead the local teams, led in South Cambs by Sgts Jon Capes and Emma Hilson will undertake a new approach Closer working relationships with Parish representatives, District and County Councillors
	This began in October with a full Council briefing to elected District representatives. Work will continue with a Parish workshop in March 2019. A key part of this is that we need Parishes to take a lead, and ensure matters of serious concern are fed back to Police (directly to your local Sgt).
	<ul> <li>Online surveys commissioned on a quarterly basis (this includes a general and "youth specific" survey). Surveys will help local police teams gather views from a much larger audience including our minority and vulnerable communities. We recognise that some communities, the elderly for example, do not have direct access to online facilities. To ensure we are capturing the views of all our residents we will run separate more traditional forms of targeted engagement work to complement the online survey.</li> <li>In partnership with Parish, District and County elected members, community meetings</li> </ul>

can be called where and when they are needed to discuss specific issues with the local police team. A recent good example of this is in Willingham where police teams met with residents to address serious concerns about crime levels.

- Where areas of serious concern are identified Police will, in partnership with other agencies, commission a public action plan, an example of which can be found here.
- Your local team will commit to holding regular police surgeries three times a month.

We believe this revised approach will help create stronger relationships with South Cambs residents. I do appreciate we are asking more of our elected members. However, I believe you are the right people to speak for your communities. If you have any questions please do not hesitate to get in contact.


#### 9. Local Transport Plan on Thu 21 Feb at 10am

# A14 Cambridge to Huntingdon improvement scheme



## We want the A14 upgrade to be the safest and best road it possibly can be and we now have an opportunity to make our road even better.

This £1.5bn improvement scheme includes a major new bypass to the south of Huntingdon and upgrades to 21 miles of the A14. Once complete, it will boost the local and national economy and cut up to 20 minutes off journeys.

The scheme's development consent order (DCO) is its planning permission. When we began designing the scheme we did not think it would be a motorway so we submitted a DCO asking to build a trunk road. As a result, the DCO does not allow us to change the road from A-road to motorway. Now that modern motorway standards coincide with the scheme we're building, it makes sense for the road to become a motorway, to get the safest and best road possible. England's motorways are among the safest roads in the world.

We are therefore now asking the Planning Inspectorate for an amendment to our DCO to allow us to make it a motorway. We anticipate the Secretary of State for Transport will give us a decision this year. We are still on schedule to open to traffic by December 2020.

## Implications of the new A14 becoming a motorway

Because the scheme's design meets the current standards for a modern motorway we're not changing what we're building. The route stays the same and the junctions don't change.

#### What would change

- Applying motorway regulations
- Slow moving vehicles prohibited from motorway
- Blue signs instead of green
- Variable mandatory speed limits to help manage traffic when appropriate

#### What would stay the same

- The design and engineering of the road
- Safety refuges already designed-in
- Local roads and junctions stay the same
- Old A14 route declassified to become a local road
- Improved pedestrian, cycle, equestrian provisions already designed-in
- Open to traffic by December 2020
- Total scheme cost

## The benefits of reclassifying the new A14 as a motorway:

#### Safety

Motorways are twice as safe as A-road dual carriageways and six times safer than single-carriageway roads. Our motorways are amongst the world's safest roads.

#### Journey speed and reliability

We designed the road to provide mile-aminute journeys. Removing slow moving traffic such as farm vehicles and mopeds will improve journey times and further improve safety.

We have built new roads and paths for local traffic, pedestrians, cyclists and horse-riders as part of the scheme.

#### A14 Cambridge to Huntingdon, Cambridgeshire: major improvements

Construction work on the new A14 Cambridge to Huntingdon scheme is underway. We are currently carrying out a variety of tasks for which we need to close lanes or carriageways on the A1, A14 and some local roads at times, usually overnight between 8pm and 6am, unless otherwise stated. A clearly signed diversion route will always be in place for closures. For this week, the planned closures are:

#### Full closures

Monday 28 to Wednesday 30 (three nights)

• A1 southbound between Alconbury and Buckden

Vehicles will be diverted south on the A14 link road, then east on the A14, south on the A1198 and west on the A428 to re-join the A1

Monday 28 January to Friday 1 February (five nights)

• A1 northbound between Buckden and Alconbury

Vehicles will travel east on the A428, north on the A1198, west on the A14 and then north on the A14 link road to re-join the A1

• A14 westbound between Bar Hill junction 29 and Swavesey junction 28

Vehicles will be diverted west on the A428 then north on the A1198 to re-join the A14 at Godmanchester

• A14 eastbound between Swavesey junction 28 and Bar Hill junction 29

Vehicles will be diverted south on the A1198 at junction 24, then east on the A428 to re-join the A14.

• A14 Girton junction 31 westbound to westbound loop

Thursday 31 January to Friday 1 February (two nights)

• A1 southbound between Brampton Hut and Buckden

Vehicles will be diverted east on the A14, south on the A1198 then west on the A428 to re-join the A1

Friday 1 9pm to Monday 4 5am

- A1 northbound Brampton village exit and entry slips
- A1 southbound Brampton village exit and entry slips

Brampton village will remain accessible via junction 22 of the A14

Brampton Road

Saturday 2 6am to Monday 4 5am

• A1 northbound between Brampton Hut and Alconbury

Vehicles will be diverted east at Brampton Hut on the A14, then north on the A14 link to re-join the A1
