# **Current and Prospective Independent Members of the Standards Committee**

#### Peter John Brindle

I retired from the Royal Air Force after 30 years' service in 1996 to take up a bursarial post in Cambridge. My last post in the RAF was as Chief of Staff at The Personnel Centre in Gloucester, responsible for the personnel, careers and pay management of all serving officers and airmen. One of my major tasks in this post was to act as the *Ombudsman* for all RAF airmen. During this time, I was also personally responsible for providing answers to all Parliamentary Questions concerning Air Force personnel and personnel operations. Prior to that, I was the RAF personnel adviser to the 1994 Defence Cost Study (*The Bett Report*) into the future RAF.
