### **Background**

- Current remit of the Standards Board to filter complaints
- Graham Committee recommendations driven by concerns about proportionality and culture
- "Despite incidence of corruption and misbehaviour, the vast majority of councillors and officers observe high standards of conduct"

- Local decisions at the local level will assist in improving local ownership of the ethical framework
- It is not whether the local filter will exist, but how it might work
- We recognise the difficulties, but we are committed to helping you



# **Guidance from the Standards Board**

- Getting the balance right consistency not blanket uniformity
- Establishing and maintaining a national framework
- Three key areas:
  - regulation
  - guidance
  - matters for local choice
- Building trust in the system



#### **Different models**

- The government's intention is that it will be a standards committee decision, not an officer decision
- Sub-committees:
  - referrals
  - appeal
  - investigation
- Joint committees

# Some issues identified with standards committees

- Difficulty in recruiting co-opted independent members
- Disillusionment amongst existing co-opted independent members
- Disparity of workloads between committees
- Lack of consistency in local decision-making
- Public perception that committees lack independence



"You can also give your standards committees other functions. We believe that standards committees should be proactive by introducing change rather than reacting to events. Ultimately standards committees should aim to create and maintain ethical organisations."
