CABINET SCHEDULE OF MEETINGS FOR 2008-2009

Purpose

- To consider and agree a schedule of meetings for the 2008-2009 Civic Year. The matter was deferred from the last meeting to allow discussions with the Chairman of Scrutiny and Overview Committee to achieve better co-ordination of meeting dates. This meeting has since taken place and the issues successfully resolved. The Scrutiny and Overview Committee will be asked to agree its schedule for 2008-2009 at its meeting on 14 February 2008.
- 2. This is not a key decision, however it is appropriate for the Cabinet to agree publicly its meeting schedule in the interests of transparent local government.

Considerations

3. The proposal below provides for monthly Cabinet meetings except for August 2008 and follows the existing pattern of meetings which has operated since 2004. Over the past year, the number of Council meetings has been reduced, the Scheme of Delegation of Cabinet functions to Portfolio Holders extended and local targets to minimise the number of information items on the Cabinet agenda introduced. For these reasons, it is expected that the amount of business being considered by Cabinet during 2008-09 will be reduced. This may in turn allow a reduction in the number of Cabinet meetings required in future years.

Proposed meeting dates 2008-2009

4. Assuming meetings are held on, or as near to as possible, the second Thursday of the month:

Note the following points:

(a) June and July 2008 meetings on the first Thursday so as to allow a 2-week gap before Council on 17 July 2009.

(b) April 2009 meeting scheduled only one week before Council to avoid Maundy Thursday.

Time and venue for meetings

5. Cabinet may wish to review times and venues for its meetings. Meetings are currently held at 2.00pm, with the exception of the meeting on 18 February 2008 which will commence at 7.00pm, the second in a trial to establish whether evening meetings stimulated higher levels of public interest and attendance. The evening meeting held in October 2007 did not attract higher public attendance. Meetings are currently held at the Council Offices; Cabinet may wish to consider whether it wishes to hold meetings at venues around the district in order to stimulate public interest in democracy.

6.	Financial	Holding evening meetings or those at outside venues will incur additional overtime, hiring and equipment costs.

	Staffing	See above.	
	Risk Management	There are specific risks associated with evening and outside meetings in terms of lone working and first aid cover which would need to be assessed in detail.	
	Equal Opportunities	Holding evening and outside meetings increases accessibility to the Council's services amongst groups who would not normally have the opportunity to attend e.g. those working full daytime hours, those without cars or with other mobility issues. Having said this, previous trials of evening meetings have not been successful in this regard.
