Dick has also confirmed that he is willing to continue the role for 2012/13 and the PC wish to express their appreciation to Dick for his continued hard work. We would also like to thank Bill Slater for keeping our Bus Shelters clean and tidy and I would like to thank other Councillors for all their hard work over the past year with cutting the village pound, mending fences etc.

Parish Clerk

Following 3 years of working as Longstowe Parish Clerk Margaret will be standing down from this role as of May 2012. I want to personally say a very big thank you to Margaret for all her help, support and advice and to wish her all the best for the years to ahead. We advertised for a new Clerk in a previous edition of the Skylark and are happy to report that a resident of the village has registered an interest. As discussions are still currently on going I am not in a position at present to disclose the resident's name, but will by our next edition of the skylark.

Precept 2012/2013

The budget and precept for 2012/13 has been reviewed at a number of meetings and was finally set at the January meeting. SCDC have been advised that a Parish precept of £4,550 will be required in 2011/12 for Longstowe, which is an increase of £350 compared to 11/12. The council knows that many people are having financial worries at this present time and we have tried to keep this in mind when setting the precept. However, we have also had to take into account that we may have elections in May 2012 and we were

advised by SCDC to estimate elections costs of £750 within the precept.

Speed Reduction A1198

The council are still working on speed reduction measures for the A1198 north of the village, especially after local residents have again raised concerns re accidents at/around the Fox Junction. Cllr Sebastian Kindersley has recommended that representatives (residents included) of Longstowe should attend the Police Panel Meetings to bring this road safety problem to the panels' attention. Unfortunately, the next meeting is on April 19th (7.30pm Gamlingay Village College), which coincides with the PC Open Meeting. However, residents are more than welcome to attend the Police Panel Meeting to raise their concerns and I will send a report to the meeting raising the concerns of the PC. The following Police meeting is July 19th 7.30pm at Haslingfield Village Hall.

Speedwatch

As a follow on from the information above Cllr Sebastian Kindersley advised that Longstowe should also pursue joining 'Speedwatch', which Arrington and Bourn among other villages are currently in. This is something the PC have spoken about before so if residents are interested please let the PC know and we will re-look into this. Church News

The Churchyard of St Mary The Virgin, Longstowe – Background to Churchyard Policy and Guidance 2012:

Our beautiful churchyard was last mapped in October 1996 by Alan Straney and the Plan shows the new progression of Plot Numbers together with the original Plot numbers, as recorded by John and Monica Allen in 1987 as part of the Cambridgeshire History Society. In addition to plot numbers the map indicates a number of *reserved plots* reflecting the wishes of long-standing parishioners and in many cases active worshippers at the Church. With the change of Church Wardens last Autumn and new members of the PCC, it seems an opportune time to check the position of the churchyard plan on the ground, and to put in place a policy and guide for future use covering not only new graves but also

maintenance and management for the benefit of the environment.

The reader may be aware of the practice of *reserving* plots. This has happened for at least 30 years and although these reservations have no legality in the eyes of the Church, it is important to state that **no** member of the current PCC would wish to cause upset and anxiety in respect of these *reserved plots*; so any agreed strategy and guidance for allocating future plots, given the lack of pressure on the churchyard where possible, shall take into account the wishes of the named holders of the reservations.

Comments have also been made over the last ten years or so that:

“The churchyard is becoming full and there is perhaps enough room on the present ground for the next 15 years”.

“The only really free space for new graves is mainly to the north side of the church”

The key points from the Policy and Guidance document are now detailed. **Please do speak to the Church Wardens if you would like to read the document in full and view the Map.**

Finally the reader may be interested in considering The Arbory Trust near Barton, Cambridge www.arborytrust.org.uk which is developing a very attractive Christian woodland burial site as an alternative to our churchyard.

Thus:

- **Ownership of the churchyard:** The ‘ownership’ of the churchyard is vested in the incumbent for the use of the parishioners. The ‘ownership’ of the churchyard remains with the Church forever, even when an area subsequently becomes a grave or place of interment of cremated remains. The relatives to the burial never take ownership.
- **Right to burial:** In a consecrated churchyard every parishioner has a right of burial in the churchyard, provided there is space available and the churchyard has not been closed for burials by Order in Council. In addition any person whose name is on the electoral roll of the parish at the time of their death also has a right to burial although they may be outside of the parish. The decision in the latter instance resting with the Team Rector and the Church Wardens taking into consideration both sufficient connection and pastoral reason. **However there is no right of burial in any particular part of a churchyard.**

- **Reservation of grave spaces:** An incumbent (or member of the PCC, or any other person) *cannot* grant or assure anyone of a right of burial in a particular place in the churchyard or area for cremated remains. *The exception is where an* application for a **faculty has been granted** by the Chancellor of the Diocese, with a designated space for a named person, in the churchyard. Faculties are normally subject to a five-year time limit for implementation and are granted on fulfilment of certain conditions, and at a cost.
- **Finally:** On undertaking investigations into the churchyard to draw up the policy on future use for burials within the consecrated grounds, there was an expectation that we would have to position any new graves to the north side of the church. However from the results our investigations decisions for future burials other than those exceptions detailed above, **will be based on the land as shown by the hatched area on the Map** and extend the area of choice. Further, this map will be revisited on a five yearly basis, and continuing capacity will be confirmed. The map will be published to the community as a whole.

Maintenance of the Churchyard

Trees in the churchyard: Maintenance of trees in the churchyard falls to the PCC and they are responsible for ensuring all trees within the churchyard are safe. A risk assessment of any trees should take place from time to time and noted in the Risk Register, and steps taken to remedy any unsafe tree within the churchyard.

Planting of trees in the churchyard is at the discretion of the incumbent and PCC and details of the type and proposed planting position of any tree must be submitted for their approval prior to any such action being undertaken.

Confetti: The throwing of confetti is permitted, however the policy for our church is that the confetti chosen should be environmentally friendly.

Churchyard Mowing: The Churchyard Policy is about striking a balance to keep churchyard looking maintained and cared for, whilst having consideration to the provision of places for wildlife to flourish in suitable areas within the churchyard.

The compost area can only be used for green waste and parishioners must please take away plastic bags, oasis etc.

Revd Alexandra writes:

Easter – the coming back to life of the executed Jesus – is the hinge on which all existence and meaning rests in Christian understanding. This year the suspense, drama, tragedy and joy of Holy Week and Easter are concentrated into the first few days of this month, when our local churches will be following the final events in Jesus’ earthly life – his triumphal entry into Jerusalem on Palm Sunday, his last supper on Maundy Thursday, his execution on Good Friday and God’s gift of a new form of life on Easter Sunday. Everyone is invited to attend any of our acts of worship during Holy Week, including a service of holy communion for the whole team, to recall that last supper of Jesus and his disciples, in Eltisle at 7:30pm on Maundy Thursday in which our Archdeacon, Ven John Beer will be leading us. Working together through the momentous events of the week will help us to understand more fully the extraordinary impact of Easter Day.

Easter is the pinnacle of our Christian celebrations, but I recognise how easy it can be, once we’ve finished the Easter eggs, to stop thinking about Easter, and move on to the next thing. But the Christian message of the death and resurrection of Jesus is a message not of ‘business as usual’, but of transformation and the possibility of change for the better even in the bleakest of situations. It’s about the beginning of a new form of life in which the grace of God can repeatedly renew and resource us. On the evening of that first Easter day, when no one quite understood what had happened, two of Jesus’ followers were walking to a place called Emmaus. As they walked, they discussed the roller-coaster events of the previous days and all that people were saying about Jesus being alive again. They were joined by a traveller who, in conversation, helped them to understand the significance of what had been happening. When they reached Emmaus the traveller stayed to eat with them. When he blessed the bread and shared it out the friends realised that it was indeed Jesus, come among them. At that moment of realisation Jesus vanished from their sight.

It can be in the most unexpected of places, with the most unlikely of people that we come to some of the most profound understandings of our lives – those moments when things just click and we make sense of the world. The spirit of Easter, of continuing renewal and rebirth, is not confined to one day in early Spring, to be packed away again afterwards until another year, rather it should accompany us through

all the highs and lows of daily life, and then we may glimpse something of the divine around us and appreciate the continuing presence of God in our lives every single day.

May God bless you richly this Eastertide.

LONGSTOWE VILLAGE HALL

A little bit of history and a view of the future

Longstowe Village Hall as it now stands, was built in 1968 to replace a small cricket pavilion on the sports ground.

It is a simple wooden structure built on stilts without foundations, and in line with buildings of its day, has no insulation. However, with regular maintenance, much of it voluntary, it has stood the test of time.

It has been the home of Longstowe cricket and sometimes football, and has been the only village amenity since it was built, for clubs, groups and societies to meet, and for exercise classes and dancing to take place. It has been the venue for New Year's Eve celebrations, birthday parties, anniversaries,

weddings, quizzes, coffee mornings, jumble sales, pantomimes, village fete, and harvest supper and in recent years a number of balls. It brings back many fond memories for many people and has served the community well.

Sadly however, it is getting towards the end of its life. It has had some major issues for some years, including a sagging roof and a floor that cannot be sanded any more times! Lack of insulation causes the hall to be bitterly cold in winter and curtails its use, and in spite of best endeavours has on occasion led to frozen and burst pipes. This issue is especially compelling at a time when the cost of electricity is so high, and energy conservation is a global concern.

You may remember a number of years ago some progress was made towards planning a new hall. Unfortunately circumstances at the time prevented it from going ahead, and the project had to be shelved.

However, time has moved on, and as some of you will already be aware, the village hall committee is once again looking closely into what it would take to rebuild the village hall. A number of people have been to talk to us from Cambridgeshire ACRE and the district council about the work it will entail, so we have a fair understanding now of what is involved.

The Committee is now considering how to move forward. Members of the committee are hesitant to take on more commitments than they have already in the day to day running of the hall but are keen to support the project. The committee is therefore looking for expertise, particularly within the village, to help take the project forward; this could take the form of project management, applications for grants, local fundraising, architectural design, surveying, building works etc. And, depending on the response to this plea, possibly to appoint a professional to oversee the project and other people with knowledge and expertise in particular fields.

This is a long term project and will not be accomplished overnight, but we are confident that the project is both desirable and achievable. We hope you do too.

If you have a skill that you could offer, please would you consider getting involved with the project.

And in order to attract funding it is very important too that the community is seen to be behind the project. Please look out for opportunities to show your support.

Good Service

I was unfortunate enough to suffer an oil fired boiler failure during the recent cold spell, when temperatures touched -14°C outside. I contacted Messrs. Shelford Energy (I use them routinely for boiler service) who promptly visited to sort things out. The fault turned out to be an elusive one needing more than one return visit.

Shelfords persisted until the fault was resolved satisfactorily. They were always prompt with appointments and prepared to fit in with my working hours. I feel I paid a completely fair price, considering the nature of the work required. I wouldn't hesitate to recommend them to anyone living locally.

I have no connection with Shelford Energy, other than having used them for service during the past few years.

Theft of oil in South Cambridgeshire

There has been theft of oil from St Andrews Church in Caxton sometime between December 1st and 15th. There have been similar incidents in other areas of South Cambridgeshire and we are urging people to check their oil tanks on a regular basis and take measures to try secure their tanks. Security Measures: Make sure that your oil tank is not visible from the road, and if it is, fences, trellis, trees or hedging can be installed to make the tank less visible to passers by. If you gates on your drive, then keep them closed when away from your property. Use a movement sensitive security light placed near the oil tank that will come on if there is any movement near the tank. Small infrared cameras are fairly cheap these days. A covert camera to record the number plates of any vehicles entering your driveway could help. It may not stop thieves but may help to trace them later. Placing a highly visible camera on your house may act as a deterrent to opportunist thieves. Fit a good strong lock; although be aware that plastic tanks can be drilled which may lead to other problems. Not only do you have to buy a new oil tank but you may have an environmental problem cleaning up the spilt oil. There are products that monitor oil levels and sends a radio signal to a receiver inside the house. It can also detect when the oil level drop dramatically such as would happen if there were a leak or theft and alerts the receiver unit. It is still possible that even after all these security changes, a determined thief could still come along and steal your oil but if you make it difficult for them they will probably go elsewhere.

Longstowe Lighthouse Now, before its too late!

Longstowe Lighthouse Feasibility Study Group

As we are increasingly aware of the rapid changes in climate, both nationally and globally, the Government has had to, like the rest of continental Europe, make plans to safeguard our country for future generations.

With rising sea levels an issue nationally and coastal erosion being far more severe in East Anglia than almost anywhere else in Britain, it is appropriate that we take steps to prepare for whatever the future may bring, in terms of coastal erosion and readiness for life in a very differently shaped county.

As a high point in our county, Longstowe is one of around half a dozen possible sites where the construction of an inshore lighthouse would be possible.

There are many who doubt the need for such a scheme. Perhaps they should remember that one of East Anglia's major cities, Dunwich, has all but disappeared into the ever encroaching sea.

What can you do to help? In the first instance, please attend our meeting at Longstowe Village Hall, on Monday 1st April at 7.00 p.m. There will be experts on hand to discuss outlines for the project and answer any questions. It is hoped that there will be sufficient interests from residents of Longstowe, so that the style of lighthouse, choice of materials from which it is to be constructed and exact siting may form an acceptable compromise.

When completed, the Longstowe Lighthouse would provide a few jobs within the village as well as a tourist attraction.
