Minutes of the Meeting held on Thursday 23rd June 2011 in Longstowe Village Hall

- c) Hedge needs cutting along from the notice board WB to action
- d) Trees overhanging pathway outside 30 Great North Road Clerk to write to owners

- 13 The MINUTES OF THE LAST MEETING were agreed and signed.
- 14 MATTERS ARISING/TO REPORT FROM PREVIOUS MINUTES

 The 40mph sign in the High Street still had not been replaced –

- MEMBERS DECLARATION OF INTEREST for items on the agenda none were received.
 - 16 The Chairman welcomed Chris Maitland, Chairman of the SCDC Disability Forum, to report on the services of the forum. He gave a brief background to the forum and their aim to focus on disability issues across all services provided to tenants and leaseholders in the district. He provided a summary, with contact details, to be distributed in the village and published in 'Skylark' and on the web site.

17 FINANCE

a) The Clerk reported an alteration the Accounts and Annual Return that had been approved by the Chairman to meet the audit deadline of 6th June 2011. The Play equipment purchase value of £28,820

- had been added to the asset register. The Council approved the revision.
- b) A request for a donation from Royston & District Community Transport was not approved as the Council does not have a grant aid budget
- c) The following cheques were signed:
 - i) Suffolk ACRE £373.56 for additional insurance cover for the play equipment.

18 TO CONSIDER PLANNING APPLICATIONS RECEIVED None received

19 TO CONSIDER OTHER MATTERS

- a) Further to Minute 6a (19th July 2011), the Clerk reported that the advice from Cambs ACRE had indicated that the Play Equipment is currently owned by the Parish Council. On that basis the purchase value had been added to the asset register and insurance extended to include the equipment and public liability cover. It was noted that the terms of the grant agreement does not allow the Parish Council to "assign or otherwise transfer any of its rights and obligations or sub contract performance of its obligations without prior agreement of the County Council". Mandy Holland, the Village Hall Chairman, was present and it was agreed that the best option was for future ownership. insurance and maintenance to remain with the Parish Council but that the Village Hall be requested to appoint a sub-committee to maintain the Play Area on their behalf. Mandy also suggested that the Village Hall should make a contribution towards insurance and maintenance costs to avoid the burden falling on residents of Longstowe. It was agreed that the Clerk would write to the Village Hall Committee with a proposal including a detailed breakdown of insurance costs.
- b) Further to Minute 8 (19th May 2011), the Chairman welcomed Sally McCall, the new Editor of 'Skylark', and thanked her for taking over the position. Sally then reported on new costings for the printing of 'Skylark' and circulated a sample of the new format to Councillors. The normal 8 page edition would cost £20 with a 12 page edition costing £30, the printers, Victoirpress, would invoice the Parish Council directly. Members approved the new format and it was agreed to create a regular agenda item to consider any future editorial issues.
- c) The Clerk reported that the notice board outside the Village Hall had been vandalised. It had been reported to the police and an insurance claim instigated.

- a) Further to Minute 4 (19th May 2011), the Clerk reported an offer from SCDC to participate in a Speed Sticker initiative. The District Council will fund 120 stickers to be distributed by the Parish Council as they wish. The Council approved the Clerk to order 120 stickers under the scheme.
