Proposed diversion of Public Footpath No.1 (Part), Hauxton s.257, Town and Country Planning Act 1990

Thank you for your letter dated 27 November 2012, and plan illustrating the above proposal.

Firstly, we can confirm that the proposed new line for part of Hauxton Footpath 1 is consistent with that which we accepted on behalf of the Ramblers' Association in our letter of 17 May 2012, addressed to the applicant. Your confirmation that there is sufficient space to accommodate a width of 2 metres throughout the length of the diversion is welcomed. We are assuming that any temporary fencing will be removed as the development proceeds, and that the path will return to what it was before the development started, a pleasant walk beside the river and through woodland.

Regarding the section of the existing right of way along the south-western bank of Riddy Brook we note your comment that it has been fenced off by the landowner for health and safety reasons – as indeed we noted when we last walked the path on 15 November 2012. In the normal way this would create a problem, as our organisation has a policy of refusing to consider diversions where the existing route is obstructed. However we accept that it would be unreasonable to require the re-opening of this section of path under the present circumstances, and we note your comment that the applicant will be obliged to seek a temporary closure and diversion to regularise the situation.

Regarding the future of Footpath No.5 we note that a temporary diversion is currently in force, though the route seems to have been altered since the initial diversion was made, as the signed route from the A10 along the western boundary of the site is now quite close to the original route which crossed the works car park. The best that can be said about this is that although uninviting between high, temporary fencing, it is at least fairly easy to locate from either end.

We will, of course, be very willing to discuss or comment on proposals for its final alignment and condition, once details of the layout become available. At best we would expect the route to have as nearly as possible the character of a rural footpath, i.e. not enclosed between high fences, and ideally along a strip of amenity land with grass borders and suitable planting.
