South Cambs Crime and Disorder Reduction Partnership 2008/09 Quarterly Progress Report

Quarter: Quarter 4 Jan-March 2009

Priority Area: Catch and Convict PPO Strategy

Lead Officer: Jenny Jolley

- 1. Key Achievements (What has gone well):
- Enforcement: The team were advised about an out of area PPO, who had been released from custody to S Cambs. Monitoring was agreed and information was shared with the NPT. Visits were undertaken to in order to ensure that the PPO was aware of their continuing status and the consequences of re-offending, along with checks on his curfew.
- **Enforcement:** A PPO has been recalled under Probation licence with, no recommendation for release by the parole board. Presently awaiting trial for offences committed, whilst on licence.
- **Enforcement:** The PPO Officer is paying frequent visits to the home address of 2 PPOs, to enforce their status and in support of their statutory orders.
- **Partnership Working:** The PPO Team met with Probation to discuss the risk management plans and sentence planning within their Offender Assessment System (OASYs). It has been agreed that there will be joint visits, discussions and information sharing with regard to PPOs, in order that each agency can provide input.
- **Partnership Working**: The PPO team are continuing to support CDIP in their work with a PPO, with drug, alcohol and anger management issues.
- **Prevention**: The PPO officer has been instrumental in the conditions for an ASBO, for a PPO involved in ASB, shop lifting and violent offences. Due at court in April.
- **Prevention:** The crime saved estimator shows that 30crimes were saved to date in FY2008/9 (base level), 150 using the F multiplier (a close approximation to BCS).
- **Rehabilitation & Resettlement:** The PPO team are participating in the formation of a working group to discuss and formalise a county-wide Prison Release Protocol for housing/accommodation.
- **Rehabilitation & Resettlement:** The PPO team have been assisting the family of 2 PPOs in their bid to be re-housed. Along, with providing the agencies concerned with information and support.

2. Areas of Concern (what has not gone well)

Support for PPOs to establish and sustain suitable accommodation, including ensuring housing advice is available to support their rehabilitation and resettlement.
