Exclusion of Press and Public



If exempt (confidential) information has been provided as part of the agenda, the Press and public will not be able to view it. There will be an explanation on the website however as to why the information is exempt.

Notes

- (1) Some development control matters in this Agenda where the periods of consultation and representation may not have quite expired are reported to Committee to save time in the decision making process. Decisions on these applications will only be made at the end of the consultation periods after taking into account all material representations made within the full consultation period. The final decisions may be delegated to the Corporate Manager (Planning and Sustainable Communities).
- (2) The Council considers every planning application on its merits and in the context of national, regional and local planning policy. 2. Please don't lecture me (or anyone else who lives in Bourn) on S.178 or S 106 Agreements – So was The Golf Course at Cambourne covered by one – where is it now? -- So was the limit of 3,000 Houses in "three villages" – how many are there now? -- All those and many many more things were promised to us all by Councillor Daphne Spink then head of the SCDC panning committee (and a person we all knew and Trusted 'till she left the area and we were in the useless hands of others replacing her) Etc!! All of which PROMISES have been totally and utterly abandoned by the enforcement officers and Councillors of SCDC – SO -- We don't believe any of the words or the paper they are written upon after our bitter and disastrous experiences with the last "permitted development"! All we are told has been/is "times have changed" --- that is not what was PROMISED to be a part of the development in perpetuity!!!!!!

It is very clear to see that even if the "no left turn" arrangement works to the north (right) of the green shading o the plan --- there is an obvious(in time to come) route out onto The Broadway from both Cambourne and Bourn Airfield [BAD] via the said to be "Bus Route only" ["Said to be" because we have had those sort of promises many times before which have **always** been broken – viz all the happenings above and with "Wincanton Transport" – which was in the end only stopped using the airfield because of OUR – **not your** – persistence in monitoring non-permitted movements through our village!!

To all Planning Committee attendees I would like to make the following points for you to consider. As this new development will greatly increase the traffic on local roads the developer and South Cambs District Council has a duty of care to all local residents. I believe that to fulfil this commitment the council should establish a bridleway to run alongside the present proposed footpaths and cycle ways designed to surround the development (similar to Cambourne) for the following reasons:

1. Horse and human safety – the more that horses and riders are able to avoid traffic the better for the horses, riders and car drivers, not to mention the ambulance and health services. Any enquiry will reveal some serious cases of human injury – most often to the rider.
2. To utilise and enhance the existing footpath/bridleway system. At present you can ride/walk (and I think cycle) from Coton through Hardwick, Highfields, Bourn, Cambourne, Caxton and further.
3. A Highfields connection would enable horses from Childerley to access off-road riding and there are some excellent horses/riders over there – up to international level.
4. Horses do provide employment opportunities (often overlooked). My son made a life as a professional jockey and is still fully employed with horse work. A friend's daughter (local) is in horse therapy and Newmarket (the horse centre of the UK) provides job training and opportunities. Giving youngsters the opportunity to have a background in horses is very beneficial and should be encouraged in this rural area and does help the horse "families" in the villages, which is particularly beneficial for younger people.
5. South Cambs is developing intensely and rapidly. Bridleways do help to retain the South Cambs "feel".
6. The present national situation has illustrated how important physical activity and recreation are for physical and mental health. Horse riding is excellent for this.

I trust that the above issues will cause you to include bridleway facilities in the new development.
