2. M11 northbound junction 9a - bridge joint replacement

National Highways plan to carry out urgent bridge joint replacement work on the M11 northbound at junction 9a to ensure the M11 continues to remain in a safe and serviceable condition.

They plan to complete this work over **five nights** between **Monday 29 April and Friday 3 May 2024.** They will work between **9pm and 5am** on weeknights only, weather conditions permitting.

Closures and diversions

To carry out the work safely, National Highways will need to close the M11 northbound at junction 9A between the exit and entry slip, and divert traffic as detailed below:

 Traffic will be diverted off at junction 9a via the exit slip before rejoining the M11 / A11 via the entry slip.

A map of the diversion can be found below.



The sale of plastic wet wipes is set to be banned under new laws to be passed this year, it has been reported.


