The Sub-Committee has considered the application very carefully and has had due regard to the Licensing Act 2003, the accompanying Guidance and Regulations and the SCDC Licensing Policy. We have read and considered the letters from representees and heard the evidence of the applicant and those making representations within the scope of the Act. These representations concentrated especially on the objectives relating to the protection of children and the prevention of nuisance.

The application is approved and the licence granted subject to the following conditions:

 This licence applies only to the interior of the permanent built structure of Unit 16a Norman Way Industrial Estate, Over as at the date of the application. For the avoidance of doubt, the licence does not extend to the garden area between the Unit and Longstanton Road or any structure whether temporary or permanent erected therein. This is for the protection of children and prevention of public nuisance. The garden site is adjacent to a public road and activities there are within the audible range and view of people using public space and of neighbouring residents

- The conditions agreed between the applicant and the Police set out within the letter and appendix dated 1 July 2008, received by the Licensing Authority from the Divisional Licensing Officer of Cambridgeshire Constabulary shall be incorporated into this licence save as conflicts with the limitation of this licence to the built structure of the Unit
- The rules for the premises dated 30 June 2008 shall be incorporated in this licence, amended and supplemented such that:

Patrons of the Premises shall only be admitted to the environs of the Norman Way Industrial Estate and to the Premises themselves upon production of a photo identity card issued by the Licence Holder upon prior application at least 48 hours before admission

Personal details, including full names and addresses as verified by production of official documentation of the nature of a driving licence, passport or equivalent, of patrons issued with photo identity cards shall be maintained and kept available at the Premises for inspection by the Licensing Authority or Police on request

Rule 10 shall require patrons who are displaying the effects of having consumed an excessive amount of alcohol to be excluded from the Premises

A rule shall be added requiring patrons to respect and have regard to the residential amenity of neighbours at all times whilst visiting, leaving or in the proximity of the Premises

Interested parties and responsible authorities may apply for a review of the licence on a ground relating to one or more of the licensing objectives should there by any relevant issues arising from the operation of the premises licence at any stage in the future. The four licensing objectives are: the Prevention of Crime and Disorder; Prevention of Public Nuisance; Public Safety and Protection of Children from Harm.

The applicant and objectors have a right of appeal to the Cambridge Magistrates' Court within 21 days of receiving notification of this decision.
