#### **GUIDANCE NOTES FOR VISITORS TO SOUTH CAMBRIDGESHIRE HALL**

While the District Council endeavours to ensure that visitors come to no harm when visiting South Cambridgeshire Hall, those visitors also have a responsibility to make sure that they do not risk their own or others' safety.

#### Security

Members of the public attending meetings in non-public areas of the Council offices must report to Reception, sign in, and at all times wear the Visitor badges issued. Before leaving the building, such visitors must sign out and return their Visitor badges to Reception.

#### **Emergency and Evacuation**

In the event of a fire, a continuous alarm will sound. Evacuate the building using the nearest escape route; from the Council Chamber or Mezzanine viewing gallery this would be via the staircase just outside the door. Go to the assembly point at the far side of the staff car park.

- **Do not** use the lifts to exit the building. If you are unable to negotiate stairs by yourself, the emergency staircase landings are provided with fire refuge areas, which afford protection for a minimum of 1.5 hours. Press the alarm button and wait for assistance from the Council fire wardens or the fire brigade.
- **Do not** re-enter the building until the officer in charge or the fire brigade confirms that it is safe to do so.

#### **First Aid**

If someone feels unwell or needs first aid, please alert a member of staff.

#### Access for People with Disabilities

The Council is committed to improving, for all members of the community, access to its agendas and minutes. We try to take all circumstances into account but, if you have any specific needs, please let us know, and we will do what we can to help you. All meeting rooms are accessible to wheelchair users. There are disabled toilet facilities on each floor of the building. Hearing loops and earphones are available from reception and can be used in all meeting rooms.

#### Toilets

Public toilets are available on each floor of the building next to the lifts.

#### **Recording of Business**

Unless specifically authorised by resolution, no audio and / or visual or photographic recording in any format is allowed at any meeting of the Council, the executive (Cabinet), or any committee, sub-committee or other sub-group of the Council or the executive.

#### Banners, Placards and similar items

No member of the public shall be allowed to bring into or display at any Council meeting any banner, placard, poster or other similar item. The Chairman may require any such item to be removed.

#### **Disturbance by Public**

If a member of the public interrupts proceedings, the Chairman will warn the person concerned. If they continue to interrupt, the Chairman will order their removal from the meeting room. If there is a general disturbance in any part of the meeting room open to the public, the Chairman may call for that part to be cleared.

#### Smoking

Since 1 July 2008, the Council has operated a new Smoke Free Policy. Visitors are not allowed to smoke at any time within the Council offices, or in the car park or other grounds forming part of those offices.

#### Food and Drink

Vending machines and a water dispenser are available on the ground floor near the lifts at the front of the building. Visitors are not allowed to bring food or drink into the meeting room.

#### **Mobile Phones**

Visitors are asked to make sure that their phones and other mobile devices are set on silent / vibrate mode during meetings or are switched off altogether.

#### 92. APOLOGIES

Apologies for absence were received from Councillor Linda Oliver (Cambridgeshire County Council), Councillor John Reynolds (Police Authority), DCI David Sargent (Cambridgeshire Constabulary) and Darcy Weaver (Cambridgeshire NHS).

#### 93. DECLARATIONS OF INTEREST (CHAIRMAN)

Councillor David Jenkins declared a personal interest as his son is a police officer.

#### 94. MINUTES OF PREVIOUS MEETING

The Crime and Disorder Reduction Partnership accepted the minutes of the meeting held on 26 October 2009 as a correct record.

In relation to Minute 81 (Strategic Assessment and Priorities), LR said that work on Anti-Social Behaviour in South Cambridgeshire was ongoing, but no longer set as a priority as it was recognised that the work is core business of the CDRP.

#### 95. CLARIFICATION OF FIRE & RESCUE SERVICE REPRESENTATIONS (CHAIRMAN)

RH reported that he had been appointed Head of Community Safety

within the Fire & Rescue Service. Partners agreed that they were happy for him to continue to chair the South Cambridgeshire Crime and Disorder Reduction Partnership, with Julian Fountain representing the Cambridgeshire and Peterboroough Fire and Rescue Service on the CDRP Board.

#### 96. SAFER AND STRONGER STRATEGIC BOARD

RH reported, that CDRP revenue funding for 2010-11 would remain at existing levels for the CDRP, but that capital would be pooled and spent wherever it was needed most within the county of Cambridgeshire.

#### 97. NOTE Q3 PERFORMANCE REPORT, AND IDENTIFY NECESSARY ACTIONS (LEIGH ROBERTS / NEIL WESTON)

The Crime and Disorder Reduction Partnership received and discussed the Quarter 3 Performance Monitoring Report (October to December 2009).

In connection with Priority 3 (Reducing Domestic Violence), the CDRP noted that a new Chairman (CI Dave Sargent) and Vice-Chairman had been appointed to lead the Task Group.

In connection with Priority 4 (Reducing Burglary), CS undertook to speak with his opposite number at Cambridge Police to explore opportunities for closer collaboration between the South Cambridgeshire and City Crime and Disorder Reduction Partnerships, thus achieving benefits for both.

#### 98. NOTE UPDATE ON 2009/10 FUNDING (NEIL WESTON)

The Crime and Disorder Reduction Partnership received and discussed a progress report relating to 2009-10 funding as at 31 December 2009.

The Crime and Disorder Reduction Partnership **approved** the proposals set out in Appendix A to the report.

# 99. AGREE REFRESH OF CDRP ROLLING PLAN 2010-11 (CHAIRMAN / JENNY MASSIE / NEIL WESTON)

The Crime and Disorder Reduction Partnership considered a report on the 2010-11 refresh of the CDRP Rolling Action Plan.

The Crime and Disorder Reduction Partnership **approved** the 2010-11 Rolling Plan refresh, as set out in Appendix B to the report.

# 100. AGREE PROVISIONAL 2010-11 CDRP FUNDING PLAN (PHILLIP ALDIS)

The Crime and Disorder Reduction Partnership considered a report on the provisional spending plan for 2010-11.

The Crime and Disorder Reduction Partnership agreed:

# Recommendation (a) Project 1 CDRP Partnership Support Officer post (part-time)

That the CDRP approves the allocation of £27,000 towards this post (including salary and on-costs)

#### Recommendation (b) Project 2 CDRP ASB Caseworker post (parttime)

That the CDRP approves the allocation of £27,000 (including salary, oncosts, maternity leave and maternity cover) to address Anti-Social Behaviour

#### Recommendation (e): Pooled Fund

That the CDRP Board agrees not to contribute further to the Pooled Fund in 2010-11, but will consider funding emerging projects and initiatives that directly contribute to the three priority areas in the Rolling Plan.

#### **Recommendation (f): Pooled Fund**

That the CDRP Board tasks the Executive Board to draw up a separate Pooled Fund Spending Plan for approval by the CDRP board in July 2010.

#### Recommendation (g): Safer and Stronger Communities Fund

That the CDRP Board approves the Executive Group recommendation allocating the remaining £13,273 SSCF revenue as follows:

- Domestic Violence £4,000
- Serious Acquisitive Crime £4,000
- Reducing Re-offending £4,000
- Work on Anti-Social Behaviour £1,273

AS reported (minute 96 refers) that capital funds were now to be allocated from a county pot. Those present noted that Recommendation (c) Project 3: Capital project: Making homes resilient to burglary and Recommendation would now be progressed by making an application to

the County fund in April and that

(d) Project 4: Capital project: CDRP Community Chest. would not be progressed.

# 101. CDRP FOCUS: REDUCING OFFENDING (MICK HARDING / GARY GOOSE)

The Crime and Disorder Reduction Partnership considered a brief report on reducing re-offending.

Detective Chief Inspector Gary Goose was in attendance to highlight the imminent statutory responsibility, under the Police and Crime Act 2009, for Crime and Disorder Reduction Partnerships, together with Scrutiny

Committees, to monitor the rates of re-offending having regard to the views of local people about policing.

# 102. FEEDBACK FROM MEETING WITH SCDC SCRUTINY AND OVERVIEW COMMITTEE (CHAIRMAN)

RH described his meeting with the South Cambridgeshire District Council Scrutiny and Overview Committee as positive. A similar meeting had been scheduled for September 2010.

# 103. UPDATE FROM ROAD SAFETY PARTNERSHIP (CLLR RAY MANNING)

As Councillor Ray Manning had sent apologies for absence, the Crime and Disorder Reduction Partnership noted that this item had been withdrawn from the agenda.

#### 104. GROWTH UPDATE

The Crime and Disorder Reduction Partnership received and noted the Growth Areas Highlights Report issued on 20 January 2010.

#### 105. FORTHCOMING CONSULTATIONS

The Crime and Disorder Reduction Partnership noted a forthcoming consultation with older people.

#### 106. APPRECIATION

PA reminded the Crime and Disorder Reduction Partnership that LR was about to go on maternity leave, and NW would be returning to GO-East on 25 February 2010 at the end of his secondment. On behalf of the CDRP Board, RH conveyed his appreciation of the contribution made by both.

#### 107. DATE OF NEXT MEETING

The CDRP noted that its next meeting would be held at 10am on Monday, 26 April 2010.

#### 2.1 Quarterly progress report

#### 1. Key Achievements (What has gone well): Enforcement:

- A PPO was sentenced to 10 months custodial for burglary.
- A PPO was released from custody on a 3 month Probation YOI licence. Licence conditions, included a curfew. This has been enforced by visits from Police Officers, during the curfew hours, in order to check that it is being adhered to.
- A PPO was arrested for burglary at a school premises. This was subsequently NFA'd

#### Partnership Working:

- A multi-agency meeting was convened to discuss accommodation issues for a PPO. The purpose of the meeting being to assist the tenant in maintaining the tenancy and deal with any issues arising from the PPO residing there.
- The PPO Probation Officer assisted in the arrest of a PPO, wanted by the Police following a Threats to Kill incident.
- The PPO Team are continuing to participate in the focus group, working on a county-wide Prison Release Protocol, for the housing and support needs of (ex) offenders.

#### Prevention:

- A PPO was encouraged and supported in a benefits claim. This was then used to pay their 'keep' and provided them with funds.
- ASB in an area where a PPO resides was made a Neighbourhood Panel Priority and was raised as a referral at the S Cambs ASB PSG.
- A PPO (under the Deter strand) and their family have been accepted under the Family Intervention Project (FIP), offering intensive, whole family support through voluntary engagement.
- The crime saved estimator shows that 34crimes were saved to date in FY2009/10 (base level), 170using the F multiplier (a close approximation to BCS)

#### **Rehabilitation & Resettlement:**

- The PPO Police Officer and PPO Support and Resettlement Support Officer, provided support for two PPOs and their families, with regard to problems with them residing in the family home. Referrals were made in order to start the process towards independent accommodation.
- Funding was made available, to enable two PPOs to undertake the preparation and to sit the test for a CSCS card. It is hoped that when this qualification is gained, employment will be available.
- A PPO continues to work with the Probation Complex Cases Worker with regard to mental health issues.

#### **Priority Area: Cambridge City and South Cambs**

#### Lead Officer: Simon Kerss

#### Key Achievements during this Quarter<sup>8</sup>

- There have been two Taskgroup meetings this guarter. The 2009/10 action plan was signed off in March.
  - A new Chair, CI Dave Sargent, was appointed on 29<sup>th</sup> March. •
  - Domestic Violence Training and Awareness Day held on 3rd February at Trinity Centre, Cambridge. 55 delegates attended. Evaluation forms show the event was a success.
  - Skyguard alarms are being trialled in South Cambs. This is a GPS-based system replacing jackpot alarms.

#### Areas of Concern for Partnership to Note<sup>9</sup>

The current Task group is a useful meeting to exchange information but is not • performing satisfactorily for the sponsor CDRP/CSPs. An increase in Taskgroup membership has not automatically led to an increase in output, with many members being unable to commit resources to the Taskgroup action plan. Instead, many Taskgroup members now see the Taskgroup as a forum for discussion, rather than accountable sub-groups of the CDRP. The number of meetings is problematic for people that attend all DV task groups.

#### <u>Recommendations to Partnership to Address Concerns<sup>10</sup></u>

To combine the City/South Cambs and East Cambridgeshire Domestic Violence Task Groups into one larger group, and align this new group's boundary with the Constabulary's Southern Sector Basic Command Unit (BCU). This new group would be known as the Southern Cambridgeshire Domestic Abuse Task group and Chaired by CI Dave Sargent. To ensure local interest and focus, each new Taskgroup will hold a minimum of two practitioner-focused fora per financial year, to spread good practice, provide updates on relevant issues and enable discussion between agencies and individuals.

#### State of the Partnership Briefing: 4<sup>th</sup> Quarter 2009/10

#### 1.0 Purpose:

1.1 To update Cambridgeshire's Community Safety / Crime and Disorder Reduction and Domestic Violence Partnerships on developmental, operational and strategic issues regarding the work of Cambridgeshire's Domestic Violence Partnership.

#### 2.0.1 Background:

- 2.0.2 At the July 2009 Community Safety Partnership Officer Support Group, it was agreed that the format of the following report would be aligned with those provided to the Cambridgeshire Domestic Violence Partnership Strategic Group to ensure that partners are provided with an overview of county issues.
- 2.0.3 The three main priorities of the DVP's 2008 2011 action plan/strategy are: **Prevention & Early Intervention, Protection and Justice, and Support.** Subsequently, this report will reflect these priorities.

#### 3.0 **Prevention and Early Intervention:**

3.1.1 The NI32 repeat rate for Cambridgeshire at the end of 2009/10 is 27.5% (Central 26% / Southern 29%), so the stretch target of 28% has been achieved. Demand for MARAC services continues to rise and a review into managing this increase has been commissioned via the Information Systems and Crime Team at Cambridgeshire County Council for May 2010.

- 3.1.2 The East Cambridgeshire DV Taskgroup's Training and Awareness event was held in Sutton on 26<sup>th</sup> March 2010. The day was attended by over 60 professionals from the District and attendees had the opportunity to listen to key-note speeches from Simon Kerss (Domestic Abuse Partnership Manager), Kay Elmy (Sexual Assault and Referral Centre Manager), Christine Papworth and Clare Cooper (Refuge) and others, before moving into workshops to examine ways of improving outcomes for those affected by DV and Sexual Violence.
- 3.1.3 The City and South Cambridgeshire DV Taskgroup's Training and Awareness event was held in Cambridge on 3<sup>rd</sup> February 2010. The day was attended by over 50 professionals from across the two Districts and attendees had the opportunity to listen to key-note speeches from Niki Clemo (Chair, Cambridgeshire Domestic Abuse Partnership), Gaynor Mears (Go-East Regional Coordinator for Domestic and Sexual Violence), DS Shane Fasey (Cambs. Constabulary), Anne Webber (Solicitor), Simon Kerss (Domestic Abuse Partnership Manager) and others.

- 3.1.4 An Early Years and Childcare domestic abuse awareness leaflet campaign delivered in partnership with the Domestic Abuse Unit and Education Child Protection was undertaken across East Cambs. in January 2010 to raise understanding of the issues and signpost services.
- 3.1.5 A proposal to restructure the county's DV Taskgroups is currently tabled the intention being to merge Fenland and Huntingdonshire into a new Central Cambridgeshire Group, with City/South/East forming a Southern Cambridgeshire group.
- 3.1.6 Central Government has been running an awareness campaign (TV, advertisements and online) targeting teenagers in abusive relationships since January 2010. Further details can be found at http://thisisabuse.direct.gov.uk/.

#### 4.0 **Protection and Justice:**

4.1.1 Work continues with partners to develop a community-based programme for men who use violence in their relationships. A framework for development has been agreed and it is expected that the programme will go live in December 2010.

#### 5.0 Support:

5.1.1 Work to address issues with generating reports from the MODUS database regarding the work of the county's Independent Domestic Violence Advocacy Service is now complete. Interim results for 2009/10 are below. A more detailed report on IDVAS performance is in development via Sandy Willatt (Commissioning and Performance Manager at Cambridgeshire County Council) and will be provided through the Safer and Stronger Management Information guide. Number of cases worked by the IDVAS per District are as follows:

Hunts:	233
Fen:	212
City:	292
East:	112
South:	136

- 5.1.2 Following a successful joint Constabulary/PCT bid for Independent Sexual Violence Advocate (ISVA) funding to support the work of the P/boro SARC across Cambridgeshire, the Domestic Abuse Unit has now recruited a fulltime ISVA to support those affected by Sexual Violence across the county.
- 5.1.3 The 'Sutton Model' of group intervention for children and their protective parents affected by domestic abuse is currently being piloted in Cambridge. A full evaluation will be available on completion of the project.
- 5.1.4 A Freedom Programme for adult female victims of DV is in development for South Cambridgeshire and will be available to residents in that District from the end of April 2010.
- 5.1.5 Work continues with the Making Cambridgeshire Count agenda to develop a multi-agency integrated unit. The project team is currently developing its business plan for consultation.

#### 6.0 Risks

6.1.1 That current work with Making Cambridgeshire Count and the Safer/Stronger members' Board will not lead to resources being assigned to DV interventions to mainstream the work of the DAU/IDVAS.

7.1.2 That CDRPs / Community Safety Partnerships support the MCC and Safer/Stronger agenda to achieve excellent services by improving provision, reducing the prevalence of DV and reducing repeat incidents across the county.



During Q4 2009-10 South Cambridgeshire CDRP accounted for 17% of the referrals to the IDVAS and 14% of referrals for the entire year 2009-10. The Domestic Abuse Partnership Coordinator reports that referrals for 2009-10 are down to 985 from 1,536 during the previous year on account of a change in system from reporting all referrals to only those adopted as caseload.

#### Police Incident data

These are 'all incidents which have been closed as Domestic Incidents, either verbal or violent, where parties are over the age of 18. 
#### Dwelling Burglary

Dwelling Burglary has been highlighted to the CDRP as an area of concern each quarter for the previous year. During recent months the volume of recorded offences has reached some of the highest levels experienced over the past three years. It has previously been highlighted that the CDRP needs to push resources into this area if it is to reach its target.

The partnership should consider closer working with Cambridge City CSP at this time as they are currently on their Vigilance programme concentrating on reducing their dwelling burglary figures.

Recorded offences for Dwelling Burglary during 2009-10 are 9.6% higher (549 offences to end Mar 10) than at the same time the previous year 2008-09 (501). There are some significant peaks in recorded offences during the year, notably Apr-May09, Nov-Dec-09 and Mar-10. In only one month, Sep-09, were fewer offences recorded than the average for the past three years. The CDRP priority to reduce offences below levels for 2008-09 has not been achieved.






South Cambridgeshire has slipped from 11<sup>th</sup> to 12<sup>th</sup> position when compared to most similar group members in the past three months and remains worse than average.





In Nov and Dec 2009 the total recorded offences are the lowest in any month over the past three years. Cleary there appears to be little interest in this type of crime whilst Dwelling Burglary is showing such significant increases.

# 6. Update from Cambridgeshire DAAT

## Service Updates:

Young People's DAAT Services

- As of 1st April 2010 there is a new DAAT-commissioned drug and alcohol services for young people in Cambridgeshire. The new service is called CASUS (Cambridgeshire Child and Adolescent Substance Use Service). It is part of the Cambridgeshire and Peterborough NHS Foundation Trust (CPFT), and will be working with young people living in Cambridgeshire and their families around drug and alcohol issues.
- CASUS has a specialist interest in reaching those young people that are seen as hard to engage where substance misuse may be part of a range of significant difficulties that the person may face.
- They have two office bases, one in Huntingdon and one in Cambridge. Their contact details are below:

- The County Council's Drug and Alcohol Action Team (DAAT) have joined forces with Go-Whippet Coaches to ensure that the drug and alcohol message gets out and about across Cambridgeshire. A Go-Whippet bus has been painted with FRANK's eye-catching branding and will be used on various routes around the county.

### Adult DAAT Services

- The Adult Drug Treatment services continue to exceed their targets for the numbers of clients in treatment.
- Harm reduction leaflets raising awareness of the dangers of injecting, and support available, are being circulated countywide to various outlets, including Addaction sites, pharmacies and GP surgeries.
- The length of time that clients have remained on a prescription with no other referrals being made in being examined. Whilst this may be the appropriate treatment for a minority of clients, there is a concern that this may be unnecessary for others. 97 of 1003 prescription clients at the end of November 2009 had been on prescription for over 5 years. This has been identified as being an issue across the country, with some clients remaining on prescription for over 15 years. Addaction are looking into these clients' cases with a view to address any potential issues.

### Alcohol Services

 Addaction will become the provider of Alcohol Treatment Services from 1st July. In the intervening period transition arrangements will be put in place for the transfer of clients.

- It is anticipated that Addaction will be promoting their new service during this transition and it will be vital for all partners to be aware of the new service and contribute to the signposting and referral of clients into treatment.
- The new contract has incorporated improved arrangements between treatment workers and those who come into the criminal justice system through alcohol misuse.

Cambridgeshire DIP (Drugs Intervention Programme)

- Addaction have successfully taken over the treatment services for the DIP from 1st April. A considerable benefit of this newly commissioned service is to facilitate comprehensive treatment and care planning from DIP to mainstream services and to facilitate access for clients into non treatment specific interventions not previously available to them.
- Client engagements remain in the region of 25 new cases per month across the county. This has been enhanced recently through the introduction of assertive outreach into Huntingdon and Fenland police custody suites having been well established within Cambridge and proving an effective referral pathway into the service.
- Further developments have been made in cementing relationships with prison CARAT and healthcare teams to actively encourage Cambridge-based prisoners to engage with community-based treatment providers on release. This also underpins the recent ambitions of DIP to be pivotal in the implementation of Integrated Offender Management whereby DIP/PPO becomes a merged resource, utilising resources and referral pathways more efficiently to identify and engage those most at risk of offending to engage with appropriate services.
- An annual DIP performance report will be compiled to highlight both the quantitative and qualitative impact and benefits of the service to both service users and the community as a whole in respect of outcomes and impact on offending. This report will be shared across the partnership and CDRPs once completed.

### <u>Performance Data - Quarter 3</u> (Cambridge City, South and East)

Please note that the performance indicator with regards to the numbers in treatment was amended in 2008/09 to record the numbers in effective treatment. This means that in order for clients to be recorded, they have to be retained in treatment for a minimum of 12 weeks. Consequentially, all performance data will be one quarter in arrears. The next quarter's data will be available in May.

- 478 Problem Drug Users recorded as being in effective treatment
- 584 all Adults (over 18s) recorded as being in effective treatment
- 290 clients in alcohol treatment year-to-date

Note: It is possible a client has engaged with two services and therefore may be recorded twice.

- Countywide, 183 clients aged under 18 are engaging with drug and alcohol treatment services. This cannot be broken down further due to the fact that some services operate countywide.

## Areas of Concern (What has not gone well):

- We have been identified as one of the lowest performing DAATs in the country with regards to planned treatment exits and therefore have been required to complete an action plan which will be reviewed on a quarterly basis with our service providers to improve this area of work.

### 2009-2010 CDRP FUNDING - UPDATE

### 1. Purpose

To update the CDRP Board on progress with 2009-10 funding as at the end of the financial year.

### 2. Background

In 2009-10 the CDRP received funding from two sources, as follows:

Safer & Stronger Communities Fund (SSCF)

- £90,120 total allocation
- A minimum of £22,847.00 of this was to be used as capital funding

CDRP Pooled Fund

• £ 35,480, consisting of £18,000 contributed in 2009-10 comprising of £4,500 each from SCDC, County Council, Police, Fire & Rescue Service and £17,480 already existing in the fund at the end of 2008-9.

### 3. CDRP Funding Position as at end of Q4 2009-10

- 3.1 At the CDRP Board meeting on 1 February it was agreed (minute 98) that funding could be reallocated from the Pooled Fund to the SSCF Revenue Fund to ensure the budget is spent.
- 3.2 The table in the attached Appendix shows the original allocation of funds and the revised funding allocation as well as progress updates on the projects the CDRP has funded during the financial year 2009/10.

### 2010-2011 CDRP FUNDING PLAN

### 1 Purpose

1.1 To update the CDRP Board on the current situation with 2010-11 CDRP funding as at April 2010.

### 2 Background

2.1 On 1 February 2010 the CDRP Board agreed to allocate SSCF Revenue funding as follows:

Partnership Support Officer£27,000ASB Caseworker£27,000

2.2 The remaining £13,273 would be allocated to the following priority areas:

Domestic Violence	£4,000
Serious Acquisitive Crime	£4,000
Reducing Re-offending	£4,000
Anti-Social Behaviour	£1,273

2.3 At the time of writing it was expected that the County Council will request a contribution in the region of £5,000 to a County piece of work relating to the priority area of reducing reoffending. The Board will be updated in due course.

#### 3. CDRP Pooled Fund 2010-11

- 3.1 There is currently £26,612.83 in the CDRP Pooled Fund. At the CDRP Board meeting in February it was requested that the Executive Group draw up a separate Pooled Fund spending plan for approval by the Board.
- 3.2 Funding of £1,560 has been allocated to broadcast on the Tesco TV channel in Bar Hill. This will be a 24 month package showing 4 messages per year. Each message will be repeated three times an hour.
- 3.3 At a meeting of the CDRP Executive Group on 7 April 2010 it was proposed that the Pooled Fund is allocated to the following themes:
  - Evaluation £ 6,653.20
     This money would be used to evaluate projects that have been funded by the CDRP in 2009-10 to ascertain if they have been value for money and ensure they were relevant to the priorities identified in the Rolling Plan.
  - ASB £6,653.20 This would be contingency funding for ASB issues and distributed as appropriate by the ASB task group.

- Youth Intervention £6,653.20 To support existing BCU projects or County youth work. The projects would be approved by the ASB Task Group before funding is allocated.
- Innovation £6,653.20 To be set aside to for pilot projects that would meet the priorities identified in the Rolling Plan.

### 4. Recommendation

- 4.1 That the CDRP Board approve the allocation of the CDRP Pooled Fund to the themes identified by the Executive Group.
- 4.2 That the Executive Group reports back quarterly on proposals and recommendations for the SSCF and Pooled Fund when appropriate.

### Purpose

- 2. Since the CDRP Board meeting held on 1 February 2010, the Executive group has met on 4 March and 7 April 2010.
- 3. The following items have been discussed and approved by the Executive Board:
  - 3.1 Agreed content of advertisement for ASB Caseworker Maternity Cover
  - 3.2 Agreed minimum standards for how anti-social behaviour is handled by the CDRP (this piece of work links to county, regional and national standards). This was circulated by email for comment by partners on 11 March 2010.
  - 3.3 Agreed to allocate £1560 of 2010/11 Pooled Fund to publicise CDRP Crime
     Reduction messages on Tesco TV in the Bar Hill store over the next 12 months.
  - 3.4 Agreed that the £3,000 capital funding (originally assigned for laptops and crime reduction) should be re-allocated to purchase some mobile CCTV equipment (no longer required by SCDC Environmental Services) to be deployed in response to ASB priorities set by Neighbourhood Panels and/or the ASB Task Group.
  - 3.5 Submitted proposals for CDRP SSCF funding 2010/11 (dealt with under agenda item 8)
  - 3.6 Submitted proposals for CDRP Pooled funding 2010/11 (dealt with under agenda item 8)
  - 3.7 Agreed to submit an application for £10,000 funding from County Capital Fund to repeat a Burglary reduction project ran by the CDRP in 2009-10.

### CHANGES TO STATUTORY DUTIES FOR CDRP'S

#### 1. Purpose

To update the CDRP Board on changes to statutory duties for CDRP/CSPs in England and Wales.

### 2. Background

2.1 Guidance has been received from the Home Office regarding statutory changes to the duties of CDRP's. These changes came into effect on 1 April 2010.

### 3. New duties for CDRP's

- 3.1 The guidance supports the statutory changes for CDRPs contained in Section 108 of the Policing and Crime Act 2009 and are summarized below:
  - 3.1a a new duty on CDRPs to formulate and implement a strategy to reduce reoffending by adult and young offenders
  - 3.1b Probation becoming a responsible authority of CDRPs, having previously been a cooperating body. The other responsible authorities are: police, police authorities, local authorities, fire and rescue, and health.
- 3.2 As well as these changes to CDRPs, Section 17 of the Crime and Disorder Act 1998, which places a duty on certain defined authorities to prevent crime and disorder, anti-social behaviour and substance misuse in their area, has been extended to include reducing reoffending.

### 4 South Cambs CDRP

- 4.1 The CDRP has prepared in advance for the changes:
  - (3.1a) New Rolling Plan agreed at February meeting includes statement and approach.
  - (3.1b) Probation has been an active part of the CDRP for some time, with input at Board and Executive meetings, PPO scheme and with the CCJB.

### 5. Recommendation

5.1 That the Board note the changes to statutory duties for CDRP's and records that it meets the new requirements.

### RECENT STATUTORY CHANGES FOR COMMUNITY SAFETY PARTNERSHIPS IN ENGLAND AND WALES

I am writing to you about our recent package of measures to strengthen Community Safety Partnerships. As you know, section 108 of the Policing and Crime Act 2009, which takes effect on 1 April 2010, means that Community Safety Partnerships (CSPs) have a new duty to reduce reoffending and probation becomes the sixth statutory responsible authority on CSPs.

Partnership working is central to delivering safer and more confident communities and will become even more crucial in the tighter economic climate, particularly in helping improve value for money of service delivery. These changes should further enhance the key role CSPs can play in bringing together and co-ordinating the actions of housing providers, health services, local authorities and other key players who have a critical role in cutting crime and reducing reoffending. I know that probation already plays an integral part in local partnership working and many CSPs have already adopted a more holistic approach to tackling crime that embraces reducing re-offending.

The duties of bodies listed under section 17 of the Crime and Disorder Act 1998, to exercise their functions with due regard to the likely effect on, and the need to do all that they reasonably can to prevent, crime and disorder, antisocial behaviour, and substance misuse in their area, have also been extended to include reducing reoffending.

The new duties strengthen the link between crime reduction and reducing reoffending. They also formalise the effective joint working that is already underway at local level through Integrated Offender Management (IOM) and schemes such as Prolific and other Priority Offenders (PPO). Reducing reoffending will impact on crime levels, make communities safer and improve public confidence and reassurance in the criminal justice system.

Working together to protect the public

There have also been amendments to two existing regulations to support these changes, which also take effect on 1 April: the **Crime and Disorder Strategy regulations** and the **Crime and Disorder Information Sharing regulations**. Further information about all of the above changes can be found in the annex to this letter.

The final change I wanted to bring to your attention is the amendment to the **Crime and Disorder Overview and Scrutiny regulations**, following our commitment in the policing white paper, *Protecting the public: supporting the police to succeed*, to enable the co-option of members of the public and community groups to Crime and Disorder Overview and Scrutiny committees. This amendment takes effect on 1 April and means that where these Committees believe they would benefit from having the objective voice and experience of the public, they will be able to invite a representative to sit on the Committee. This change will strengthen the ability of local communities to hold to account their local Community Safety Partnership for the services it delivers in their area.

### Policing and Crime Act 2009

The Crime and Disorder Strategy regulations set out minimum requirements for CSPs on various things including membership, community engagement, preparation of strategic assessments, partnership plans and information sharing. The regulations have been amended to update references to the duties and membership of CSPs to include reducing reoffending and specified probation service providers, and can be accessed through the following links:

# Crime and Disorder Information Sharing regulations<sup>2</sup>

The Crime and Disorder Information Sharing regulations set out the datasets that the relevant authorities have a duty to share every quarter. The original regulations were updated in 2008. This further update to the regulations places a requirement on providers of probation services that will become responsible authorities to disclose certain information, that when shared with other responsible authorities will facilitate partnership working to reduce reoffending.

The regulations also update references to the National Incident Category List

## Crime and Disorder Overview and Scrutiny regulations<sup>3</sup>

The Crime and Disorder Overview and Scrutiny regulations make provision for the exercise of powers by crime and disorder committees of local authorities, including co-option of additional members, frequency of meetings, information sharing, attendance and responding to recommendations.

The Crime and Disorder Overview and Scrutiny regulations have now been amended, following a commitment made in the recent Policing White Paper, and in effect will enable anyone to be co-opted, subject to the discretion of the committee, and with the exception of members of the executive of the committee's local authority. ### **NEIGHBOURHOOD PANELS**

### Purpose

- 1. The purpose of this report is to
  - (a) update the CDRP with regard to Neighbourhood Panel developments that have occurred over the past year,
  - (b) provide members with a summary of issues that have arisen at recent panel meetings.

### Background

- 2. There are seven neighbourhood panels in South Cambridgeshire, covering five police neighbourhoods. The first South Cambridgeshire panel meeting took place in early 2006 in the Histon neighbourhood and all panels are now well established. The seven panels are:
  - Histon
  - Sawston
  - Linton
  - Swavesey
  - Comberton
  - Gamlingay
  - Bassingbourn and Melbourn
- 3. The panels cover a wide range of issues, which require action from various agencies. The South Cambridgeshire panels have predominantly been police led both during meetings and in taking forward actions, stemming from the Government's requirement on the police to consult with the public and allow them to have a say and influence the setting of priorities for their area. There is a great deal of variety across the district; some panels are well attended and vibrant, others less so.

### **Panel Developments**

- 4. On 2<sup>nd</sup> December 2008 Cambridgeshire County Council (CCC) gave a commitment to engage more fully in neighbourhood panels across the county. Officers have been nominated to each of the neighbourhood panels in the district; they are required to represent the whole council rather than their specific team. The County Council's Cabinet also agreed a basic set of minimum principles that it would like panels to be governed by:
  - (a) A primary role for locally elected members from all tiers of local government;
  - (b) Substantial time allowed for open questioning from the public;
  - (c) Time set aside for Neighbourhood Policing issues; and
  - (d) 'Bottom-up' agenda setting.

- 5. The Local Strategic Partnership, following a recommendation by the District Council, agreed to consult all panel areas from August 2009 to March 2010 to establish if there was an appetite for extending meetings to cover other topic areas as well as those relating to community safety. The response from those attending the panels was strongly in favour of the panels remaining in their current format. Responses from people who do not currently attend panels were more varied about the issues they would like to be able to influence, however, many stated that they were unlikely to attend panel meetings for whatever issue.
- 6. Since the consultation the following recommendations were accepted by the Local Strategic Partnership and are currently being implemented:
  - (a) Include a definition of community safety on neighbourhood panel agendas and include these topics specifically in panel terms of reference to be published on the SCDC website, with copies available at all meetings.
  - (b) Reflect partnership working in panel branding and ensure LSP and Crime and Disorder Reduction Partnership banner pop-ups are displayed at each meeting.
  - (c) Include a regular agenda item of Local Consultations at neighbourhood panels, which will enable partners to highlight and/or present consultations as appropriate.
  - (d) Suggest that relevant partners consider alternative methods of involving residents in discussions and/or decisions about community and youth facilities.
  - (e) Ensure wider advertising of panel meetings in parish magazines and on the SCDC website, plus posters with a year of dates in local venues (updated in January each year).
  - (f) Review the Linton Neighbourhood Panel boundary in order to try to address the "inconvenient" nature of the geography (i.e. Horningsea), which is reflected in the consultation findings as well as attendance at panel meetings.
- 7. The District Council has also committed to senior level officer representation at panel meetings, which began in January 2010.
- 8. Informal conversations have recently occurred on a county level with NHS Cambridgeshire to consider their involvement with panels across the area.

### **Panel Priorities**

- 9. Appendix A shows the priorities set at the last two meetings for each of the seven panels. The priorities, in the main, relate to anti-social behaviour (17 of 40) or road safety (9 of 40)<sup>1</sup>.
- 10. Actions are either taken forward by an individual organisation or in partnership through the CDRPs task groups, as appropriate.
- 11. The agenda for each meeting includes an opportunity for attendees to hear feedback about what action has occurred and comment upon whether they feel there has been an improvement since the priority was set.

### Recommendations

12. The CDRP Board is recommended to note the content of the report.
