Thursday 3 November: BBC Online: Funding of £20m to support domestic abuse victims

Local Government will be able to bid for a share of a £20 million fund to support domestic abuse victims which has been launched by the Government.

The Government is to "delay" extending Right to Buy to housing associations, with the policy no longer at the top-of its "to-do list", according to the official in charge of implementing it.


