Thursday 7 February, Mail: LED streetlights

Councils are making large savings on carbon emissions and energy bills from a switch to LED streetlights, research by Press Association shows.

7. View Planning Applications





To view the list of planning applications that have recently been submitted to the Council, please visit the authority's on-line <u>Planning Application Search</u>. Once the page has loaded, you can use the <u>Search option</u> to set your own criteria of parish, area and date range.

The system will provide a range of information on current and decided applications since 1948, including a brief description of the development, reference number, decision and the date of decision. More recent applications show the name and telephone number of the council officer who is dealing with the application.

Search results are presented in a collection of pages, the number of which depends on the number of results your search produces. There are navigation tools to allow you to browse your results.

EXECUTIVE DECISIONS TAKEN SINCE WEDNESDAY 6 FEBRUARY



In accordance with the Access to Information Procedure Rules in Part 4 of the Council's Constitution, any executive decision shall be published normally within five days of being made. That record will bear the date on which it is published and will specify that the decision will come into force, and may then be implemented, on the expiry of 5 working days after the publication of the decision, unless called in for review by the Chairman of the Scrutiny and Overview Committee or by any five other councillors.

The call in procedure is set out in full in <u>Part 4 of the Council's Constitution</u>, 'Scrutiny and Overview Committee Procedure Rules'.

8. Waterbeach Supplementary Planning Documents Adoption

Cabinet

- noted the main issues raised in recent correspondence with the three statutory bodies (Environment Agency, Historic England and Natural England) and in their responses to the SPD consultation in respect of sustainability appraisal and habitats regulations and the considerations as set out in the supplementary report from the Joint Director of Planning and Economic Development (see Appendices A and B);
- 2. agreed responses to the representations received, and agreed the consequential changes to the draft SPD approved by Cabinet for consultation on 5 September 2018, as set out in the Consultation Statement:
- 3. adopted the Waterbeach New Town SPD, agreed by Cabinet on 5 September 2018 and as amended (see Appendices B and C); and
- 4. delegated to the Joint Director for Planning and Economic Development, in consultation with the Deputy Leader, the authority to make any editing changes prior to publication. Including to the figures and spatial framework diagram, to ensure consistency with the agreed text of the SPD.

A14 Cambridge to Huntingdon, Cambridgeshire: major improvements

Construction work on the new A14 Cambridge to Huntingdon scheme is underway. We are currently carrying out a variety of tasks for which we need to close lanes or carriageways on the A1, A14 and some local roads at times, usually overnight between 8pm and 6am, unless otherwise stated. A clearly signed diversion route will always be in place for closures.

For this week, the planned closures are:

Full closures

Monday 11 to Friday 15 (five nights)

A1 northbound between Buckden and Alconbury

Vehicles will travel east on the A428, north on the A1198, west on the A14 and then north on the A14 link road to re-join the A1

A1 southbound between Alconbury and Buckden

Vehicles will be diverted south on the A14 link road, then east on the A14, south on the A1198 and west on the A428 to re-join the A1

- Brampton Road
- A428 eastbound Madingley to A14 eastbound Fen Ditton junction 34

Motorway traffic will travel south on the M11, east on A505 and north on A11 to re-join the A14. Non motorway traffic will be diverted on local roads through Cambridge.

- M11 junction 14 exit slip
- A14 westbound between Six Mile Bottom junction 36 and Girton junction 31

Motorway traffic will travel south on the A11, west on the A505 and then north on the M11.

Non motorway traffic will diverted on local roads through Cambridge

Buckingway Road/Anderson Road

Friday 15 9pm to Monday 18 5am

- A1 northbound Brampton village exit and entry slips
- A1 southbound Brampton village exit and entry slips
