2. Amendments to parish council/meeting announcement for S211 tree work notices and TPO tree work applications

At the request of some local parish councils, Jane Green and the trees team have reviewed the letters which are sent out to the parish councils/meetings announcing a new S211 tree works notice or TPO tree works application has been received and being considered. The letter has been amended to give a clearer indication as to:

- If the case is a S211 tree works notice or a TPO tree works application,
- If the Council consider it minor tree works which should receive an outcome without delay or if it is a greater amount of tree works which will require review, and
- A clear but limited period in which people can comment on cases via the website.

Previously, the parish councils/meetings were notified at the point of validation but from now on, they will be sent at the point of initial triage (where cases are identified as being either major or minor).

Over the next few months we hope to provide some remote training to give a little more basic

information about tree work cases to those that are interested, and review the new system in six months' time (June/July) to see how the councils/meetings like the new system and make any adjustments as necessary.

3. Update: Highways England Roadworks Notification - M11 Junction 11, Mill Bridge: bridge maintenance

**Please see note below from Highways England:
M11 junction 11 Mill Bridge: bridge maintenance**

Following on from our previous communication, I write to update you on some changes in our work programme due to bad weather for the essential bridge maintenance work at the above location.

Due to weather conditions, we now plan to complete this work with following closures for each phase, as detailed below:

Phase 1: M11 Mill bridge, north bridge closure, starting 8pm Friday 22 January to 6am Monday 25 January

- Traffic on the A10 / Cambridge Road will be diverted via the A505 at Royston, before joining the A1301 to head towards Trumpington. **(Diagram 1)**
- Traffic from the A10 wanting to travel on the M11 southbound at junction 11, will be diverted northbound on the M11 to junction 12, A603 roundabout before returning southbound on the M11 to continue your journey. **(Diagram 2)**
- Traffic wanting to leave the M11 for Cambridge will stay on the M11 to junction 12, A603 roundabout before re-joining the M11 southbound to exit at junction 11 to join the A1309 / Hauxton Road. **(Diagram 2)**

Phase 2: M11 Mill bridge, south bridge closure, starting 8pm Friday 29 January to 6am Monday 1 February

- Traffic on the A1309 / Hauxton Road wishing to join the A10 will be diverted via the A1301, A505 westbound before joining the A10 at Royston. **(Diagram 3)**
- Traffic from the A1309 / Hauxton Road wishing travel northbound on the M11 will be diverted southbound to junction 10 to turn around and continue their journey northbound. **(Diagram 4)**
- Traffic wanting to leave the M11 for the A10 southbound from Trumpington will be diverted via the M11 junction 10 and return northbound to exit at junction 11 onto the A10. **(Diagram 4)**

We will contact you if there are any changes to the programme and update you with the most recent closure information.

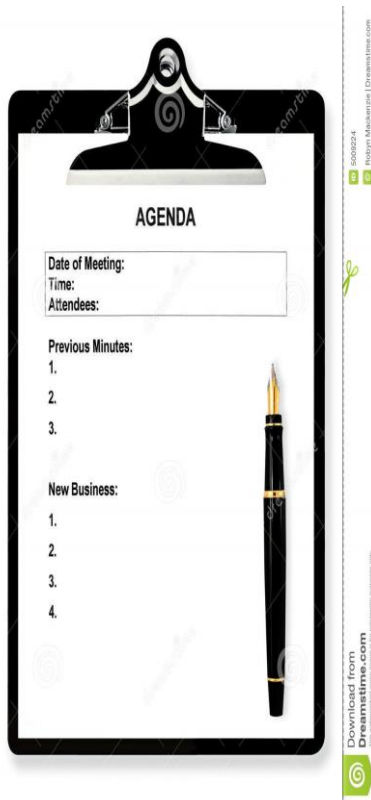

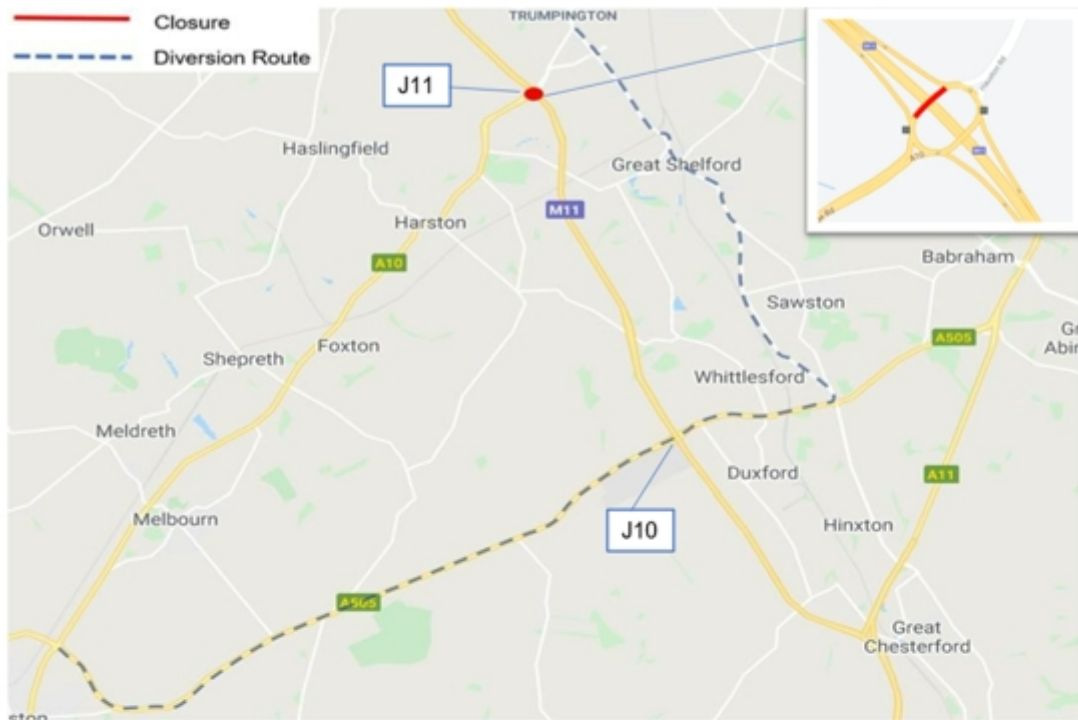

A14 Cambridge to Huntingdon, Cambridgeshire: major improvements

We are currently carrying out finishing works for which we need to close lanes or carriageways on the A1, A14 and some local roads at times, usually overnight between 8pm and 6am, unless otherwise stated. A clearly signed diversion route will always be in place for closures.

For this week, the planned closures are:

Full closures

Monday 25 to Friday 29 (five nights)

- B1514 Brampton Road between the Hinchingsbrooke Park Road emergency exit and Edison Bell Way

Vehicles on the Huntingdon town centre side will be diverted onto the ring road, Ermine Street B1044 to Spittals roundabout, A141 west to Brampton / Brampton Racecourse junction and into Brampton via B1514. Vehicles on the Brampton side of the closure will follow this diversion in reverse.

Residents living between the closure points will be provided with an escort

Monday 25 to Tuesday 26 (two nights)

- A1307 westbound between Swavesey North roundabout and Fenstanton

Vehicles will be diverted east on A14 to Histon junction 32, exit and return on the A14 westbound to the A428. North at Caxton Gibbet onto the A1198 and onto the A1307 at Godmanchester

Monday 25 (one night)

- A1307 eastbound exit slip from A14 at Girton

Vehicles wishing to exit the A14 to the A1307 Huntingdon Road will be warned in advance to exit the A14 at Bar Hill junction 25 to access the A1307

Wednesday 27 to Thursday 18 (two nights)

- A1307 eastbound between Fenstanton and Swavesey North roundabout

Vehicles will be diverted west on the A1307 to Godmanchester, south on A1198, east on A428 to the A14. Exit the A14 at Histon junction 32 and return on A14 westbound to Swavesey junction 24b

Saturday 30 5am to 11.59pm (19 hours)

- Brampton Road B1514 between station car park and Edison Bell Way

Vehicles on the Huntingdon town centre side will be diverted onto the ring road, St Peters Road to A141 west to Brampton / Brampton Racecourse junction and into Brampton via B1514. Vehicles on the Brampton side of the closure will follow this diversion in reverse.

Pedestrians will be diverted alongside the car park and under the railway line to join Edison Bell Way by Aldi
