Thursday 9 December, Guardian: <u>Fly-tipping in England increases during pandemic</u> Fly-tipping incidents in England increased last year during the pandemic according to government figures.

#### Friday 10 December, BBC News: Dozens eyeing council tax rise

Two thirds of Councils in England are considering a rise in Council Tax next year in order to help fund services, with many unable to rule it out, BBC research finds.

#### Friday 10 December, Independent: Plans to radically after Local Government

The Government reportedly plan to use the upcoming levelling up white paper to introduce a single-tier mayoral-style system across the whole of local government, according to a leaked draft document.

#### Friday 10 December, Express: Fly-tipping incidents surge

Councils dealt with 1.13 million cases of fly-tipping between March 2020 and March 2021, in increase of 16 per cent on the 980,000 reported the previous year.

#### Saturday 11 December, Express: Millions could face council tax rise

Millions across the UK could see their council tax rise as two thirds of councils in England are considering an increase in order to help fund services, with many more unable to rule it out.


#### Monday 13 December, Mail: Fly-tipping

Three in five councils did not carry out any prosecutions last year for fly-tipping while one if five issued no fixed penalty notices, according to data obtained under Freedom of Information requests.

# Tuesday 14 December, Times: <u>Businesses to get more funding and possible furlough</u> support if further lockdown is imposed

The Times reports that businesses will be supported with new state funding including a potential return to furlough, if the Government orders further lockdown restrictions to tackle the Omicron variant.

#### **Executive Decisions Taken Since Wednesday 8 December**



In accordance with the Access to Information
Procedure Rules in Part 4 of the Council's
Constitution, any executive decision shall be
published normally within five days of being made.
That record will bear the date on which it is published and will specify that the decision will come into force, and may then be implemented, on the expiry of 5 working days after the publication of the decision, unless called in for review by the Chairman of the Scrutiny and Overview Committee or by any five other councillors.
