## HEARING PROCEDURE

## 1. Introduction

- The Chairman of the sub-committee will welcome and introduce everyone present, giving explanations of roles where necessary, and outline the procedure to be followed.
- The hearing will take the form of a discussion to be led by the sub-committee.
- Members of the sub-committee will be able to ask questions of any party, or the Licensing Officer, at the hearing. They will try, so far as possible, to ask their questions at the conclusion of each party's submission.
- The sub-committee will consider any requests for permission to ask questions of other parties. It will decide if questions are required in order for it to consider the case properly. If permission is given to one party, it will usually be given to all other parties.
- The Chairman may ask any person behaving in a disruptive manner to leave and may refuse to permit that person(s) to return or may permit them to return with specified conditions. Such a person may, before the end of the hearing, submit to the authority in writing any information which they would have been entitled to give orally had they not been required to leave.
- Members of the sub-committee will be asked to make any Declaration of Interests.

### 2. Witnesses

The sub-committee will consider any requests from any of the parties to call witnesses.

### 3. New evidence/information

The sub-committee will consider any requests for permission to present new evidence or information not previously disclosed to all the parties and the sub-committee prior to the hearing. The general rule is that such information or evidence must not be considered unless all parties at the hearing agree to it being considered on the day of the hearing. A request may be made for a short adjournment to allow time for everyone to receive copies of the extra information and time to read it.

## 4. Allocation of time

Each party will be asked for a time estimate for the presentation of their case. The sub-committee will hear all estimates and then allocate each party an equal amount of time to speak.

## 5. Licensing Officer's report

The Council's Licensing Officer will outline details of the application and representations received by the council. No recommendation to members will be made.

## 6. Applicant's case

The applicant will present their case first. They have a right to:

- address the sub-committee on any points of clarification the council has sought;
- address the committee generally; and
- call any witnesses that they have been given permission to call. Witnesses may be crossexamined if permission is granted. If this happens, the time taken for questions will count towards the allocated time of the party asking the questions, not the party answering them.

Members of the sub-committee may ask questions of the applicant.

## 7. Police representations

The Police will make any representations about the application, with the same rights as listed at s.6. Members of the sub-committee may ask questions of the police representative.

## 8. "Responsible authorities" representations

Other "responsible authorities" (Police/Fire/Environmental Health Officer/Social Services/Trading Standards/Planning Directorate) will then make representations, with the same rights as listed at s.6. Members of the sub-committee may ask questions of those authorities represented.

## 9. Any other representations

Anybody else making representations will go last, with the same rights listed at s.6. Members of the sub-committee may ask questions of any person who has made a representation.

## 10. Legal advice

Once all parties have presented their cases to the sub-committee, and the members of the subcommittee have no more questions for any of the parties, the Council's Legal Officer will be asked to outline any relevant legal guidance.

## 11. Decision-making

The sub-committee will then retire to another room to make its decision. The Council's Legal Officer and Clerk will accompany members to advise where necessary and take notes of the decision.

## 12. Notification of decision

Depending on the nature of the application, a determination of the case will either be made at the conclusion of the hearing, or within 5 working days. In most cases, all parties will be notified of the decision in writing.

## **Application for Variation of a Premises Licence:**

# LJs Sandwich Bar, 40 Church Street, Gamlingay, SG19 3JH

## **Executive Summary**

 The Committee is asked to determine an application for the Variation of a Premises Licence under section 17 and 18 of the Licensing Act 2003, which has been subject to representation from local residents and Gamlingay Parish Council.

## Recommendations

- 2. It is recommended that the Committee determine the application for the variation of a premises licence at a hearing pursuant to section 18(3) Licensing Act 2003.
- 3. The Council, the applicant and all persons who made valid representations may agree to dispense with the hearing provided notice is given in accordance with The Licensing Act 2003 (Hearings) Regulations 2005 regulation 9.

## Details

- 4. On 25 October 2021, an application for the variation of a premises licence for LJs Sandwich Bar & Barista, 40 Church Street, Gamlingay, SG19 3JH was submitted to the Licensing Authority, and advertised and consulted upon.
- 5. The application is to :
  - Extend the terminal hour for the supply of alcohol for consumption on the premises from 12:00 until 22:30 Monday to Sunday. The licence currently permits the supply of alcohol from 12:00 until 15:00 Monday to Wednesday and 12:00 until 21:00 Saturday and Sunday.
  - To extend the opening hours of the premises until 23:00 each day (to enable a 30 minutes "drinking up time" following the last sale of alcohol.

- To amend the existing condition so as to read "The courtyard will be closed to customers for the consumption of alcohol and/or food after 23:00 every day." (the condition currently states until 21:00 every day).
   Note paragraph 10 below which amends this condition.
- 6. The application form is attached as **Appendix A**, the plan of the premises is attached as **Annexe B** and the location plan indicating the location of the residents who submitted representations is attached as **Appendix C**.
- 7. The existing licence is attached as **Appendix D**.
- 8. The application was advertised in the Cambridge News on 2 November 2021, and the site notice displayed on the premises as required. A copy of the advertisement is attached as **Appendix E**.
- 9. Cambridge Fire and Rescue Service have no objection to the application but requested that a suitable and sufficient fire risk assessment must be conducted and documented of the premises under the Fire Safety Order, to help identify fire hazards and the measures and arrangements required to safeguard all relevant persons on the premises. The fire risk assessment should be conducted by a competent person with relevant knowledge, skills and experience of fire safety matters. A copy of the response is attached as **Appendix F**.
- 10. Environmental Health requested that the following condition be imposed on any licence that may be granted "Alcohol shall only be permitted in the external areas of the premises until 21:00 Sunday to Thursday and until 22:30 Fridays, Saturdays, Bank Holidays and Valentine's Day". The applicant has confirmed acceptance of this condition.
- 11. There were no responses from other Responsible Authorities.
- 12. Representations have been received from Gamlingay Parish Council (Attached as Appendix G1) and four local residents (attached as Appendices G2-G5). One resident (Appendix G3) submitted sound clips as part of the representation, and these have been emailed to the applicant.
- 13. The applicant submitted documentation in support of the application in response to the representations. Copies of the submission are attached as **Appendix H**. In addition, noise clips relating to noise from a neighbouring property have been circulated to all parties.
- 14. There are no policy presumptions within the Council's Statement of Licensing policy, against the grant of the licence unless it can be shown that the application would undermine or prejudice the licensing objectives.

## Options

- 15. The Sub-Committee in determining the application will consider the steps set out in section 18(4) Licensing Act 2003.
- 16. The Sub-Committee will decide whether to grant the licence (imposing all mandatory conditions) in the terms set out in the application or take any of the following steps before granting the licence:
  - a. To refuse to grant the application
  - b. To grant the application with (or without) conditions in full (or in part)
- 17. The Sub-Committee must give the reasons for the decision.

## Implications

18. In the writing of this report, taking into account financial, legal, staffing, risk, equality and diversity, climate change, and any other key issues, the following implications have been considered:-

## Legal

- 19. The Council, the applicant and all persons who made valid representations may agree to dispense with the hearing provided notice is given in accordance with The Licensing Act 2003 (Hearings) Regulations 2005 regulations.
- 20. When determining applications, the Sub-Committee recognises the Council as the licensing authority is required to carry out its functions with a view to promoting the licensing objectives;
  - the prevention of crime and disorder;
  - public safety;
  - the prevention of public nuisance; and
  - the protection of children from harm.
- 21. In considering the licensing objections the Council must have regard to its statement of Licensing Policy, and to the statutory guidance (Revised Guidance April 2018) issued under section 182 Licensing Act 2003. The application process is considered at section 8 of that Guidance. The procedure and information on hearings starts at 9.31 of that Guidance.
- 22. Any party aggrieved by the decision of the Sub-Committee has the right of appeal to the Magistrates' Court.

## **Risks/Opportunities**

23. The decision creates no additional risks or opportunities in the context of the Council's risk management.





#### Hostility, and intimidation if challenged about noise and smells

The applicants attitude to being challenged is anti social and sometimes physically intimidating. We tried for many months to communicate basic issues with every attempt to be friendly and accommodating. This approach failed and for two years the relationship has been almost hostile. So rather than pressing the applicant to make changes we have engaged with the Environmental team, as directed by the Licensing team, to press for a cancellation of the current licensing for which we have clear evidence of repeated breaches.

#### The Prevention of Public Nuisance

#### Systematic disregard to closing after agreed operating hours

The Bar & Brasserie have operated often past permitted hours both within but mainly in the courtyard with customers sometimes leaving after 10pm. Audio/video files have been provided as evidence of this repeated behaviour. This noise, typical for every Friday and Saturday evenings has prevented us from enjoying our garden, such that we hardly use it now preferring to sit in doors on pleasant weekend evenings. If the applicant behaved as a normal neighbour they firstly would not have what seems like parties all these days, and would try to be understanding, civil and take steps to avoid such noise and repetition. Their few signs are ignored by customers, and themselves as is clear from the recordings. We have video/ audio files with such noise from typically 6pm to 10pm every Friday and Saturday. Supplier deliveries occur between 5 and 5 30 several times every week for more than 3 years. The applicant has made no effort to stop this. Caroline has contacted the companies but they still continue to deliver early. They now don't have their radios on but still slam their doors which guarantees us an early wake up.

#### Noise

We suffer with continuous music and voices audible within several rooms of house, and in our garden that is adjacent to LJs courtvard. This happens even when the Bar and Brasserie are closed with music played for the applicants sole benefit. We have recordings demonstrating the noise we hear that are provided as evidence. The affect is we cannot relax and feel angry of our situation. Whilst in the house downstairs it is not overly loud, it is a constant noise much like a dripping tap that is analogous to Chinese water torture. Upstairs in the bedroom it is impossible to have an afternoon kip or to got to bed early as the noise is even worse. You can hear the low bass and drone of many voices and beat of music, and clear words when voices are raised. This can happen with just a few people using the bar and brasserie but increases when a large group excitedly raises voices to be heard all fuelled by the alcohol. In the lounge we need to turn up the volume on our television to not hear next door. In the kitchen we have to turn on our radio for the same affect. My wife uses our ensuite bathroom to study for her degree and needs to close two intermediate doors and turn on the shower fan to drown out the noise from LJs. It is ridiculous that we should have to do this. In the garden, the voices of customers and staff shout into our garden and disturb our relaxation, thoughts and own quiet discussion. No efforts are made to reduce the noise. The reality is that use of the courtyard is not viable in this location. The initial proposal was that the courtyard would allow smokers to smoke without doing do so on the street. The courtyard has seating for 19 and is often filled with eating and drinking customers. As mentioned earlier we have probably 100 hours of clearly loud audio/ video recording from 6pm to consistently past 9.30 and past 10 on some occasions. All comfortably past their permitted hours. When the business is not open for customers, typically most summer afternoons, Sundays and sometimes Mondays, the applicant will play the radio loudly that we cannot relax in the three adjacent rooms but more so in the garden. The constant beat of music is unsociable. The applicant does not care and is possibly enjoying our unhappiness. At the same time, the front door to the street is open and music is loudly broadcasting into street no doubt attempting to advertise that LJs exists, which is of course impossible to miss given the large waving flags and flashing lights in the evening. The affect upon us is worse as we get to hear it not only through the walls and structure, but also through our adjacent windows that have thin panes of glass as required of a listed building. Neighbours apparently have to turn their television on to make the sound entering their homes when window are open. The applicant does not care about the impact upon neighbours and the undermining of the charm and character of this historic village.

#### Noxious smells

The diary provides full details of the frequency of smells of food, drink and cleaning chemicals we experience in our main bedroom.

Their single refuse bin is frequently overfilled by close of play Saturday before emptying with bin collection on Monday morning. The affect of this is not clear, however, neighbours experience significant Rat problems that may feed on contents in these bins. Several years

#### **Risk of Asbestosis**

Not obvious to customers is the exposed Asbestos roof in courtyard that is within 1.5 metres of seating. No efforts have been made to remove, cover or warn customers of the risk in catching Asbestosis. Hopefully the committee are also concerned about this.

#### Lack of fire protection to listed adjacent listed building

Within the property, no physical modifications were made to ensure the increased risk of fire in LJs could reach the attached timber frame listed building. In 2010, the approved planning application to create the restaurant imposed the condition that prior to work commencing, the design to protect against fire, noise and odours needed approval by buildings inspectors. That application lapsed, and four years ago LJs took over the butchers with no planning application that would have required the same conditions. The only measures taken have been the purchase of fire blanket, extinguishers and signage. Risk of fire from cooking fats is now greater than when it was a butchers shop

# Objection to LJs, Church Street, Gamlingay application for extension of licensing hours, reference SCDCPL0510

Supplementary information supporting our 'Representation form for Interested Person/ Body'- Simon Bathie and Caroline Betts 36 Church Street, Gamlingay, Sandy, Beds, SG193JH

#### Summary

1

We object to this application to extend and request a review of the current license that will hopefully lead to it being cancelled. Since the approval of their current license, almost 3 years ago, we have had nothing but problems which have forced us to take this strong position. The motives for the applicant are clearly to run a bar and make money. Extending the hours would only allow the situation to get worse for us as the applicant has proven to have no intention to consider the detrimental impact upon us and other neighbours' needs. Any arguments that this extension serves the needs of customers is false, as other options for later drinking are 30 metres away at the under used Cock Pub, and three other venues within the village. We also observe that the business is often closed when it could be open and that when open, the customer numbers can be low, so existing permissions are not fully utilised.

We have a presumption that licensing assumes appropriateness of establishment for purpose to then license. We argue that No 38 is inappropriate for this purpose and that licensing should be withdrawn based upon arguments and evidence provided demonstrating clear breaches of current permission and intent in such ways. This application to extend would, if approved, seem contrary to the licensing objectives and the role of a governing committee/ review body.

Below we provide a brief description of the background, reasons for our objections and include demonstrative evidence of clear breaches of the current license.

#### Background to our objection

#### Our house and its physical connection to LJs Bar & Brasserie

We live at 36 Church Street, which is attached to 38 Church Street, where the LJs Bar and Barista operates. Our kitchen, sitting room and master bedroom lie on the party wall, which is allowing due to its composition, both cooking smells and sound disturbance into our home on a frequent basis. Our garden is adjacent to the courtyard at the rear of 38 Church Street that is used by LJ's customers. The ceiling of No 38 is physically connected to the Elm frame of No 36 Church Street. Noise vibrates through the structure and walls. No 36 Church is a grade 2 listed property and No 38 and 38a are treated the same due to their attachment to No 36.

#### Related planning concerns

No 38/ 40 Church Street has A3/A5 licence but not A4. We are already on record on how unfairly the A3/A5 licence has been applied to the Bar & Brasserie which previously operated as a butchers shop for 100 years. They now openly advertise use of the

courtyard as open for drinking, and we and others have frequently observed the serving of alcohol when no one is having or had a meal within the building. All observed evidence suggests that applicant wishes to run a bar, has clearly demonstrated this over the past year, and the application request clearly supports that aim. The application to 10.30/11 pm is not for eating but drinking and for alcohol off sales. This has gone way past serving alcohol with food, as was outlined in the initial license application. Even the signage above the door indicates the applicant's intention: **Bar** and Brasserie.

#### Other related reasons

Street congestion is worse due to LJs operation with there being no off-road car parking. Lorries, vans, and cars are parked on the road and pavements causing further congestion. An extension to the licensing hours could worsen this. The application in 2012 for hot food take out that gave 38/ 40 Church Street mixed A3/ A5 license inaccurately stated that customer parking was available at rear. We own that space and had right of way that would prevent any customer parking. That application which we never saw until looking into the planning history in 2019, should have been rejected on this basis.

# Our objection to the current license and what was agreed at last hearing (1st Feb 2019)

The current application was justified to allow drinks to be served with food. The applicant then requested on premise alcohol sales Monday to Sunday 11.00 to 23.30. We argued that noise and smells were excessive within our home and that if the intention was to serve drink with food then most people would finish eating by 9. Agreement was to allow sales of alcohol 12-21.00 Thursday to Saturday and opening hours Monday to Saturday until 21.30, with the garden shut to customers by 2100, and was based on the applicant's indicating willingness to work with us regarding avoiding noise and noxious odours within our property. We agreed to this on the basis that work would be done to stop the noise and smells.

#### What happened in the six months following that decision

Following their application approval 1st feb 2019, we met 27th Feb 2019 with Luis and Jill to discuss the actions to address the noise and smells. A separate letter dated 28th March 19 records our discussion which agreed that the work necessary would happen within six months allowing them to recover expenses already made before being able to afford this work. Reluctantly we agreed as this seemed the best deal we could reach at this point in time meaning we would need to suffer with noise and smells until then. We agreed we would let them know as soon as we could hear or smell so they could hopefully lessen the problem. We did on occasion send facebook messages and drop notes to them to this effect, which was met with hostility. That spring and summer were not easy for us. On 26th August 19 having not heard from Luis, we then asked what was the plan. His response was that there was no problem and therefore no plan. At this point we started to seek other course of actions including speaking with their landlord, who did not care and said for us to take it up with the council.

#### What has been happening ever since

Having raised the issue with SDLC councillors, reviewing the string of incremental planning decisions that had, and we would say incompetently, led to the situation that LJs could operate next door, we were finally directed in the Autumn 2019 towards the environmental department. We provided diaries of problem events that finally led to a decision in December 2019 to install sound monitoring equipment. This would happen in Feb/ March 2020 time to be ready for the new season. This was then stopped as Covid-19 prevented the Environmental officer to make house appointments until Summer 2021

when LJs reopened. Dialogue recommenced with Environmental on 2nd October 2020, during which time a full diary of further problems was captured and provided to the Environmental team. On 17th October 2020, Environmental were informed that LJs were still plaving music at 11pm. We contacted the police but they would not act as no threat of physical violence had occurred. The music continued for some time after. December 2020 further records of noise, deliveries and smell problems were sent to Environmental team asking for something to happen. The next exchange with Environmental was August 2021 reminding them of the last exchange during December of 2020 about nuisance noise and smells, but we did not receive a reply. Covid had understandably diverted their resources. "What with lockdown and the restrictions to business since then, although the noise has continued, there has been some respite, so I have delayed contacting you again. But things are ramping up once more and I should really like the chance to see if we can get the music noise levels looked at. Recently the styles of music being played next door seem to have altered and include more heavy beats, which travel into our living space. Could you please confirm that you are still in post and how we may be able to make progress on this issue, which is a real blight.' The next exchange was with the new Environmental Office which relates to our complaint in early September of this year, which is still under investigation (SR 356271).

Problems have continued with noise, smells and delivery issues throughout. A full diary is provided at the bottom of this document. It did not include on one occasion at 0430, Luis brought a group of friends to the shop and cooked steak for them. Being woken during the night in that way is an unpleasant and debilitating experience.

#### Reasons for our objection to this application

#### Prevention of Crime & Disorder

The applicants attitude to being challenged is anti social and sometimes physically intimidating. We tried for many months to communicate basic issues with every attempt to be friendly and accommodating. This approach failed and for two years the relationship has been almost hostile. So rather than pressing the applicant to make changes we have engaged with the Environmental team, as directed by the Licensing team, to press for a cancellation of the current licensing for which we have clear evidence of repeated breaches.

In addition to our worries, we understand that the applicant has physically strong-armed a pensioner, and has made threats to neighbours who have challenged the applicant in some way. The applicants' attitude to resolving neighbourly concerns is in clear contrast to that of the Co-op team who have always acted pleasantly and have promptly dealt with delivery drivers and noise concerns.

#### **Public Safety**

Not obvious is the exposed Asbestos roof in courtyard that is within 1.5 metres of customer seating. No efforts have been made to remove, cover or warn customers of the risk in catching Asbestosis. Hopefully the committee are also concerned about this. Within the property, no physical modifications were made to ensure the increased risk of fire could reach the attached timber frame listed building. In 2010, the approved planning application to create the restaurant imposed the condition that prior to work commencing, the design to protect against fire, noise and odours needed approval by buildings inspectors. That application lapsed, and four years ago LJs took over the butchers with no planning application that would have required the same conditions. The only measures taken have been the purchase of fire blanket, extinguishers and signage. Risk of fire now is greater than when it was a butchers shop.

#### Prevention of Public Nuisance

#### Operating hours

The Bar & Brasserie have operated often past permitted hours both within but mainly in the **courtyard** with customers sometimes leaving after 10pm (as opposed to the licensing terms of **9pm**). Audio/ video files have been provided as evidence of this repeated behaviour. This noise occurs every Friday and Saturday evening, and has prevented us from enjoying our garden, such that we hardly use it now, preferring to sit in doors on pleasant weekend evenings. If the applicant behaved as a regular neighbour they firstly would not have what seems like parties all these days, and would try to be understanding, civil and take steps to avoid such noise and repetition. Their few signs are ignored by customers, and themselves as is clear from the recordings. We have video/ audio files with such noise from typically 6pm to 10pm every Friday and Saturday.

Supplier deliveries have occurred between 5 and 5.30am several times every week for more than 3 years. The applicant has made no effort to stop this. Caroline has contacted the Woods Bakery (Biggleswade) company but they still continue to deliver early. They now don't have their radios on but still slam their doors which guarantees us an early wake up.

We can negotiate, we understand we live next to businesses. We have had 20 years of good relationship with the Co-op, had 15 years of good experience with the butchers and then a few years of good relationship with Luis. Our problems only started when they opened next door as the Bar & Brasserie and we objected.

Delivery and customer drivers occasionally park blocking our drive, preventing us leaving or entering. The applicant makes no effort to stop this and has on several occasions tried to intimidate Caroline from addressing the delivery drivers to park more responsibly, which apparently he considers to be harassment of the poor drivers.

When customers collect their cars at 2am, possibly still under the influence, we can have radio playing, loud voice and car doors slamming. All this is a consequence of this license contributing to our poor sleeping and general weariness.

#### Noise

We suffer with continuous music and voices audible within several rooms of house, and in our garden that is adjacent to LJs courtyard. This happens even when the Bar and Brasserie are closed with music played for the applicant's sole benefit. We have recordings demonstrating the noise we hear that are provided as evidence. The affect is we cannot relax and feel angry of our situation. Whilst in the house downstairs it is not overly loud, it is a constant noise burden, that is analogous to Chinese water torture. Upstairs in the bedroom it is impossible to have an afternoon kip or to go to bed early as the noise is even worse. You can hear the low bass and beat of music, and the drone of many voices, often distinct clear words when voices are raised. This can happen with just a few people using the bar and brasserie but increases greatly when a large group excitedly raises voices to be heard, all fuelled by the alcohol. In the lounge we need to turn up the volume on our television be able to hear above the noises. In the kitchen we have to turn on our radio for the same effect. My wife uses our ensuite bathroom to study for her degree and needs to close two intermediate doors and turn on the shower fan to try and drown out the noise from LJs. It is ridiculous that we should have to do this.

In the garden, the voices of customers and staff shout into our garden and disturb our relaxation, thoughts and own quiet discussion. No efforts are made to reduce the noise. The reality is that use of the courtyard is not viable in this location. The initial proposal was that the courtyard would allow smokers to smoke without doing do so on the street. The

courtyard has seating for 19 and is often filled with eating and drinking customers. As mentioned earlier we have probably 100 hours of clearly loud audio/ video recording from 6pm to consistently past 9.30 and past 10 on some occasions. All comfortably past their permitted operating hours.

When the business is not open for customers, typically most summer afternoons, Sundays and sometimes Mondays, the applicant will play the his own music, or the radio loudly that we cannot relax in the three adjacent rooms but more so in the garden. The constant beat of music is antisocial and far noisier than what can be heard from the Indian restaurant, Chinese Takeaway, Cock and Wheatsheaf pubs on Church Street. The applicant does not care and seems deliberately to be creating noise. At the same time, the front door to the street is open and music is loudly broadcasting into street, no doubt attempting to advertise that LJs exists, which is of course impossible to miss given the large waving flags, pointing finger signs and flashing lights in the evening. The affect upon us is worse as we get to hear it not only through the walls and structure, but also through our adjacent windows that have the thin panes of glass as required of a listed building. Neighbours apparently have to turn their television on to cover the sound entering their homes when window are open. The applicant does not care about the impact upon neighbours and the undermining of the charm and character of this historic village.

We are not aware if a music license is required or not but music is always on everyday irrespective if the business is open or closed to customers.

#### Light pollution

Small flashing lights above LJs front window and in the courtyard are on throughout evening and night. It is well known that such lighting has a damaging effect to wildlife. Whilst this does not impact our sleep, we feel it undermines the charm, character and ideally tranquility of this historic village. This is at odds with the context of the village, pushing this part of Church Street more into a commercial scene, that impacts desirability and property values. An example of not controlling how commercial properties present themselves is evident as one of the 4 listed timber frame buildings in this part of Church Street has been on the market for 3 years with no one wanting to take on the challenge and investment required of owning a listed building that faces a colourful commercial business.

#### Noxious smells

The diary provides full details of the frequency of smells of food, drink and cleaning chemicals we experience in our main bedroom. Whilst not recorded specifically, as the alcohol sales seem to predominate, the room also can smell "like a brewery" at the end of a night and even into the next morning!

Their single refuse bin is frequently overfilled by close of play Saturday before emptying with bin collection on Monday morning. The affect of this is not clear, however, neighbours experience significant Rat problems that may feed on contents in these bins. Several years ago the business had two large bins before the Applicant reduced this to one, no doubt to save money. The bin is damaged and the lid does not close securely, allowing pests access to refuse whether the bin is overfull or not. Clearly this is an Environmental Health issue, is not pleasing to the eye and again degrades the tone of the village.


