Please find attached our Technical Note reviewing the Transport Statement prepared by Vectos for the proposed Marley Eternit development at Meldreth. As discussed with my colleagues Colin Young and Amy Barnett, we have been undertaking further analysis of baseline and development traffic flows to inform junction capacity assessments of the A1198/Whaddon Gap and Whaddon Road/Fenny Lane junctions.

In brief, and building on Colin's summary email last week, our general findings are that the further assessment work undertaken by Vectos in support of the proposed Marley Eternit development is largely robust, and the proposed development is considered unlikely to have a major impact on the capacity and operation of the local junctions and on the local highway network between the site and Meldreth village (i.e. Whaddon Road and Whitecroft Road).

Regarding the predicted impact on the capacity of Whitecroft Road, the figures have changed slightly from Colin's summary email provided last week due to the more detailed work we have undertaken this week on reviewing baseline traffic flows. However Whitecroft Road is still predicted to operate well within capacity (i.e. 35% of maximum capacity in the AM Peak Hour with the proposed development).

David,

I was hoping to send you our report but it will take a little bit more time due to the modelling aspect of the junctions. So I thought I would give you some headlines on what have assessed so far.

- Site access the assessment of the site access appears appropriate to what they should be
  assessing and we consider having separate access points is appropriate from a safety point
  of view;
- The trip generation and multi-modal analysis appears to be done in accordance with guidelines and they have considered a robust case for the trips. They could have gained employee trip patterns from the current operations to bolster their analysis but they didn't;
- The journey to work analysis is adequate, they have distributed traffic using existing traffic flows which is a standard approach, although we haven't had sight of their exact analysis;
- Cycle parking at Meldreth their cycling methodology appears robust but they have used a
  person/household UK average to work out number of likely people living in the development
  when they could have used a locally derived person per household number.

Traffic impact through Meldreth – we had a look at the existing flows through Meldreth as reported from Vectos' traffic surveys and have looked at this data in two ways, firstly we have derived a rate of 2.6 vehicles a minute down Whitecroft Road during the AM peak period 8 to 9, secondly, we have used the Design Manual for Roads and Bridges (DMRB) guidance to check what capacity a road like Whitecroft Road should be able to accommodate and discovered that based on the existing flows currently 17% of the current road capacity is being used. When we apply the additional traffic from the proposed site to that existing traffic on Whitecroft Road we find that it adds an additional vehicle per minute during the AM peak period – a rate of 3.6 vehicles per minute. Furthermore, the additional traffic during the AM peak period would add to the percentage of capacity of 7% and so taking the capacity up to 24%. We therefore consider the impact is likely to be minimal and possibly not even noticeable.

Generally they have undertaken a reasonable assessment but we are still looking through the report. We have made a start on the modelling of the two junctions but looking at the low traffic flows I am expecting the junctions to function within capacity. We will let you know about that in due course. We hope to get our report to you next week.

I am on leave next week and my colleague Matt Croot copied in on this e-mail will be undertaking the work so you can contact him with any queries.
