On these figures the Council Tax would range from £748.35 for Band A to £2,418.96 for Band H before any discounts or benefits.

Council Resolution: Setting the Council Tax

The formal Council Resolution to be passed in order to re-set the Council Tax for 2005-2006 is that the following amounts be now calculated by the Council for the year 2005-06 in accordance with Sections 32 to 36 of the Local Government Finance Act 1992:

(a)	£60,703,837	being the aggregate of the amounts which the Council estimates for the items set out in Section 32(2)(a) to (e) of the Act (gross expenditure including parish precepts and the Housing Revenue Account)
(b)	£46,821,170	being the aggregate of the amounts which the Council estimates for the items set out in Section 32(3)(a) to (c) of the Act (gross income including the Housing Revenue Account and use of reserves)
(c)	£13,882,667	being the amount by which the aggregate at (a) above exceeds the aggregate at (b) above, calculated by the Council, in accordance with Section 32(4) of the Act, as its budget requirement for the year (net expenditure) being the maximum amount of £11,350,000 and the parish precepts of £2,532,667

(d) **£6,232,010**

being the aggregate of the sums which the Council estimates will be payable for the year into its general fund in respect of redistributed non-domestic rates and revenue support grant increased/decreased by the amount of the sums which the Council estimates will be transferred in the year from/to its collection fund to/from its general fund in accordance with Section 97(3) (Council Tax transactions) of the Local Government Finance Act 1988.

(e) **£138.91**

being the amount calculated by the Council, in accordance with Section 33(1) of the Act, as the basic amount of its council tax for the year (average Council Tax for a band D property for the District including parishes)

(f) **£2,532,667**

being the aggregate amount of all special items referred to in Section 34(1) of the Act (parish precepts)

(g) £92.93

being the amount calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its council tax for the year for dwellings in those parts of its area to which no special item relates (average Council Tax for a Band D property for the District excluding parishes), the amounts being for each of the categories of dwellings shown below:

- (i) In accordance with Section 36(1) of the Act, the amounts to be taken into account for the year in respect of categories of dwellings listed in different valuation bands are shown by adding the amounts for each band in paragraph (g) and **Appendix 'A'**.
