CELEBRATING THE CLASSICS

Celebrating the Classics is part of a long standing tradition of free concerts organised by South Cambridgeshire District Council. 2005 will see the last concert of its kind happening at the Cambridge Corn Exchange on **Thursday 10 November**.

This year international duo-pianists the Cann Twins perform with the Cambridge Youth Orchestra. Three very special concerts will bring together international artists to play with the best young musical talent from the district through the guidance of CIMA (Cambridge Instrumental Music Agency). The programme includes Bruch's Two-Piano Concerto, Festival Overture by Shostakovich, Ravel's Mother Goose Suite and excerpt from Tchaikovsky's Piano Concerto No 1.

In the morning 1,000 school children from South Cambs will see the twins Claire and Antoinette Cann take to the stage with their two pianos and the Youth Orchestra. In the afternoon there will be a free concert for South Cambs residents over 60.

We would like to invite Councillors to the schools concert at 11.30 or the over 60s concert at 2.30. Both concerts will be an hour long, and we will reserve the boxes for Councillors seating. Please let me know by Friday 4th November if you wish to join us for either or both of the concerts.

The final evening performance at 7.30pm is a full-length concert, with drinks in the interval. Due to the current financial situation we ask that you purchase tickets should you wish to attend the full evening concert. SUPPORTING THE REPRESENTATIVE COUNCILLOR - MAKING WARD MEMBERS MATTER Being a Councillor is a form of public service that puts people in a privileged position where they can make a difference to their local community, and to the quality of constituents' lives. It's a complex role and Councillors have to balance the needs and interests of their residents, voters, political parties and the Council.

Following the introduction of the executive model into local government with its emphasis on cabinet decision making and scrutiny many non-executive members have felt increasingly disengaged from the work of the Council. However, the primary role of a Councillor is to represent

the ward and citizens who live in it. The job of the Councillor is not to be the council's advocate in the Community but to be the community's advocate in the Council, and to ensure that local democracy works and people believe in it.

The East of England Regional Assembly (EERA) is holding an event on Wednesday 14th December 2005 at Ickworth House, Horringer, near Bury St Edmunds which offers the opportunity for members to review what works best to support them in their representative role, and to meet members from other councils who face the same issues. The event comprises a mixture of presentation and discussion sessions, and will give an opportunity through workshops to have a more detailed look at key issues.

CONSULTATION ON A REVISED CODE OF PRACTICE ON PART 3 OF THE DISABILITY DISCRIMINATION ACT.

The Government and the Disability Rights Commission (DRC) are producing Codes of Practice to explain the Disability Discrimination Act (DDA) 2005. The DRC are consulting on the latest of these, a draft Code of Practice relating to Part 3 of the DDA 1995, amended by DDA 2005. It revises the existing Code to reflect changes to be introduced in December 2006. These changes will affect:

- Public authorities, some of whose functions had previously been excluded;
- Private clubs whose activities regarding their members were previously excluded;
- The housing sector, with important new duties being placed on those selling, letting, controlling and managing property.

To enable full consultation the draft code has been prepared prior to the production of the regulations under DDA 2005. The DRC has tried to reflect the stated policy of the government on the regulations, but the final regulations may necessitate some alterations being made to the final version of this Code.

DRC are keen to have the views of all interested parties – particularly on the new chapters 11, 12, 15 and 16 – as these will shape the redrafting of the Code for publication next summer. LOCAL.GOV.UK - ONLINE SURVEY

The gateway website for the national local government organisations was launched in 2004 to improve access to the Local Government Association (LGA) and its partner organisations providing information and support to member authorities. It was aimed primarily at local authority officers and members and acts as a portal for the content on the existing websites. Emphasis was placed on the fact that each of the bodies has a distinct and unique role – with individual expertise and specialisms – but that all have a common purpose.

The portal currently allows easy searching across all of the national sites providing quick links to the unique content on the sites. There is also a 'featured websites' area – on each visit different family websites are shown – again to illustrate and inform users of the diversity and range of activities and services provided nationally and to provide easy access to the sites. The local.gov.uk site has been built to high accessibility standards – achieving AAA rating which is the highest standard possible.

The LGA is now working on upgrading the site, starting with a more user-friendly 'events' section to be launched early next month and an improved jobs area. The LGA will also be redesigning the

news and features areas on the site – with your assistance. From now until the end of November an on line survey is being run from the home page (http://www.local.gov.uk). The survey consists of ten short questions that will only take a few minutes to answer. The views of officers and Councillors will help to ensure the website is meeting the needs of all and highlight the areas that need further attention. Feedback and comments from SCDC Members and Officers to the LGA will be gratefully received!

ADDENBROOKES ACCESS ROAD, PROPOSED BRIDGE OVER THE RAIL LINE

Further to your letter dated 20 October 2005 regarding the above mentioned development the comments of South Cambridgeshire District Council are as follows.

The proposed bridge needs to be of an exceptional quality design which makes a statement and which is a landmark. It should help create a distinctive gateway into the city. Unfortunately the various options presented do not fulfil these key principles. The following comments are made in respect of each option.

Option 1

This relates to the standard engineered style of bridge giving a functional but unimaginative appearance. This would not be acceptable in the location as it would have an adverse visual impact.

Option 2

Although has a wider opening than option 1 the design is still unimaginative and would not make a high quality landmark.

Option 3

This option is the most permeable but lacks the requirement for a landmark feature.

Option 4

This option goes some way to making an architectural statement but lacks the permeability that is also required.

Option 5

This also goes some way to making a statement and landmark feature. This needs to be more permeable also.

In terms of a preferred option it would be options 4 or 5 but designed so that there is less banking so that they are much more permeable.

The Council cannot stress enough the importance of a bridge design which is striking and of exceptional quality that makes a statement in the landscape. In addition the bridge should not be cluttered with highway signage, lighting or safety features which would dilute any landmark feature. These features should be designed to complement rather than dominate the structure.

I hope these comments are helpful.
