CONCLUSION: South Cambridgeshire District Council has confirmed that the 'Referendum' version of the Waterbeach Neighbourhood Plan meets the legislative requirements.



The draft Waterbeach Neighbourhood Plan submitted to SCDC met the requirements in the legislation, and SCDC publicised the neighbourhood plan for a minimum of 6 weeks, invited comments, notified any consultation body referred to in the consultation statement and sent the draft neighbourhood plan to independent examination. Following examination, SCDC has determined that the 'Referendum' version of the Waterbeach Neighbourhood Plan is ready for a public referendum (Schedule 4B of the Town and Country Planning Act 1990 (as varied by s38A & 38C of the Town and Country Planning Act)).
