

South Cambridgeshire District Council Privacy Notice for Council, Committee and Sub-Committee minutes

South Cambridgeshire District Council provides a written record (minutes) of its Council, Committee Joint Committees and Sub-Committee meetings and makes these available on its website.

This Privacy Notice gives you information about what we record, what we do with the recording and how long we keep it.

To comply with Data Protection legislation the Council needs to provide you with the following information (and the information on page 2):

- South Cambridgeshire District Council is the data controller for the personal data that you provide at any Committee meeting and for any audio recordings that we may make of those Council meetings.

- The lawful basis on which the Council will record your name and any comments you may make is as
 a 'Public Task' (as under the Local Government Act 1972, Part VA, Section 100C), i.e. If you wish to
 speak at a Council, Planning Committee, other Committee, Sub-Committee or Greater Cambridge
 Partnership meeting, you will be addressed by your name in order that the meeting may run
 smoothly, and your comments will be recorded in order that the Council may accurately reflect these
 in the minutes of the meeting.
- Your name and comments will be included in the minutes of the meeting.
- The minutes will be published on the Council's website¹ and kept indefinitely. They will also be kept as a permanent historical record in a book of minutes, deposited with a historical archivist employed by Cambridgeshire County Council.
- In the case of questions to a Greater Cambridge Partnership meeting, your contact details, provided by yourself, will be shared with Greater Cambridge Partnership staff.
- The Council is based in the UK and stores its data within the European Union.

Further information

You have the following rights:

- You have the right to be informed via Privacy Notices such as this.
- You have the right to request access to and to receive a copy of any information we hold about you (including in an electronic format) - to request a copy of this information you must make a subject access request in writing.
- If you find that the information South Cambridgeshire District Council holds about you is no longer accurate, you have the right to ask to have this corrected.
- You have the right under certain conditions to ask us to erase your personal data.

seek to comply with your request but may be required to hold or process information to comply
with our legal duties).

You also have the right to make a complaint to the Information Commissioner's Office (ICO). This is an independent body responsible for making sure that organisations comply with Data Protection legislation. The ICO will always expect you to have raised your concerns with us before submitting a complaint.
