APPOINTMENT OF CONTRACTOR - PINE VIEW, SMITHY FEN, COTTENHAM

Purpose

1. To seek the Cabinet's approval to accept a single tender for the execution of work in accordance with Contract Standing Order 4.5.

Background

2. Members will be aware that the Planning Sub-Committee is considering taking direct action pursuant to Section 178 of the Town and Country Planning Act 1990, to enforce the provisions of an Enforcement Notice and High Court Injunction to remove sheds, caravans and hard standing from Pine View, Smithy Fen, Cottenham. If the Planning Sub-Committee decide to take direct action at its meeting on 11 October, contractors need to be appointed to carry out the works.

Considerations

3. In order to carry the action as mentioned above, the Council needs to instruct external bailiffs. Your Officers believe that the agents previously instructed to carry out the works at Victoria View in 2005 will provide the most effective service. In order to instruct these agents without carrying out a formal tendering process Cabinet approval is required pursuant to Contract Standing Order 4.5 which allows the acceptance of single tenders where the Council considers it desirable in its best interests. The value of the contract is between levels 3 and 4 as defined in the Constitution, thus requiring this procedure to be followed.

Options

- 4. There are two options available to Members:
 - (a) To accept the recommendation and allow direct action to proceed in accordance with the current plan.
 - (b) Not to accept the recommendation. A tendering process would therefore be required, delaying the direct action.

Implications

- 5. In line with general and specific statutory duties under the Race Relations Act 1976 and Race Relations (Amendment) Act 2000, the Council operates a Race Equality Scheme (RES). This was last revised and agreed by the Council in July 2006, with an update of the 2005 2008 action plan.
 - (a) The Council is committed to treating everyone fairly and justly, whatever their race or background.

- (b) The Scheme gives priority to actions relating to Travellers as the biggest ethnic minority in the district (around 1.0% of the district's population).
- (c) Planning is identified as being amongst the services most relevant to promoting race equality.
- (d) The lead Cabinet Member for Race Equality, Councillor Edwards, is establishing an RES Member Working Group. This will highlight to the Cabinet and GTDPD Member Reference Group findings and recommendations from ODPM Circular 1/2006 and the Commission for Race Equality's "Common Ground" report, which may be appropriate to the Council's strategic approach to Traveller issues and the Gypsy and Traveller Development Plan Document. The first meeting of the Working Group is being arranged to take place in October.
