COMMUNITY AND CULTURAL STRATEGY 2007-12

Purpose

- 1. To consider and recommend to Council the approval of the Community and Cultural Strategy 2007-12. The Strategy is enclosed as a separate document.
- 2. To consider and approve the Community Capital Grants Programme guidelines as shown in the **Appendix**.

Executive Summary

- 3. The Strategy has been prepared by a number of different officers in discussion with a large number of partner organisations; it is recognised as a working and evolving document, which will be reviewed annually.
- 4. The Draft Strategy was considered by the Community, Arts and Sports Advisory Group meeting on 19 April 2007. Members of the Advisory Group approved the draft strategy, subject to a number of additions and amendments, and recommended that the Portfolio Holder seek its adoption by Cabinet. Officers have since revised the document accordingly and added in a number of case studies as agreed at the meeting.
- 5. The draft Community Capital Grants Programme guidelines were also considered at the meeting and Members approved them subject to a number of amendments. In addition officers agreed to consult with a small number of Parish Councils who had recently received a capital grant from the Council. The attached final draft guidelines now include these amendments.
- 6. Once approved, it is intended to actively promote the new capital grants programme to all Parish Councils and local groups and organisations.

Officers have subsequently consulted with a wide range of partner organisations on the draft Strategy and have also consulted with a small number of Parish Councils on the draft grant guidelines.
