Therefore 1.00 represented a good performance in that the same % of care leavers were EET compared to the level of EET in the general population. Our ratio in 2006/07 was 0.69 hence care leavers were less likely to be EET than the general population.</p> <p>The indicator was changed for 2007/08 and simplified to the % of care leavers that were EET. We have therefore gone back and calculated the 2006/07 figure on this basis - which is 57.1% (35 qualifying former care leavers reaching age 19 in 06/07 of which 20 were EET).
