HOMELESSNESS STRATEGY 2008 – 2013

Purpose

- 1. To seek approval on the attached Homelessness Strategy for 2008 2013.
- 2. This is a key decision because it is likely to be significant in terms of its effects on communities living or working in an area of the District

Background

- 3. The council are required to produce a homeless strategy every 5 years. The previous strategy was published in 2003, and therefore we are required to have a new one in place in 2008.
- 4. Significant improvements have been made to the homeless services provided by the Council since July 2003, including:
 - (a) A significant reduction in the numbers of households living in temporary accommodation. The Government set all local authorities the target of reducing the numbers of households in temporary accommodation by half by 2010; SCDC reached our target for this in 2007/08.
 - (b) Minimised use of Bed and breakfast accommodation, including no use of B&B at all during 2007/08.
 - (c) Increased homelessness prevention. This includes new prevention initiatives including a settled homes scheme and a young person floating support scheme.
 - (d) Introduced a sub-regional choice based lettings scheme and new lettings policy.
 - (e) Awarded the status of Regional Homelessness champions by the CLG in October 2007.

Considerations

- 5. The new homelessness strategy aims to address the continued progress the service wish to provide, national and regional targets and priorities, and potential challenges ahead. The action plan accompanying the strategy includes:
 - (a) Monitoring the impact of the new choice based lettings scheme on homelessness.
 - (b) Further reduction in temporary accommodation, including minimal use of bed and breakfast accommodation.
 - (c) Increase homeless prevention.

- (d) Focus on the accommodation needs of young people.
- (e) Support to Travellers.
- (f) Potential hostel re-provision.
- (g) Maximise opportunity raised by being awarded Regional Champion status for the eastern region.
- (h) Meet the Audit Commission's inspection (KLOE) requirements relating to the service.
- (i) Working with partner agencies.
- (j) Ensure value for money
- (k) Increase access to the private sector.
- (I) Equality and diversity needs.
- (m) Housing futures.

Implications

6.	Financial	The strategy will help to address the housing needs within the district and minimise the need for costly emergency accommodation. Some schemes to prevent homelessness may require funding and where possible it is hoped that this will be available within existing budgets.	
	Legal	The strategy is a legal requirement.	
	Staffing	The activities included within the strategy will be carried out by the existing staffing resources.	
	Risk Management	There is a risk that external factors in the housing market may impact on the anticipated outcomes of the homeless strategy.	
	Equal Opportunities	The strategy aims to address diversity and equality issues within the service.	

Consultations

- 7. During the Homelessness Review surveys were sent to private landlords, RSL's, service providers and previous customers. The feedback received has helped to formulate the strategy and its action plan.
- 8. The draft strategy has been consulted on and has been available on the council's website for the public to view and comment. Partner agencies, service providers and parish council's have all been contacted directly during the consultation period.
- 9. As a result of the feedback received during this period no amendments have been made to the strategy document, although some minor changes have been made to the action plan, which accompanies this.
- 10. In additiona, an equality impact assessment has been completed on this strategy, and as a result we have decided to amend the action plan to ensure that all elements of equality are monitored where appropriate.

The strategy aims to address housing needs within the district and provide better access to various housing options including social rented, low cost home ownership and private renting. Through pursuing various housing options and the choice based lettings scheme, customers will have more choice over their housing.

Conclusions/Summary

13. A new homeless strategy is required for 2008-2013. The attached strategy and action plan is designed to ensure that the Council can continue to address the needs of residents in the district who are homeless or threatened with homelessness.
