## HOUSING FUTURES AND THE SUSTAINABLE COMMUNITY STRATEGY

The following notes identify areas where transfer of the housing stock would have an impact.

Comment	SCVH would employ a dedicated officer to tackle anti social behaviour and thereby promote safety and community cohesion.
	It would also take action to help make homes and neighbourhoods feel safe and secure, including improved security measures inside and outside homes including doors and windows with built in security features-"secure by design" Two of the measures in NI 16 relate to burglary. There would be funding for up to1950 new secure doors in the first 5 years that would not be available without transfer. There would also be a programme to provide door entry systems to around 120 homes which would not be available with the Council.

A sum of £750,000 would be available for renewable energy installations and £750,000 for insulation work in the first 5 years compared to a total of £125,000 for insulation measures without transfer.
	There would be £3.1m available for new doors-for around 1,950 homes-compared to no programme available to the Council. There would also be £2.4m available for double glazed window upgrades compared to a Council programme of £350,000.
	There would be an £8m budget for around 1,450 new or upgraded (fuel efficient) central heating systems compared to a budget of £2.5m for around 500 homes with the Council in the first 5 years.

There would be an £8m budget for around 1,450 new or upgraded (fuel efficient) central heating systems compared to a budget of £2.5m for around 500 homes with the Council in the first 5 years.
	There would be a Village Fund of up to £500,000 in the first 5 years that could provide some funding for community transport schemes.
