#### CAMBRIDGESHIRE QUALITY CHARTER FOR GROWTH

#### **Purpose**

- 1. The Cambridgeshire Quality Charter for Growth was recently completed by a group of partners that included the District Council, Cambridge City Council and Cambridgeshire County Council and certain local developers along with others and with the support of Cambridgeshire Horizons and the external consultant, Urbed. The charter sets out the core principles and level of quality expected in the planning and development of new development in the Cambridge sub-region. The document was published and circulated earlier this year.
- 2. This is NOT a key decision because Quality Charter is not a policy that seeks to amend or replace any existing related planning policies in the Council's Local Development Framework and has no impact on the Council's current activities or budgets. The Quality Charter is a set of 36 "principles" which outline the key qualities that the Council's in Cambridgeshire are seeking to imbed within the planning, decision-making and construction of new communities.

# **Background**

3. The Quality Charter was undertaken in order to set out the local authorities' vision for the type of communities that are desired to be developed in the coming years in the Cambridge sub-region. Over a period of 3-4 years the local Councils, with the support of Cambridgeshire Horizons, produced the charter through a series of working visits, workshops and consultation exercises. The result is a form of "protocol" or "accord" to which all parties involved in the growth agenda should be able to sign up to.

# **Considerations**

- 4. The Quality Charter is organized around a group of 4 underlying objectives:
  Community, Connectivity, Climate and Character. Each principal objective is
  supported by 9 charter "principles" which set out the aims the charter is seeking to
  achieve. For example, under Connectivity, one principle is to seek to deliver public
  transport at the start of the development in order to encourage residents to use
  "green" options. As another example, Under Climate, the charter seeks to encourage
  biodiversity and wildlife through the use of Sustainable Urban Drainage Systems
  (SUDS). It is important to note that the principles of the charter are underpinned by
  national, regional and local planning and environmental policies.
- 5. The respective stakeholders, including the District Council, are encouraged to adopt the charter as a statement of policy in the delivery of new communities. Cambridge City Council has already adopted the charter earlier this year. The New Communities Portfolio Holder is urged to also adopt the document as a clear statement of the

Council's support of ensuring a high standard of development of new communities in South Cambridgeshire.

### **Conclusions/Summary**

9. The Quality Charter has been through a lengthily and detailed phase of preparation and consultation. The document represents an important tool in the planning and delivery of new communities. The Joint New Communities and Planning Portfolio Holders are recommended to adopt the charter.

#### Recommendations

10. That the Joint New Communities and Planning Portfolio Holders adopt the Cambridgeshire Quality Charter for Growth as a statement of South Cambridgeshire District Council's aspiration to create major new developments that offer future communities a fulfilling, visually pleasing and environmentally sensitive way of life.
