BARRINGTON PARISH COUNCIL - REQUEST FOR DISPENSATION

Purpose

1. The seven members of Barrington Parish Council seek a dispensation from the Standards Committee from any items concerning Barrington Green.

Background

- 2. Barrington Green, in the centre of the village, was designated as common land and established as a charity in the early twentieth century, of which the Parish Council was nominated as Custodian and sole Trustee of The Green Charity Barrington. The Charity, therefore, can exercise its power as Trustee only through the members of Barrington Parish Council.
- 3. The Standards Committee, at its meeting of 3 October 2002, granted a four-year dispensation to the (then) six Parish Councillors in Barrington from any items concerning Barrington Green and noted that any new Barrington Parish Council members would need to apply for a dispensation.
- 4. Under the *Relevant Authorities (Standards Committee) (Dispensations) Regulations* 2002, a standards committee can grant a dispensation to a member if:
 - (a) the transaction of business of the authority would, on each occasion on which the dispensation would apply, otherwise be impeded by, or as a result of, the mandatory provisions because:
 - (i) the numbers of members of the authority that are prohibited from participating in the business of the authority exceeds 50 per cent of those members that are entitled or required to participate; or
 - (ii) the authority is not able to comply with any duty which applies under section 15(4) of the Local Government and Housing Act 1989;
 - (b) the member has submitted to the standards committee a written request for a dispensation explaining why it is desirable.
- 5. The dispensation is sought for Parish Councillors Paul Cook, Laura Cooper, Anne Day, Tony Fletcher, Judy Hardman, Malcolm Reeder and Aidan Van de Weyer, and is required for four years, or the elected period of the incoming council as from 9 May 2007. The Clerk asks that the dispensation be granted for the duration of the Parish Council rather than for four years, in case the election timescale were to change.
- 6. All requests to a Standards Committee for dispensations are granted at the Committee's discretion.

Considerations

7. Parish Council members must still declare an interest in matters in which they have been granted a dispensation. As a matter of good practice, members should also state that they have been granted a dispensation.

8. The Monitoring Officer, writing to the Parish Clerk in 2002, noted that, in point of fact, the individual Parish Councillors were not Trustees, but were members of the Trustee, and therefore should declare that "I am a member of the Trustee of the Green".

Options

9. Not to grant a dispensation would leave the Charity unable to operate.
