STREET TRADING CONSENT REQUEST FOR RESOLUTION – DUXFORD VILLAGE

Purpose

1. To seek approval of all streets in the village of Duxford to be designated Consent Streets under the Local Government (Miscellaneous Provisions) Act 1982.

Background

- 2. Duxford Parish Council requested that all streets in the Parish be designated as Consent Streets so that trading could be controlled. The Licensing Committee held on the 31 March 2009 agreed to this request.
- 3. A Notice of Intention to designate all streets in Duxford was published in the local press on 29 May 2009, with a deadline of 26 June 2009 to make representations. No objections were received.

- 5. The Licensing Committee can either:
 - a. approve the request from the parish Council, or
 - b. refuse the request from the Parish Council

Consultations

7. Notice was served on the Clerk to Duxford Parish Council, The Director of Transportation, Local Councillors for the Duxford Ward and the Chief Constable of Cambridgeshire Police.

8. A letter was received from the Highways Authority but the contents were not relevant to, and do not affect the proposal for Street Trading Consent in the Village of Duxford. The letter was to inform the Licensing Officer that there is a new panel dealing with such applications and inviting a representative to join it.

Conclusions/Summary

10. Once agreed by Committee any person wishing to trade on any of the streets in the Parish of Duxford, after 24 August 2009, would require to make an application for Street Trading Consent.
