# **Council Publicity and the Local Elections**

The Local Government Information Unit (LGiU) has issued a briefing, detailed below, which advises on protocol for publicity in the run-up to local elections. It covers the relevant aspects of the Code of Recommended Practice, but also reminds affiliates of what they can do at this time. For further information The LGiU publication 'The Right Side of the Law' sets out the Code of Conduct on Local Government Publicity. #### Summary

This briefing advises affiliates about publicity in the run-up to local elections. It covers the relevant aspects of the Code of Recommended Practice, but also reminds affiliates of what they can do at this time.

#### Introduction

The run-up to local elections is a particularly sensitive time in relation to local authority publicity. Those responsible for issuing publicity need to be mindful of the restrictions, but they should not suspend all publicity action because of the elections.

The time to exercise caution is generally defined as the period from the issuing of the notice of an election to election day. However, it is sensible to look at publicity issued shortly before this period, particularly if it may have a 'shelf-life' that takes it into the election period.

#### STATUTORY RESTRICTIONS AND THE CODE OF RECOMMENDED PRACTICE

#### **Definition of Publicity**

Publicity is defined as 'any communication, in whatever form, addressed to the public at large or to a section of the public': it includes press releases, newspapers, newsletters and the council's web site.

#### The Broad Restrictions

It is worth recapping the general restriction on local authority publicity:

A local authority must not publish any material that, in whole or in part, appears to be designed to affect support for a political party. In determining whether material falls within the prohibition, regard shall be had to the content and style of the material, the time and other circumstances of publication and the likely effect on those to whom it is directed and, in particular, to the following matters:

- whether material refers to a political party or to persons identified with a political party or promotes or opposes a point of view on a question of political controversy which is identifiable as the view of one political party and not of another; or
- where the material is part of a campaign, the effect which the campaign appears to be designed to achieve.

#### **Specific Restrictions at Election Time**

The revisions to the Code of Recommended Practice which came into effect in April 2001 (that apply only to England) tightened restrictions around elections. It now adds a further recommendation to English authorities, that authorities should stop all forms of proactive publicity relating to candidates and other politicians involved directly in elections.

The Code says that at this time publicity should not deal with controversial issues or report views, proposals or recommendations in such a way that identifies them with individual members or groups of members. Proactive events organised for this time should not involve members standing for election.

While the safest policy between the notice of the election and polling day is to avoid mention of any councillor who is seeking re-election, there is no need to cease all proactive publicity so long as the authority is mindful of the broad restrictions. This is illustrated by the Code.

#### When Members can be Quoted

It is acceptable for the authority to respond in appropriate circumstances to events and legitimate service enquiries provided its answers are factual and not party political.

Members holding key political or civic positions should be able to comment in an emergency or where there is a genuine need for a member level response to an important event outside the authority's control.

#### **Other Politicians**

Even where politicians are not standing for election, if they are quoted, what they say should not be identifiable as the view of one political party. Politicians from outside the council such as members of parliament, who are clearly identified with political parties should not generally be quoted at this time.

#### **Press Releases**

The safest route is to not mention councillors who are standing for election. If it is necessary to have a member comment, consider also including a quote from an opposition councillor (although press releases on politically controversial issues should be avoided at this time).

#### **Council Newspapers**

The authority need not suspend publication of its council newspaper or magazine, as long as the content does not fall into 'restricted' categories. If the paper is issued at this time, care should be taken to make sure that councillors who are standing for election are not featured and that the information in the paper is 'neutral'. It would be unwise to change publication dates so that a paper appeared in an election period when its normal schedule would not lead to this.

In practice, if it is possible to arrange publication so that it falls outside the election period, it would be wise to do so. Bear in mind, too, that papers published just before the election period will be circulating during it and may be subject to challenge.

#### The Council's Web Site

Electronic communications now come within the scope of the Code, although there is no specific guidance. Web sites represent a particularly 'grey area' because of the amount of material archived but available. Common sense would dictate that any current content should be checked and gauged against the rules and caution should be exercised about material posted on the site during the election period.

#### **Other Publications**

A good question to ask about the publication of material around election time is 'can it wait and if it can't might others think that it appears to be designed to influence how people vote?' An information leaflet about a major initiative, for example, could be regarded by some as promoting the majority party because of the timing rather than the content.

#### Consultation

Consultation exercises are also within the scope of the Code of Practice and while it is unlikely that consultation would breach the code even outside of elections, it is a good idea to check that no consultations are taking place on issues that could be seen as politically sensitive.

#### **Other Organisations**

The restrictions apply to publicity issued by other organisations that receive local authority funding. While this is unlikely to be a problem with most partners, authorities may want to check if tenant groups or community groups that they fund are planning publicity around election time, as they may be more likely to deal with issues that are politically controversial.

#### An LGIU publication

"The Right Side of the Law" is an LGIU guide, which has been the bible of local government publicity since the introduction of the Code of Conduct on Local Government Publicity in the 1980s. The most recent edition incorporates changes to the Code that came into force on 2 April 2001. The guide aims to help councils - councillors, chief executives, legal officers and communications officers - through the maze of new regulations and challenges from about by the Local government Act 2000. It includes sections on scrutiny, referendums, the law regarding local government publicity and the code. It can be obtained from:
