## **Review of Parliamentary Constituencies**

The Boundary Commission for England have proposed a realigning of the boundaries for the Parliamentary Constituencies of South Cambridgeshire County Constituency and South East Cambridgeshire County Constituency and Cambridge Borough Constituency. These changes are outlined below:

The Commission have proposed that the South Cambridgeshire District ward of Cottenham (which is currently divided between South Cambridgeshire CC and South East Cambridgeshire CC) should be wholly included in South East Cambridgeshire CC, and the South Cambridgeshire District ward of The Abingtons (which is currently divided between South Cambridgeshire CC and South East Cambridgeshire CC) should be wholly included in South Cambridgeshire CC. In addition, the Commission propose that the South Cambridgeshire District wards of Linton and Balsham (which are adjacent to The Abingtons ward) should also be included in South Cambridgeshire CC. These changes would reduce the electorate of South East Cambridgeshire CC from 79,768 to 72,274. The Commission also propose, as a result of these changes, that South East Cambridgeshire CC should be renamed East Cambridgeshire CC.

The Commission propose that the constituency boundary between Cambridge BC and South Cambridgeshire CC should be realigned so that the City of Cambridge wards of Cherry Hinton and Coleridge (which are currently divided between Cambridge BC and South Cambridgeshire CC) would be included in the constituency containing the part of the divided ward with the greater number of electors (Cambridge BC). The Commission also propose that the Trumpington ward (which is currently divided between Cambridge BC and South Cambridgeshire CC) should be wholly included in Cambridge BC, although this does not represent minimum change realignment. This would allow for all but one of the City of Cambridge wards to be included in Cambridge BC. These changes, together with the changes proposed in the preceding paragraph, would produce a South Cambridgeshire CC electorate of 73,264. The electorate of Cambridge BC would be 76,906.

The representation period is from 18<sup>th</sup> September 2003 until 31<sup>st</sup> October 2003.
