# STREET TRADING CONSENT BARRINGTON REQUEST FOR RESOLUTION – BARRINGTON VILLAGE

## **Purpose**

- 1. To seek approval of all streets in the village of Barrington to be designated Consent Streets under The Local government (Miscellaneous Provisions) Act 1982 and subsequent publication of the required Public Notices to confirm adoption.
- 2. This is not a key decision, however, the Constitution requires the Licensing Committee to discharge the Council's statutory licensing functions.

#### **Recommendations and Reasons**

3. That the Licensing Committee agree to the request by the Parish Council of Barrington for all streets in the village to be designated as Consent Streets.

## **Background**

- Barrington Parish Council requested that all streets in the Parish be designated as Consent Streets so that Trading could be controlled. The Licensing Committee held on 13 July 2009 agreed to this request.
- 5. A Notice of Intention to designate all Streets in Barrington was published in the local press on 16 July 2009, with a deadline of 13 August 2009. No objections were received.

## Considerations

- 6. If the village of Barrington was granted Consent Street Status, consultations would be made by the Council on any application made to trade within the village. This would enable Parish Councils along with Police Fire and Environmental Health to have an input into the consultation process and the final decision taken by South Cambridgeshire District Council.
- 7. Adoption of Consent Street status means that conditions can be set to ensure that any licensed traders meet pre determined standards which include cleanliness, hours and areas of trading etc. By adopting this resolution it also gives power to South Cambridgeshire District Council to take enforcement action against traders operating unlawfully on the public highway

- To approve the request from the Parish Council
- To refuse the request from the Parish Council

## **Conclusions / Summary**

- 11. Authority is sought from the Licensing Committee to approve the request for all Streets in Barrington village to be designated as Consent Streets.
- 12. Once agreed by the Licensing Committee any person wishing to trade on any of the streets in the Parish of Barrington after 22 July 2010, would be required to make an application for a licence for Street Trading to this authority.
