DECISION ITEMS – ISSUE DATE 29th AUGUST 2001

1. Decision items taken under delegated powers at the Resources and Staffing Executive Group meeting held on 22nd August 2001

1) NATIONAL NON-DOMESTIC RATES – BOUNDARIES OF RURAL SETTLEMENTS

Under delegated powers Cllr RT Summerfield agreed that the boundary of the Rural Settlement in **Litlington** should be redrawn to include the immediate village envelope and to exclude the land between Ashwell Street and the A505 from the rural settlement of Litlington. As a consequence the Crown public house would be granted mandatory and discretionary relief from payment of the National Non

Domestic Rate in a Rural Settlement, as the only Public House in that settlement and one which provided a vital service to the community.

2) RURAL RELIEF NON DOMESTIC RATES

Under delegated powers Cllr RT Summerfield agreed to “top up” mandatory relief to 100% with an award of 50% discretionary relief to all food shops in a designated Rural Settlement.

1. Items for information from Resources and Staffing Executive Group meeting held on 22nd August 2001

1) FOOT AND MOUTH DISEASE HARDSHIP RELIEF

14 enquiries have been received from businesses affected by the foot and mouth outbreak but to date only one completed application had been received.

2) COUNCIL TAX BANDING

The revaluation of properties should begin in 2005 and would affect the council tax bills issued in 2007. This would not affect the total revenue but it was likely to affect the share between houses as the council tax burden would be distributed more fairly on the basis of up to date property values.

2. Election of Chairman and Vice-Chairman of the Licensing Committee

At the Licensing Committee held on Thursday 23rd August 2001 Councillor RFA Murfitt was elected Chairman and Councillor R Driver was appointed Vice-Chairman of the Committee.
