Motion for next council meeting:-

This council deplores the action of the government in restricting the democratic rights of some members of Council who wanted to debate and to vote on the principle of the agricultural tied cottage. In so doing the Council does not accept that the members so barred from voting or debating had any direct pecuniary interest and had a right to take their full part. Furthermore, members consider that the government's attempt to influence and to interfere with this council's affairs, and its effort to stifle free and open discussion, to be a gross misuse of power, and to be alien to the democratic principles held by most people in this country.

The Government's action is made more unacceptable by the recent activities of a government department which needs the use of a tied cottage for a herdsman on a ministry farm. While making it clear that the proper use of the tied cottage is essential for the welfare of the dairy herd concerned, the officials will not take the normal legal steps for possession hecause of the political implications and the embarrassment that it would cause the government. Insetad, a backdoor approach has been made wanting this council to provide alternative accommodation and so avoid possible publicity. This action is also considered unacceptable by the Council and is seen as another example of blatant hypocrisy. It is considered that if a government department finds it essential to have agricultural tied cottages, it should say so and not try to retain the system by devious means, which are not available to ordinary farmers.
