- (b) The Chairman of the County Transportation Cttee(Cllr Everlegh) assumes that early "Park and Riders" will use the periphery carparks so that the elderly shoppers and other disadvantaged persons e,g young mothers with families will be enabled to find more central car park spaces available later.

  - (B) Whether consideration of the likely expansion in the use of smaller passenger carrying vehicles from the villages was taken into account when determining these proposals:— (following recent legislation)
    - (1) in respect of central bus stops and parking.
    - (2) the use of shop trolleys to the bus stops. (Instead of the central carparks)
  - (C) Whether the central shopkeepers were consulted.
  - (D) Whether Members of the County Council representing Wards in the above Disticts (1). Have agreed to share the discomfort except when visiting Shire Hall for Council & Cttee Meetings.
    - (2) Have Voted-For-Against or Abstained/these proposals.(Named details1please)
  - (E) Whether an approach has been made to the County and City Council's Staff
    Association to use the proposed periphery carparks or buses to assist in the
    scheme suggested by Cllr Everlegh.
- 2. Members of South Cambs and the Staff be asked to state whether they will use the "Park and Ride" system. (Members only-Names please)
- 3. South Cambs D.C. deprecates:-
  - (A) The lack of consultation with this Council.
  - (B) The "stealth" with which these proposals have been introduced.
  - (C) The invitation to a "Discussion" on 14th Jan which turned into a "Dictation"
- 4. Dear Chairman,

I am sure that you will have appreciated that my Motion on the subject of "Park and Ride" was for the benefit of our Members, because I wished to stress my personal feeling of resentment at the lack of courtesy to us. This does not mean that other Members will enthuse over the wording being conveyed to the County Council, and I have expressed these views to the Chief Executive.

You have kindly indicated that you will allow me to introduce Paras 1.A to E, and 2, but will refer 3 to 6 to the Planning Committee. If you are agreeable, at the end of my brief introduction, I will explain that as an alternative I would accept a more conciliatory enquiry of the County Council on the following terms:-

I beg to move that:-

- 1. Cambs County Council be invited to indicate what consultations have taken place, other than with Cambridge City Council, on the subject of "Park & Ride"?
- Cambs County Council be invited to indicate how Members of the County Council who represent Wards in this District Voted on the question of "Park & Ride".?

My main concern is to ensure that the County Council are in no doubt as to our views on this matter. We do not wish to interfere in any way with the City Council's right to implement "Park & Ride" at their expense, but since it will manifest affect the most disadvantaged in our District, it would be quite wrong for the County Council to spend their Rate Money in support of these proposals.

# Notice of Motion

Councillor D.J.L. Allen sought leave to amend his motion to read:

Bearing in mind that :-

- (c) The "Park and Riders" will be the Electors of the Huntingdon, East and South Cambs. Districts.

## I beg to move that :-

- Cambridgeshire County Council be invited to indicate what consultations have taken place, other than with Cambridge City Council, on the subject of "Park and Ride".
- 2. Cambridgeshire County Council be invited to indicate how Members of the County Council who represent Wards in this District voted on the question of "Park and Ride".
- South Cambs. District Council deprecates :-
  - (A) the lack of consultation with the Council
  - (B) the "stealth" with which these proposals have been introduced
  - (C) the invitation to a "Discussion" on 14th January which turned into a "Dictation".
- 4. South Cambs. District Council write to the County Council and remind them that at their Meeting with the 6 Districts of the County on 31st January, 5 Districts urged the County to reduce their contemplated Rate burden of 194p because it will be bound to involve a loss of jobs, and that the County Ratepayers should not be asked to support a potential "White Elephant".

- 5. Failing greater willingness to discuss these proposals, this District Council will object to any Planning Application on their District for this purpose, and seek their M.P's support to require the Secretary of State to "Call-in" the Application on the grounds that it is discriminatory between Ratepayers money.
- 6. Members should agree to form a Sub-Committee of Members of the Finance and Planning Committees:-
  - (A) to consider other means of assisting with Cambridge's traffic problem
  - (B) to consider other means of improving shopping facilities in this area
  - (C) to consider the financial implications in (A) and (B).

The Chairman determined that paragraphs 3 onwards should stand referred to the Planning Committee, but was prepared to allow discussion on paragraphs 1 and 2.

Councillor Allen reiterated his concern that the District Council was only being involved after decisions had been taken, when it was South Cambridgeshire residents who would be most affected. He also doubted that the scheme would work as planned, with commuters leaving their cars on the outskirts of the City, unless enforced by price. He urged Members to attend the Planning Committee, but asked that in the meantime letters be sent on paragraphs 1 and 2. The Chairman of the Planning Committee was glad of the amendment and the reference of the rest of the motion to the Committee, but suggested that it might be preferable for the whole motion to be considered by the Committee

so that other points could perhaps be included, with delegated powers to approach the County. This was acceptable to Councillor Allen, and it was

AGREED that the amended Notice of Motion relating to park and ride standing in the name of Councillor D.J.L. Allen be referred to the Planning Committee with delegated powers to take the appropriate action.
