Such a Committee should include at least:

Chairman and vice-chairman of Council
Leader and deputy leader of Council
Elected members
Chief Executive and senior officers
Representatives of charities
Representatives of churches/faith communities
Co-opted members

The "shadow" committee should finalise its membership prior to ratification of any constitutional amendment.

In the event of an emergency occuring whilst the committee is in "shadow" form, it should still meet as soon as possible, and advise the Leader of Council and Chief Executive on the use of their existing delegated powers.

Could the following Notices of Motion be included on the agenda for the next Council meeting please.

That South Cambridgeshire District Council has no confidence in John Prescott the Deputy Prime Minister and asks the Prime Minister and the Cabinet to relieve him of his planning duties as soon as possible.
