### **Experimental Road Closure Scheme** Bridge Street, Cambridge

The above scheme comes into operation on Wednesday 22nd January and I thought it would be appropriate to write to all elected members in Cambridge and the surrounding villages (both county and district) to advise of the likely initial impact of the scheme.

While efforts have been made to publicise the experiment via the media, road signing and through an information leaflet distributed widely, experience with other road closures necessitated by streetworks suggests that the scheme will still come as a surprise to many motorists. As a result conditions in the first few days of the experiment could be difficult. However, experience also shows that within a week or so conditions should stabilize.

During these initial, possibly difficult days of the experiment, elected members of all councils are likely to come under some pressure from the motoring public who will undoubtedly experience delays when travelling to and from their workplaces. Whilst it is difficult to placate drivers at these times I do anticipate that conditions will get better within a few days.

The scheme, which forms an important part of the transport strategy for Cambridge, is likely, initially, to be viewed in a negative light, but I would encourage elected members to emphasize the experimental nature of the scheme. Judgment overall should be reserved until such time as conditions stabilize and the public have the opportunity to consider the benefits of the scheme as well as the drawbacks. I am sure that when the new measures become established, the scheme will achieve overall improvements in street environments, space, safety and air quality.

To help minimise delays during the first few days of the scheme, additional police and traffic wardens will be on duty in Bridge Street and the surrounding streets to explain the new experimental restrictions and to direct and assist with the re-routing of traffic.

Council officers will be on site during the peak periods to fine tune the timings at various signal controlled junctions in the surrounding area to reflect the changing traffic flows until such time as traffic patterns stabilize.

Any help you can give in encouraging the public to persevere with the initial difficulties and reserving judgment on the scheme until conditions stabilize would be much appreciated.

I had hoped to see you prior to the Housing Cttee on 28th August because I wanted to ask you what you would have advised your Cttee to do if Cllr Kime's Motion to spend £4 million on Housing this year had been carried at Coun.last Autumn.

You will recall that then I suggested that his request should have been referred to the Housing Cttee for consideration before Council should be asked to Vote on it. I would expect the Amendments to Standing Orders which I want you to add as a Motion to Council on 25th Sept submitted on 8th January 1997 will be remitted to G.P.Cttee on 23rd October and back for ratification on 13th November. at Council.

I wrote to Cllrs Mrs Woodbridge and Kime after that Council Meeting to try to find out what they would have done, and because I received no reply, presumably because Cllr Kime's Motion was not carried, but only by a few Votes I understand, I raised the question at Housing Cttee on 28th August because your Housing Strategy was then outlined and I wanted to get a reaction if, once again, there was a proposal to vary your programme this year, in the same way.

As I mentioned to the Chief Executive before his Conference I would have wished to discuss how Cllr Cathcart was pictured with an official from English Heritage making provision for managing a Church at Whittlesford.



### Car parking on the Addenbrooke's site

Your letter of 13 November addressed to Mrs Crandall at South Cambridgeshire District Council has been passed to me by Michael Monk for comment. In your letter you propose a Council motion relating to the possibility of constructing a multi-storey car park on the Addenbrooke's site.

The Trust is acutely aware of the car parking problems being experienced by staff, patients and visitors accessing the site. On previous occasions when we have faced a shortage of car parking spaces we have constructed additional car parks to meet rising car parking demand. The additional car park spaces that have been created in this way are now full to capacity and overflowing. Constructing additional car parking spaces does not appear to be a long term solution

As you may know the total number of car parking spaces that can be constructed on the site is limited by a Section 106 Agreement with the Cambridge City Council. This ceiling has not yet been reached but the Trust has decided to attempt to reduce demand for car parking on the site by encouraging staff and others to switch to non-car methods of travel. This approach is in line with current Government thinking and also has benefits in terms of environmental improvements.

the Trust seriously considered the option of constructing a multi-storey car park about three years ago and carried out a detailed feasibility study which showed that the high capital costs of construction would have to be passed on in high car parking charges. If such a car park were to operate effectively, these higher charges would have to be applied to all car parks on the site otherwise no drivers would make use of the multi-storey facility. Car parking charges at the levels required to make the facility viable would give serious problems for staff and would mean that more cars would be parked in the neighbouring streets which is not acceptable to the local residents, their Councillors or the City Council. Charges at these higher levels would also apply if the facility were to be financed through Private Finance Initiatives (PFI).

The only way to make a multi-storey car park financially viable and a practical proposition under the current circumstances, would be for the Trust to make a capital or revenue contribution to the scheme. As I am sure you know, the Trust receives its funding by selling its services to purchasers such as the Cambridge and Huntingdon Health Authority who have cash-limited budgets. If the Trust were to increase

its service costs, because of subsidising expensive car parking provision, then this would result in purpasers having to reduce the level of service provided to the local residents to balance their budgets. In the current circumstances the Trust can not therefore consider investing its funds in this way.

More recently, during the negotiations with a drug company and the University who are both constructing research buildings on the site, we reworked the financial calculations. This showed that a multi-storey car park was still not financially viable and both developments have made provision for surface car parking spaces. Were the Trust to have insisted that the two organisations increased their capital contribution to provide a multi-storey car park, this would have resulted in a lower land lease payments to the Trust for these developments. These payments are being used by the Trust to support its core activity of providing clinical patient care.

I can confirm that the Trust has no plans at present to construct a multi-storey car park unless it were to be possibly associated with some new development on the site which requires the replacement of some of the existing surface parking to free up development land.

In your letter you draw attention to possible links between a possible multi-storey on the Addenbrooke's site and park and ride facilities. The City Council's view is that the current three access points to the Addenbrooke's site are approaching their maximum capacity. If this view is accepted, then constructing a ti-storey car park on site to be used for park and ride could not be sustained through the current access points. As I have already explained, the cost of parking in an independent multi-storey car park on the site would be much higher than the current park and ride costs and is unlikely to be used as an alternative to park and ride sites.

During this year the Trust has been considering options for reducing reliance on car travel to the site. The Trust has now prepared a document, "Access to Addenbrooke's" which sets out an action plan, target traffic reductions, and describes the progress being made on the site for promoting non car travel to the site. I understand that Michael Monk has already passed you a copy of the latest version of the document. These measures outlined in the document are designed to help to reduce the current level of demand for parking spaces on the site. In the first instance these initiatives are directed to staff travel, but investment in public transport and other schemes will also be available for patient and visitor travel to the site.

The Trust has been working closely with the City and County Councils and more recently with officers of S Cambridgeshire District Council and representatives of Long Road 6<sup>th</sup> Form College on the implementation of these initiatives. The Trust will be looking to South Cambridgeshire District Council for support with some of these schemes, particularly those relating to transport from areas outside the City.



Following my memo to the Conservation Cttee Chairman dated 22nd, and due to the need to get a Motion to Council at least 10 days before 8th Jamuary, I felt that a simple Remit to G.P.Cttee to define Terms of Reference now that Council have agreed unwisely in my opinion, to go down this road, is the best approach.

It must be a truism since all Churches are historic and distributed widely in Parishes across our District, that ALL Parishes through their District Cllr should have the right to be considered for a District Grant and not just the twelve Members of the Conservation Cttee. As I indicated in my letter to Cllr Cathcart I believe therefore that an application for help should be within the remit of all Members.

I also believe that as the Diocesan Authorities may wish to be consulted because of possible deconsecrations etc, and that it makes sense to get the Parish Council's views as to whether they are prepared to contribute, that the Chief Executive's Dept is the logical section of the Council best able to deal with the correspondence etc.

Following Council's decision to give Grants to repair Churches that Terms of Reference for purposes of the Council's Diary be considered by the next G.P.Cttee on 22nd January.

Terms of Reference should include method of contact with the Diocesan Authorities and those responsible for the Church, method of contact with Parishes to ascertain interest of Parish in their support to giving their Church a Grant.

I also Move that the Chief Executive takes charge of the Grants procedure to ensure a just and equitable programme is created.
