



Resident Name Sewage - Caxton.

I have read your report to your Councils

ENVIRONMENTAL SERVICES and HEALT H Committee on the above, and may the Lord have mercy on your soul.

REMOTE, you say, REMOTE? So is my backside. But its as essential to my front side as this property is to the village called Caxton - which I am then the Chief Officers know by name/only as a remote village in the district; for apart from the edd Sanitary Inspector, none set foot in it other than to collect rates or rents. Compared with the time that you all spend dancing to the whims of all those urban areas with great problems that we little remote villages have paid for since the end of the war, I think you might have remembered that we too \*\*\*\* are entitled to a measure of your time.

I trust that you will bring EVIDENCE to support a number of the statements that you have made to support your total disinterest in the welfare of this lady, for as the owner and relation of property-owners, who never saw or heard a sign of ANY council representative enquiring about our needs or wishes for property connection, I have a suspicion that you have no records at all in writing stating that each of our handful of houses - for which the scheme was intended and not just to provide jobs for the boys - were approached and had the opportunities properly explained.

The above is just the outline of a case which I vlaim to be "a contribution which is of vital convern" if not to the "Parish concerned" then to an occupant who is valiantly trying to keep her family by her own efforts, as well as her children from the sewage that surrounds her, while your HEALTH authority's sewage pipes flow gaily on. But there, I had forgotten, your authority has passed the buck to the A.W.A. or some such bureaucratic home for our army of officialdom that have never handled a shovel in their lives.

You will recall, I presume that we have had a lot of inclement weather, frost and rain since Christmas - or maybe Resident Name, an invalid, is supposed to take that in her stride for the joys of having improvements, which have TOTALLY ROBBED her of her, or any pentry; AT THE SAME TIME as they have stripp out ALL THE SHELVING from her large cupboard beside the fireplace in order to put pipework up (which could and should have resulted in shelving appropriately cut to shape, being put back); at the same time as the pantry of which she has been robbed has had a water closet installed within 10 feet of the bathroom WC, ON THE SAME FLOOR > WHEN OLD AND INVALAD PEOPLE need one on the bedroom floor (ye gods and to think that all this is in the name of "improvement" costing six thousand pounds); AT THE SAME TIME as ALL THE HOUSES have been provided with stop-cocks (which I would have thought that half-wits would have known NEED TO BE IMMEDIATELY ACCESSIBLE for turning off, has been BOXED IN WITH A PANEL ON THE FRONT OF THE BOXING FIRMLY F LX E D with FOUR SCREWS -does not the thought of elderly tenants confronted with a burst pipe endevaouring to find a screwdriver then getting down on their mees with the help of a torch then unscrewing four screws EVER ENTER THE HEADS of the people who design

There were a number of other matters .. but I have grown tired, and really its just a waste of my time going on.

All this I tried to explain to c uncil members recently, but I realise my breath was wasted.. and so I'll pack by haversack, put on my boots and walk from Ely to Littleport. I hope to be back before the Environmental Services Committee .. if I'm not then tell the police to search just below the River Lark entry!
