CAMBUS RULING – Briefing notes (25/06/99):

Following a public enquiry into poor timekeeping and cancelled services by Cambus Stagecoach, the Traffic Commissioner for issued a decision statement on 18th. June, 1999. The main provisions were:

- a) A prohibition of Cambus Stagecoach from operating services 4 and 103 as from 26th July, 1999.
- b) A prohibition of Cambus Stagecoach from registering any new services before 4th January, 2000.

Unless another operator can be found, this ruling would leave the 102 service as the only link between Sawston and Cambridge. The effect on passengers would be:

- Reduction of the morning rush hour service (06.40 9.00 am) to Cambridge from 9 to 1 (07.30).
- Reduction of the daytime services to Cambridge from 4 to 1 per hour.
- The loss of the direct link to Addenbrooke's, Cambridge railway station and Cambridge Regional College currently provided by the number 4 service.
- Reduction of the evening rush hour service (16.30 18.30) from Cambridge to Sawston from five to two buses.
- No evening service from Cambridge to Sawston on Weekdays or Saturday after 17.55 or from Sawston to Cambridge after 19.22.

Conversations with the County Council have so far failed to identify any operator with the capacity to operate either service at the present level.

The number 4 service was started in January, 1999 with aid from Rural Transport Initiative funding. Since the contract entered into with Cambus also included other services, it is apparently impossible to transfer this grant to a new operator. It is therefore very unlikely that this service could be reinstated other than by Cambus.

Notice of Motion

That

South Cambridgeshire District Council notes with concern that Cambridgeshire County Council is currently consulting on plans to close *School House, Stapleford*, a respite care unit currently providing 4 places for mentally and physically disabled children, many of them children of residents of this district.

Council notes that it was originally planned that School House would be replaced with a new facility at London Road, Harston. Council notes with concern that it is now proposed that this new unit be used instead as a replacement for *Church Street, Great Wilbraham*, a longer stay unit for 4 disabled children, and further notes that these proposals will result in a net loss of 4 respite care places available to disabled children resident in our district.

Council believes that respite care is an essential part of enabling disabled children and adults to remain in their family homes, by affording family members a break from their caring responsibilities. In the case of families with children, respite care is also essential to allow other children within the family to receive the full measure of attention that they need.

South Cambridgeshire District Council therefore requests the County Council to take the necessary steps to ensure that these four respite care places are kept open and relocated to the new facility in Harston as originally planned. Council also requests that plans be made to ensure that facilities at *Church Street* are improved as soon as possible.

Council further offers its support to those parents of children at *School House* who are opposing the proposed closure, and requests our representative on the Social Services Local Panel to convey our concerns to other members of that body.

CHILDRENS DISABILITY BEST VALUE REVIEW

Councillor Powley has asked me to thank you for your letter of 4th April 2000, informing him of the District Council's resolution and the points made in the Council debate. Copies of the letter were made available to all the members of the Social Services Committee prior to their meeting yesterday, when they considered the attached report. The Committee approved the recommendations contained in the report.

As you will see from the report, it is now intended to use **all** the savings arising from the closure of School House for the service for children with disabilities. The effect of this should be to offer a wider choice and range of community support services and to ensure that the remaining residential respite care homes are used more effectively. In relation to the concern expressed in your Council's resolution, I would particularly draw your attention to the targets within our Quality Protects Management Action Plan, referred to in the table at the top of page 6 of appendix 1 of the report.
