### 133. GENERAL DECLARATIONS OF INTEREST

Councillor Sebastian Kindersley declared a personal interest as an elected Member of Cambridgeshire County Council, a statutory consultee for all planning applications on the agenda.

### 134. MINUTES OF PREVIOUS MEETING

The Committee authorised the Chairman to sign, as a correct record, the Minutes of the meeting held on 11 January 2012.

### 135. S/2273/11 - BAR HILL (PARISH OF LOLWORTH) - (21 TRAFALGAR WAY)

Stanbury (Applicant), Councillors Roger Hall and Bunty Waters (local Members) addressed the meeting and Councillor Nick Wright (Economic Development Portfolio Holder) addressed the agenda.

The Committee was **minded to approve** the application subject to satisfactory resolution of planning matters, including archaeology, subject to safeguarding conditions and subject to it being referred to the National Planning Casework and not being called in for determination.

Councillor Hazel Smith declared a personal interest as a friend of the applicant's agent.

### 136. S/1927/09 - BASSINGBOURN (26 SOUTH END)

Rupert Webb (objector), Tom Sims (applicant's agent) and Councillor Nigel Cathcart (a

local Member) addressed the meeting.

The Committee **refused** the application for the reasons set out in the report from the Corporate Manager (Planning and New Communities) and because the design and scale of the proposed development would fail to preserve or enhance the character and appearance of the Conservation Area. In addition the proposal exceeds the number of dwellings identified as acceptable on a greenfield site in a Group Village in Policy ST/6 of the Core Strategy.

**137. S/1044/11 - GREAT EVERS DEN - (SITE KNOWN AS OSP148)**

Stephen Salisbury (objector), John Walton on behalf of the (applicant), John White (supporter), Clive Dalton (Great and Little Eversden Parish Council), Councillor Liz Heazell (local Member) and Councillor Mark Howell (Housing Portfolio Holder) addressed the meeting.

The Committee gave officers **delegated powers to approve** the application contrary to the recommendation in the report from the Corporate Manager (Planning and New Communities), subject to clarification of financial contributions and highways issues. The Committee agreed the reason for approval as being that need for the development outweighs any harm to the surrounding heritage assets. As a result, the Committee was satisfied that there was no conflict with the South Cambridgeshire Local Development Framework 2007, particularly Policies CH/4 and DP/3.

Councillor Sebastian Kindersley declared a personal interest because he is Cambridgeshire County Councillor for the Electoral Division of Gamlingay, which includes the Parish of Great Eversden. Over the years, he has in such capacity attended site visits, and meetings of Great and Little Eversden Parish Council at which this application site had been considered. He was now approaching the matter afresh.

**138. S/2480/11 & S/2481/11 - PAPWORTH EVERARD (SITE TO THE WEST OF ERMINE STREET)**

Councillor Nick Wright (a local Member) addressed the meeting.

The Committee **approved** both applications S/2480/11 and S/2481/11, subject to the Conditions attached to the original Decision Notices relating to planning applications S/2286/07/F and S/1163/08/F.

**139. S/0029/11 - MELDRETH (LAND ADJ TO THE TAVERN YARD & STATION YARD)**

The Committee gave officers **delegated powers to approve** the application, subject to the prior completion of a Section 106 Legal Agreement requiring financial contributions in respect of public open space, community facilities, waste receptacles and a Section 106 monitoring fee, and to the Conditions set out in the report from the Corporate Manager (Planning and New Communities).

**140. S/2291/11- WATERBEACH (LAND TO THE NORTH OF 43 ROSEMARY ROAD)**

The Committee **approved** the application subject to the Conditions and Informatives set out in the report from the Corporate Manager (Planning and New Communities).

**141. S/2272/11- IMPINGTON (LAND TO THE EAST OF 37 CAMBRIDGE ROAD)**

Don Proctor (applicant's agent) addressed the meeting.

The Committee **approved** the application subject to the Conditions and Informatives set out in the report from the Corporate Manager (Planning and New Communities).

**142. 2111 - UPPER CAMBOURNE (CELL 1A)**

The Committee noted that this application had been **withdrawn** from the agenda.

**143. SAWSTON - PROPOSED DIVERSION OF FOOTPATH 18**

The Committee **resolved** to make an Order under Section 257 of the Town and Country Planning Act 1990 diverting Public Footpath number 18 in Sawston between Mill Lane and The Baulks (Footpath number 20), and to ask officers to arrange for the appropriate Notices to be published in order that the Order can be confirmed in due course, thus enabling the development proposed by planning application S/2435/07/F to take place.

**144. APPEALS AGAINST PLANNING DECISIONS AND ENFORCEMENT ACTION**

The Committee **received and noted** a report on Appeals against planning decisions and enforcement action.
