Service Plan Priorities 2015/16

Purpose

- 1. To seek approval to proposed priorities for the Planning Service for 2015/16.

Recommendations

3. It is recommended that the Portfolio Holder approve the proposed priorities for the Planning and New Communities Service Plan 2015/16, and suggests additions or amendments to these service plan actions if required.

Reasons for Recommendations

4. Planning and New Communities, like each section of the Council, produces a Service Plan each year. Portfolio Holders are asked to agree the priorities for their service areas to enable service and financial planning to be put in place for effective delivery by April 2015.

Background

5. The Planning and New Communities Service Plan 2014/15 is attached as background information. The proposed list represents a continuation of key projects already underway and new projects designed to take forward key developments identified in previous years' work, and to further enhance the service to customers.

Considerations

- 6. The existing Planning and New Communities Service Plan includes a number of service plan projects intended to run over a 2 or 3 year timeframe. This is therefore a refresh of the service plan designed to recognise the strengthened commitment to shared services and a business-minded approach, the current stage of the Local Plan and new initiatives such as Right to Build.
- 7. The service plan addresses the key Council's key aims and actions from the Corporate Plan 2014 -2019, as well as projects contained within the Business Efficiency and Improvement Plan.

Options

- 8. The Portfolio Holder is requested to consider these proposed actions and to suggest changes or additions where required.
- 9. It is proposed that the Planning and New Communities Vision remain the same as last year: 'Our vision is to be a strong and responsive service that provides excellent customer service as part of delivering high quality places and protecting what is great about South Cambridgeshire.'.

Implications

11. Financial

There are financial dimensions to all of these projects but significant new funding that is required is provided from fee income or government grant. The Council has been awarded £50,000 for the Right to Build Vanguard and £50,000 from the Site Delivery Fund over 2014/15 and 2015/16.

12. **Legal**

A number of these projects will require specialist input from our legal services.

13. **Staffing**

There are no specific staffing requirements arising from these projects at this stage, however additional posts have been agreed to provide resources required for additional major planning applications.

14. Risk Management

A number of risk logs will be developed for projects and the overall Planning and New Communities risk register will be used and amended as necessary.

15. **Equality and Diversity**

Equality Impact Assessments will be carried out as required for policy changes.

16. Consultation responses (including from the Youth Council)

The priorities proposed in this report have been prepared in consultation with team leaders and managers in Planning and New Communities, and will be discussed with team members at meetings in November.

Effect on Strategic Aims

17. The Planning and New Communities service plan is important for all three of the Council's main strategic aims.
