I am a local builder working almost entirely with a 5 mile radius of the city. If this ill thought of scheme goes ahead I would need to commence work at 6.30am or 10.30 am and finish at 3.30 or 7pm which would not work for me or my customers. My suppliers are Ridgeons, Travis Perkins, Howdens and Wickes. How am I supposed to pick up building materials without incurring several &Acirc;&pound;60 fines every day? I am most concerned not only for myself but all businesses in Cambridge. This scheme could kill most businesses large and small if it goes ahead.

I am also angry and confused about how little was known by so many people of Cambridge about all of this. Personally I knew nothing of this scheme until about a fortnight ago when my daughter received an email about the Mill Road Winter Fair. It soon became clear that none of my family, neighbours and colleagues had heard anything about it.

Having attended the consultation at Mill Road , Councillor Lewis Herbert stated that every household had received letters and leaflets about the road closures, that is simply not true! Every household should have received official notice by mail about these measures that will affect most of us who live/work in and around the city.
